





The signing ceremony of facility agreement for a syndicated Term Loan of Tk 900 million favouring Dhaka Telephone Company Limited, under lead arrangement of Dutch-Bangla Bank Limited, was held in Pan Pacific Sonargaon Hotel, Dhaka on September 06, 2006. Dr. Fakhruddin Ahmed, Managing Director, Palli Karma-Sahayak Foundation (PKSF) and the former Governor of Bangladesh Bank was present as the Chief Guest.

With the syndicated facility, the project envisages setting up of a Fixed Wireless Telephone Network based on CDMA 20001 X platform to cover 4 zones of Bangladesh: Northwest, Northeast, Southwest & Southeast.

When implemented, the project will have the installed capacity to connect up to 232,000 subscribers. The company has a plan to increase connection to 368,000 more subscribers by 2009, and additional 500,000 by 2012.
