

HC rejects Ershad's appeal, hands him 2 yrs behind bars

Defence claims of no hearing on appeal, sees political link

To the utter surprise of many, the High Court (HC) handed two years' imprisonment to former dictator HM Ershad yesterday, rejecting his appeal against the trial court's verdict in a corruption case of purchasing Japanese boats.

The verdict has now given rise to the question if Ershad, who is also the president of the Jatiya Party (JP), will be able to take part in the upcoming parliamentary election.

After over 11 years of appealing against the trial court judgment that awarded Ershad a three-year term in the jail, the attorney general's office moved in the court for holding hearing of the appeal. Tuesday was fixed for the hearing at

the court of Justice Faisal Mahmud Faizee.

Ershad's lawyers said they did not get the chance to hold hearing of their client's appeal against the lower court verdict. "The way the verdict came is unprecedented," Advocate Shaikh Sirajul Islam told The Daily Star.

They said they are aggrieved by the verdict like their client Ershad.

It is a "politically motivated" case and Ershad has been deprived of justice, they said, adding that they will challenge the HC judgment at the Appellate Division.

When the court sat on Tuesday, Ershad's counsel made a verbal submission for deferring the date of hearing, seeking time for collecting some necessary documents.

The court fixed the next day for the hearing.

When it resumed on Wednesday, Ershad's lawyers filed a written prayer for time extension, saying the paper-book lacked most essential papers and documents and exhibits necessary for the disposal of the case. They also mentioned that Ershad's senior counsel Barrister Azminal Hossain will leave for Hajj. They appealed for deferring the case by two weeks after the Supreme Court vacation ends on January 9.

The court fixed yesterday—the last working day before the vacation—for hearing the time prayer.

The court rejected the time petition at 11:25am yesterday. When it was preparing for passing its order at 2:45pm, Ershad's lawyer sought half an hour's time for getting an Appellate Division order

Advisers slow down to end EC standoff

Plan not to take any move before Sunday

There might not be any move before Sunday to recast the Election Commission (EC) in line with the package proposals drawn up by the council of advisers to the caretaker government 10 days ago.

By this time the advisers might be trying informally to negotiate a consensus among the political parties on reconstituting the commission by sending two commissioners on leave, said sources.

President and Chief Adviser Iajuddin Ahmed at a meeting on Wednesday asked the advisers to initiate steps to break the deadlock stemming from his strong opposition to the idea of sending Election Commissioner SM Zakariah on leave.

The advisory council did not meet yesterday. They did not even discuss among themselves how to go about negotiations with the parties. They however have plans to take steps to that end on December 17, just four days before

"We will take measures next Sunday to end the impasse in efforts to recast the Election Commission," newly appointed Adviser Shafiqul Haque Choudhury told The Daily Star last night.

"It might take a few more days to find a solution to the problem," he added.

Another newly appointed adviser, M Moinuddin Khan, said they are trying their best to overcome the differences.

The four new advisers, sworn in last Tuesday, will seek to play a robust role in implementing the package proposals and will place some recommendations to the president after discussions with the political parties, sources said.

Guest birds chirp at JU lakes

With the arrival of winter, migratory birds of different species thronged Jahangirnagar University (JU) campus making it eloquent with the chirping of the birds.

Even though the number of birds this year seems lesser than the previous year due to the delayed advent of winter, more than six thousand birds, six foreign species alongside local breeds, have already taken shelter here. This year the birds arrived in the last week of October, a month later than in the previous year.

EC moves to ensure salary for MA Aziz

The Election Commission (EC) Secretariat has finally issued a circular to enable Chief Election Commissioner (CEC) MA Aziz to get his pay during leave.

The CEC's three-month leave will now be considered as 'advance leave,' which will be adjusted after his resuming of the office, the EC circular issued on Wednesday said.

The office of the Controller General of Accounts (CGA) refused to pay the CEC his last month's salary saying that he was not entitled to enjoy the 'three month paid leave'. As laid out in the financial rules, Aziz has been the CEC for one

Nation pays homage to martyred intellectuals

The nation observed the Martyred Intellectuals Day yesterday paying rich tribute to those illustrious sons of the soil who were brutally killed at the fag end of the Liberation War.

With defeat looming large, the Pakistani occupation army aided by their local collaborators -- Razakar, Al-Badr and Al-Shams -- abducted frontline intellectuals and professionals on December 14, 1971 and killed them to cripple the nation intellectually.

The killers dragged renowned academics, teachers, litterateurs, doctors, engineers, journalists and other eminent personalities blindfolded out of their houses and killed them before dumping the

EC men yet to visit scores of houses


