Educational qualification: Second class postgraduate degree with Doctorate degree or second class Honours degree and 3 (three) years teaching experience at any degree college or university;

or

M.Phil degree with second class postgraduate degree in respective subject and 6 (six) years teaching experience at any degree college or university;

or

Honours & postgraduate degree in respective subject from any foreign university and 5 (five) years teaching experience at any degree college or university;

**General important information**

- Maximum age limit for bonafide freedom fighter's/martyred freedom fighter's wards relaxable up to 32 years for posts where age limit is below 32 years. In case of relieved/retired non-commissioned army personnel age is relaxable up to the maximum limit of his actual service in army. But non-commissioned relieved/retired army personnel of age reaching the last limit of govt service shall not be treated eligible for appointment to civil post.
- Person appointed on ad-hoc basis to the post having his age within the prescribed limit as per appointment rules & requisite qualification, shall be treated eligible to apply for the post.
- Applications of persons appointed to the advertised posts on ad-hoc basis in service of govt/autonomous/semi-autonomous/local govt organisation and under local authority should reach with Bank Draft/Pay-Order or Treasury Challan & requisite certificates informing the authority to the Commission Secretariat on or before the last date of receiving application stated in the advertisement. Clearance from Ministry/Department/Directorate/Office/organisation should be submitted at the time of interview. Interview shall not be taken if clearance is not submitted.
- Candidate should be a citizen of Bangladesh by birth or permanent domiciled in Bangladesh as per rules.
- Candidates will be selected as per the current govt order on quota reservation for merit, women, tribal, freedom fighter & in absence of freedom fighter, freedom fighter's/martyred freedom fighters' wards candidates. While writing 'yes' in any of the three Columns No. 11, 12 & 13 of Freedom Fighter's BPSC Form-3 (Original application) the candidate must submit freedom fighter certificate issued by the Ministry of Liberation War Affairs with the application. If the certificate is not submitted after writing 'yes', then the application shall be treated as cancelled.
- Candidate shall have to deposit Bank Draft/Pay Order of Tk 75/- (seventy-five) on Sonali Bank in favour of Secretary, Bangladesh Public Service Commission Secretariat or Treasury Challan of depositing Tk 75/- (seventy-five) under Code No. 1/0801/0000/2031 as examination fee with the application. This is non-refundable. Application shall be cancelled if Bank Draft/Pay Order/Treasury Challan is not submitted with the application.

- It is appropriate to submit application at the respective office of Commission Secretariat at the place where the candidate intends to appear at examination.
- Candidate must enclose the copies of the undermentioned certificates attested by 1st class gazetted officer with the application, otherwise application shall be treated as cancelled:-  
(I) As proof of age: Copy of original certificate of SSC/equivalent examination. Provisional certificate or admit card or testimonial shall not be acceptable in this case.  
(II) As proof of educational qualification: Copy of original certificates on all degrees secured from Board & University to prove educational qualification. In case of inability to submit original certificate (except SSC), provisional certificate shall be accepted. Marksheets from university shall also be accepted as proof of educational qualification on condition that original/provisional certificate must be submitted prior to interview.  
(III) Copy of character certificate from head of the last educational institution where from the candidate has secured the advertised educational qualification.  
(IV) In case of freedom fighters: Copy of freedom fighter's original/provisional certificate issued from the Ministry of Liberation War Affairs.  
(V) In case of freedom fighter's/martyred freedom fighter's wards copy of freedom fighter/martyred freedom fighter father's/mother's original/provisional certificate (issued from the Ministry of Liberation War Affairs).  
(VI) In case of tribals: Certificates received from appropriate authority.  
(VII) Experience certificate from proper authority: Experience certificate must state that the govt/private colleges/educational institutions the candidate has taught at are degree college/university level educational institutions and his/her secured teaching experience is of degree level. If it is not mentioned that the institution is degree college/university & secured experience is of degree level in the experience certificate and if joining letter is submitted without submitting experience certificate, the candidature shall be cancelled.
- Any kind of canvassing or recommendation shall only prove disqualification of candidate.
- Application form (BPSC Form-3) should be filled in with pen & signed and BPSC Form-4 should be signed with pen; application signed with pencil shall be treated as cancelled.
- Candidate's name & father's name should be written in application exactly same as written in SSC or equivalent certificate. Md./Mohd./Muhammad whatever there before father's name in SSC certificate should be written exactly the same in application even if the father happens to be late (dead). In case of any ambiguity found in self name & father's name, the application shall be treated as cancelled.
- In case the permanent address given by the candidate in application happens to be different from earlier mentioned permanent address in certificate elsewhere or husband's address is used in case of woman, then the candidate should submit certificate signed by respective city corporation chairman/ward commissioner/municipality chairman/union council chairman/notary public in support of the changed permanent address with the application.
- The govt reserves the right to decrease/increase or cancel/withdraw the advertised vacant post.
- If the terms & conditions applied to this advertisement do not conform with any terms & conditions of the application or instructions, then the terms & conditions of advertisement shall be treated as final.
- The commission shall consider all applications and take selection test/interview of only those candidates whose application will be considered as eligible by the commission. But if the application form is not properly filled in as per terms & conditions of advertisement, partially filled in, any column-left incomplete or wrong information furnished, not signed & attested copy of necessary certificates not submitted, ambiguity in candidate's & father's name found in application & different certificates, then candidature shall be cancelled at any stage of selection process i.e. before or after selection test/interview whenever these irregularities are detected.  
N.B: At the time of interview, all original or provisional certificates of educational qualification issued by Board of Education & University, original copy of experience certificate advertised for degree college/university teaching issued by appropriate authority applicable for all posts, clearance from appointing authority & original copy of character certificate from head of the educational institution last attended must be submitted to the Board of Interview. Otherwise viva voce shall not be taken.
- In case the information provided by candidate on his/her educational qualification proved wrong his/her candidature shall be cancelled. Even cancelling the recommendation the commission given for him/her the commission may declare the candidate disqualified from any post of govt service advertised by the commission for up to any time next for his/her offence. Even legal action may be taken against such candidate.
- In cases where the number of candidates may be much higher than the number of posts, a written selection test may be taken before interview. In matters of whether the selection test/interview shall be held at the Commission's Regional Office i.e. Chittagong, Rajshahi, Khulna, Barisal or Sylhet, the decision of the Commission shall be treated as final. In case it is not practicable to hold selection test/interview at any centre chosen by the candidate then the candidate shall have to take part in selection test/interview at the centre mentioned in admit card/interview letter by the commission.
- Definition of Departmental candidate: Departmental candidates are who hold post or posts in the same line of service for at least two years either in substantive or officiating capacity and are eligible for promotion or direct recruitment to the post advertised provided that their age at the time of first appointment to government service was within the age limit prescribed for direct appointment to the post.

**Request for Expressions of Interest for Selection of Capacity Building Service Providers**

- The Government of the People's Republic of Bangladesh has received a credit towards the cost of the Local Governance Support Project (LGSP) from the International Development Association (IDA). The Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives (MLGRD&C) has initiated the implementation of LGSP and intends to apply part of the proceeds for services to be provided by Service Providers (autonomous public sector or private sector) under Division-wise packages described as follow in the table below to build capacity at the local government level and in particular to the Union Parishads (UPs) and to Upazila Resource Teams (URT):

- The scope of services will include: Undergoing training of trainers' sessions; drafting capacity building work plans; conducting basic training for all Upazila Resource Teams comprising of selected Upazila level officers with LGSP Module 1 (Introduction and Orientation); conducting basic training for selected UPs with LGSP Modules 1 (Introduction and Orientation), 2 (UP Planning and Budgeting) and 3 (UP Budget Execution, Procurement, Financial Management and Reporting); organising other capacity building activities; and providing reports.
- The working area under each package (names of Districts, number of Upazilas and UPs, number of URT and UP trainees) may vary during Request for Proposal (RFP) and/or contract negotiation. A Service Provider may express interest for more than one package; however, the number of packages for which the Service Provider will be short-listed will depend upon its qualification, experience and capacity. Service Providers may associate with others to enhance their qualification, but should clearly mention whether the association is in the form of a "joint venture" or "sub-consultancy". In the case of an association, all members of such an association should have real and well-defined inputs to the assignment.
- The Local Government Division of MLGRD&C now invites eligible Service Providers to submit their Expressions of Interest (EOI) separately for each of the abovementioned contract packages (package-wise) for providing the required services. Interested Service Providers must submit information with documentary evidences in support of the requirements described in paragraph 5 below indicating that they are qualified to perform the services (brochures, description of assignments of similar nature, experience in similar conditions, availability of appropriate skills among the staff, etc.).
- The EOIs received will be reviewed on the basis of the following:
  - Registration and age of the Service Provider (Institution).
  - Record of competent capacity building in Bangladesh.
  - Experience of working with local government institutions (especially UPs).
  - Knowledge of the local government system, its role/mandates and how it interfaces with the civil administration.
  - Availability of appropriate human and logistical resources.
  - Adequacy of resources for timely delivery of contracted services.
  - Availability of communications facilities (telephone, fax, internet,)
  - Knowledge of the districts/divisions to be covered.
- Service Providers will be selected using the selection sub-method in accordance with the Public Procurement Regulations, 2003 issued by the GOB ([www.cptu.gov.bd](http://www.cptu.gov.bd)). It is expected that the services will be commenced in February 2007 and continue up to December 2007.
- Interested Service Providers may obtain further information from the office of the undersigned during office hours on working days. The authority reserves the right to accept or reject any or all EOIs received without assigning any reason thereof.
