Advisers tell Zakaria to go on leave, spare Modabbir

EC changes poll schedule again but not the voting date

The advisory council of caretaker government requested Election Commissioner SM Zakaria yesterday to go on leave of absence while at its request the Election Commission (EC) rescheduled the polls timetable again, keeping in mind holding of election within the 90-day constitutional obligation. The advisory council claimed that it has implemented the entire package proposal finalised 16 days ago although the proposals also included sending of Election Commissioner Modabbir Hossain Chowdhury on leave and appointment of new election commissioners to recast the EC.

The council of advisers also decided not to appoint any new

election commissioner although its package proposal had a deal in this regard.

Upon hearing about the latest changes, the Awami League (AL) led grand alliance rejected them, sources said.

A delegation of the AL-led grand alliance rushed to the EC yesterday afternoon and rejected the new timetable for the ninth parliamentary election, demanding announcement of election schedule after properly correcting the voter list first.

The grand electoral alliance—consisting of the AL-led 14-party alliance, Jatiya Party (Ershad), Liberal Democratic Party, a faction of Islami Oikya Jote, and Islami Oikya Front—will clarify its stance on the over-all situation today. Sources said the Bangladesh

communicated with Zakaria yesterday afternoon and informed him of the advisory council's decision.

In line with the request of the council of advisers, the EC rescheduled the next election by extending the deadline for filing nomination papers by three days up to December 24. Today was the deadline in the earlier schedule.

The dates for other stages of the election were also re-fixed. In the new timetable, the date for scrutiny of nomination papers is December 28 and the date for withdrawal of candidature is January 3. The previous deadlines were December 22 and 28.

The polling date, however, remains the same—January 22. The EC has to complete the election by January 25, the last day of the con-

stitutionally stipulated 90-day period for holding election.

EC Secretary Abdur Rashid Sarkar disclosed the new polls schedule yesterday afternoon through a gazette notification. He said the EC rescheduled the official polls plan to ensure participation of all political parties in the election.

Following these latest developments towards resolving the existing political deadlock, the council of advisers hoped that all political parties will now participate in the election.

"The council of advisers has now implemented the entire agreed package proposal and hoped that the decision will be acceptable to all. We also hope that all political parties will now participate in the election process,"

Iajuddin 'key obstacle' to fair polls

AL, LDP tell EU observers

Leaders of Awami League (AL) and Liberal Democratic Party (LDP) in separate meetings with the European Union (EU) election observation team yesterday described President Iajuddin Ahmed as the 'key obstacle' to a free, fair and neutral election.

Observing that Iajuddin's activities will go in favour of the BNP-Jamaat alliance in the upcoming polls, the leaders of both the parties said other than his resignation from the post of the chief adviser (CA), there is no other way for holding the election in a credible manner.

The three-member team, led by chief observer Alexander Lambsdorff, which also met senior leaders of BNP, emphasised creating a congenial atmosphere for the polls with participation of all parties. Other members of the team

Latest proposal of advisers rejected

14-party, LDP, JP decide today new agitation plan

Awami League (AL)-led 14-party coalition, Jatiya Party (JP-Ershad) and Liberal Democratic Party (LDP)-led Jatiya Oikya Front (JOF) yesterday rejected the fresh proposals of the advisers to the caretaker government (CG).

In separate news conferences, they termed the CG's latest move 'a fresh conspiracy and a piecemeal approach only to mislead the people'.

"The latest announcement is not acceptable. It's a move to mislead the people. No one talked to us before taking the decision," 14-party Coordinator Abdul Jalil told a news briefing at his NAM Bhawan residence in the capital.

Prior to 14-party's briefing, JP and LDP held two separate news conferences over the matter.

Earlier, Jalil also AL general secretary, visited JP Chairman HM Ershad at his President's Park residence in the morning and discussed the current political situation with him.

He also consulted with the top leaders of LDP, Zaker Party and other components of the grand electoral alliance before the briefing.

AL-led alliance will sit again today to chalk out fresh programmes.

In a latest development yesterday, the CG decided to make a formal request to 'controversial' Election Commissioner SM Zakaria to go on a leave and the Election Commission (EC) rescheduled the next election without changing the polling date.

FAULTY TONGI POWER PLANT 9 top PDB officials sued for graft

The Anti Corruption Commission (ACC) yesterday filed a case against nine Power Development Board (PDB) officials, including one of its former chairmen, involved in the construction of the Tongi 80 megawatt power plant.

The nine officials are accused of deliberately accepting sub-standard machinery from the plant's Chinese builder Harbin, as well as dispensing with the approval of higher authorities for the deviation they committed for their personal gains, the case filed with Gazipur Police Station states.

The accused officials are: SA Mayeed (former chairman of PDB), Dr MAK Azad (former member (Generation), PDB), BSMM Haq Fatimi (former project director), Akhtarul Islam (director, Ghorashal power plant), Naimul Hossain (deputy director of

3 cattle lifters beaten to death in Ctg

A mob beat three cattle lifters to death and injured one at Syedpur in Sitakunda upazila during early hours yesterday.

One of the killed was identified as Nurun Nabi, 30, from Phulbaria of Mymensingh while the other two remained unidentified.

The injured, Rabiul alias Ronny, 35, was undergoing treatment at Chittagong Medical College Hospital (CMCH), said police.

Sources said a gang of ten cattle thieves on a truck went to West Bakkhali village of Madhyam Bogachatar under Syedpur at around 2:30am.

Western envoys meet BNP leaders, advocate all-party participation in polls

Diplomats from several Western countries and representatives of UNDP and other donor agencies met BNP Secretary General Abdul Mannan Bhuiyan yesterday and once again raised voices for holding a free and neutral election with participation of all political parties.

Sources said BNP leaders told the delegation that according to

the constitutional framework there is no scope to defer the poll date beyond the stipulated 90 days.

The envoys, however, did not express any opinion to the BNP leaders.

British High Commissioner Anwar Choudhury, who led the delegation, also did not make any comment while talking to reporters after the meeting at the BNP
