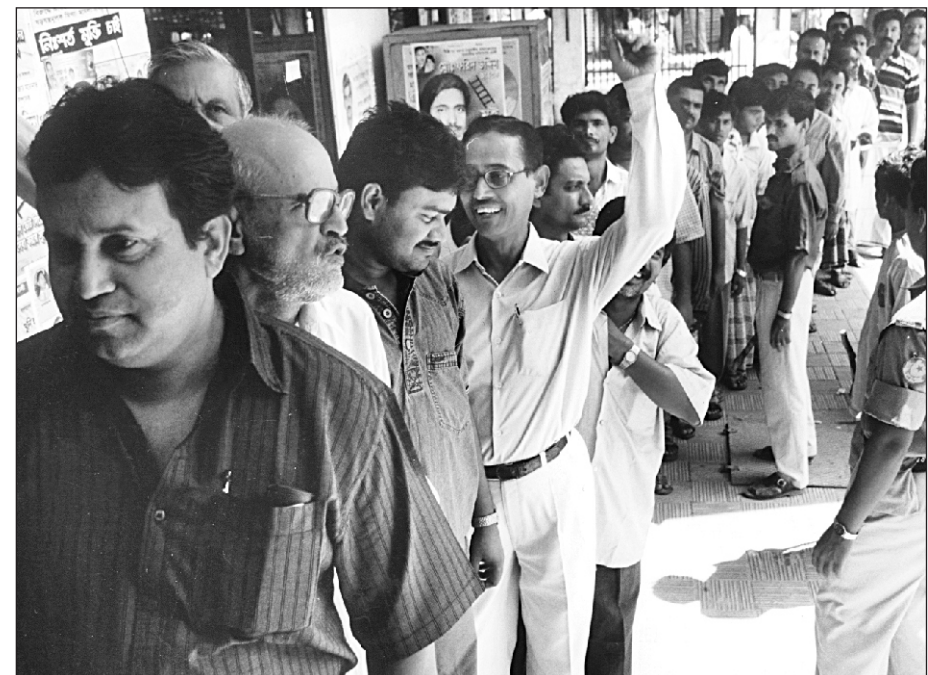


# Voter list isn't the issue

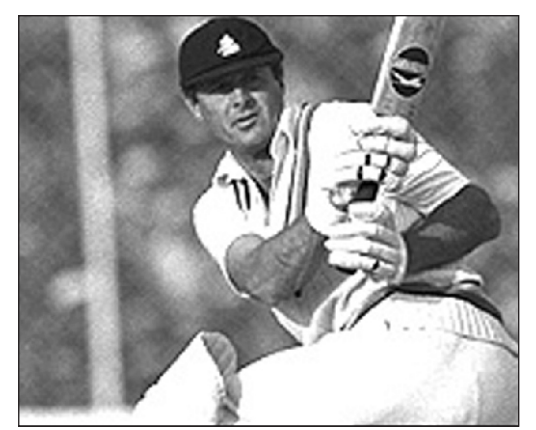

There is stark contrast between Dhaka airport and Bangkok Subarnabhum Airport. Bangkok airport is passenger friendly and convenient. Dhaka airport is rude and unfriendly. As we arrive in Dhaka airport departure area we confront security personnel as if we require only security at our airport and life! There are two terminals but in name only. Airlines do not guide from which terminal passengers should enter. Security will not allow the passengers' relatives to enter the lounge. It seems that we are living in a police state. The immigration police gossip more than they work. On 23 December we witnessed an immigration officer quitting the

desk while ten persons were still in the queue. He had to be requested and brought back. In Bangkok airport we just walk into the departure area and make a queue. An official of the airport authority directs the passengers to the reporting desk. There is no breach of line or discipline. Luggage is weighed and boarding card is issued. Passengers then can relax with his/her friend or family and enter the departure lounge. We are received with smiles everywhere. People are not overtly overburdened with security measures. We would request the authorities concerned to arrange passenger friendly orientation courses for the officials working at the airport and also open the arrival and departure lounges for public. **SN Mamoon, On e-mail**
