

Bilateral issues to be resolved thru' discussion

President tells new Indian HC

UNB, Dhaka

President Iajuddin Ahmed yesterday said the bilateral issues with India, including the proposed Tipaimukh dam on the Barak river, will be resolved through discussion.

The president said this when newly appointed Indian High Commissioner to Bangladesh Pinak Ranjan Chakraborty presented his credentials to him at the Bangabhaban.

Welcoming the new Indian envoy, the president said Bangladesh attaches great importance to its relations with India and is deeply committed to promoting peace, progress and development

through bilateral and regional cooperation.

He also stressed the need for inter-university linkage between Bangladesh and India, particularly with Dhaka University.

The president said the prosperity and economic development of Bangladesh and India are closely inter-related and it is necessary to intensify efforts to enhance economic cooperation between the two neighbouring countries.

Bangladesh would like to see greater cooperation and interactions with India in the field of trade and commerce, he said and hoped that both the countries would take appropriate measures to expand

and diversify economic and trade relations.

The president assured the high commissioner of all support and cooperation in discharging his responsibilities.

He requested the envoy to convey his best wishes to Indian President APJ Abdul Kalam and Prime Minister Manmohan Singh.

The Indian high commissioner termed the relations between India and Bangladesh "excellent" and said it would be further strengthened in the days to come through people-to-people contact.

He said he will take the issue of the proposed Tipaimukh dam with his government.

Charges framed against Mirza Jalil, 8 others
Trial on Jan 21

A Dhaka court yesterday framed charges against Krishak League President Dr Mirza Abdul Jalil and eight others in a case filed under the Speedy Trial (Law and Order Disruption) Act.

The case was filed against them for damaging a police van and disrupting law and order at Shyamoli Ring Road in the capital during hartal hours on December 21 last year.

After scrutinising the case docket (CD) and other relevant documents of the case, Metropolitan Magistrate Abdur Rouf Khan of the Speedy Trial Court-2 framed charges against them and fixed January 21 for trial of the case.

Other accused are Jalil's personal secretary Naimul Haq, 25, assistant personal secretary Abdul Barek, 28, Ershad Hossain, 25, Humayun Kabir, 27, Kabir Ahmed, 22, Sekendar Ali, 23, Jamal Uddin, 25, and Abul Hashem, alias Hasu, 30.

Dr Jalil and others pleaded not guilty and demanded justice before the court after the charges were read out to them.

Earlier on January 7, Sub-Inspector Golam Rasul, who is the investigation officer (IO) of the case, submitted the charge sheet to the Chief Metropolitan Magistrate's Court, Dhaka, showing 37 people as prosecution witnesses.

Police also implicated around 1000 to 1200 others under the same act, but the IO did not mention their names in the charge sheet.

In the charge sheet, the IO stated that the charges brought against them were initially proved and they should be brought under trial.

Police arrested Dr Jalil and others from the spot during the incidents. Later, they were granted bail by the court.

Three to die for killing Khulna madrasa student

A Khulna court yesterday sentenced three people to life imprisonment for killing a student of Nurul Ulum Hafizia Madrasa in 2004.

District and Sessions Judge AKM Ishtiaque Hossain handed down the verdict on Hussein Ahmed alias Chhoto Huzur, Shaikh Rabiu Islam and Md Mahmudul Haque. Of them, Chhoto Huzur was tried in absentia.

According to the prosecution, Imran Hossain Rony was slaughtered inside the madrasa at Basupara in the early morning of September 19 in 2004.

Sub Inspector Shabbir Ahmed, who investigated the case, submitted charge sheet against the four accused on February 5 in 2005 and the charges were framed on June 15 the same year.

DEFAMATION SUIT
Jugantor editor, publisher asked to appear in court

A Dhaka court yesterday asked Jugantor editor, publisher and its proprietor to appear before it on February 21 after former communications minister Barrister Nazmul Huda filed a defamation case against them.

Metropolitan Magistrate Mohammad Mizanur Rahman issued the order following the case with the Chief Metropolitan Magistrate's Court seeking an arrest warrant against them from the court.

The defendants are editor Golam Sarwar, publisher Advocate Salma Islam and its proprietor Nurul Islam Babul.

In his complaint, Huda mentioned that the daily ran a news item titled "Nazmul Huda is the first in corruption" that is false, fabricated and concocted and it was done to tarnish his image in the political arena as well as in the society.

500 suffering from filariasis in Rajshahi city

Nearly 500 residents of Rajshahi City Corporation areas are suffering from filariasis, a mosquito-borne parasitic disease, according to a survey.

Name street after Sir Salimullah

Speakers urge govt

Name a city street after Nawab Sir Khwaza Salimullah Bahadur in recognition of his contribution to the development of Dhaka city, demanded his successors at a discussion yesterday.

They also urged the government to set up committees at every district to pay due homage to great philanthropist on the occasion of his birth and death anniversaries.

The discussion was organised by the national committee to observe birth and death anniversaries of Nawab Salimullah marking his 92nd death anniversary on the premises of Ahsan Manzil Museum in the old city.

Speakers at the discussion highlighted the life and works of Nawab Salimullah.

They recalled the outstanding contribution of Salimullah to the advancement of education, especially madrasa education and politics as well.

While presenting a keynote

paper titled 'The role of Salimullah in the movement for education of Muslims in Bangla', Dr Md Alamgir, deputy keeper of Ahsan Manzil Museum, said Salimullah, who mainly patronised Islami ideology and modernised education, was eventually involved in politics.

In 1906, Salimullah took initiative to reform Madrasa curriculum since students completing education from there could not avail themselves of suitable jobs in comparison to non-Muslim students who used to receive education from mainstream institutions, he added.

"Many of us do not know that Ahsan Ullah Engineering School founded at the own initiative of Salimullah is now known as Bangladesh University of Engineering and Technology (Buet)," said Alamgir.

Khwaza Ehsanul Haque Bhola, a successor of Salimullah, called upon the authorities concerned to observe both birth and death

anniversaries of Salimullah and name a city street after his name.

Talking to The Daily Star, actor Khwaza Naim Murad, a great grandson of Salimullah, lamented that the birth and death anniversaries of Salimullah, one of the great leaders of the sub-continent, are not observed in a befitting manner at national level.

Naim also regretted that Sir Salimullah, as the founder of Bangladesh Muslim League, Kobi Nazrul College, Mitford Hospital and one of founders of Dhaka University, has not been given adequate exposure in the textbooks.

Mayor Sadeque Hossain Khoka addressed the seminar as chief guest while Begum Shamsunnahar Khwaza Ahsan Ullah, daughter-in-law of Sir Salimullah, spoke as special guest.

Earlier, Qurankhwani and doa mahfil were held for the salvation of the departed soul.
