

300 shops removed from footpaths in Chittagong

In a massive drive, the authorities dismantled around 300 illegal makeshift shops on footpaths in different areas of Chittagong city yesterday in a bid to facilitate easy movement of traffic and pedestrians.

Also, several hundred illegal electricity connections were snapped during the coordinated drive.

Chittagong Port Authority (CPA) Magistrate Mohammad Munir Chowdhury conducted the drive named 'Operation Safeguard Civic Rights' with the assistance from Chittagong City Corporation (CCC) and Chittagong Metropolitan Police (CMP), sources said.

Over 250 illegally erected makeshift and floating shops were removed from the busy New Market, Darul Fazal Market, Reazuddin Bazar Amtala and

Station Road areas. These shops also occupied a portion of the busy roads, hampering the movement of traffic.

During the four-hour drive, illegally extended portions of various shops, signboards and slabs that covered the drains for erection of makeshift shops were demolished.

Cold claims 3 more lives in Satkhira

The city dwellers hailed the move to evict the vendors and hoped that the drive would continue against the illegal occupants.

Pilot killed in Indian Air Force jet crash

A pilot was killed in an Indian Air Force Jaguar bomber jet crash yesterday in the northern desert state of Rajasthan, officials and witnesses said.

The British-built aircraft took off from a military airbase in Bikaner district and reportedly caught fire in midair and exploded on impact with the ground in a village in the tourism town of Jaisalmer, eyewitnesses said, adding the pilot had died. Air force officials said the deep penetration bomber aircraft was on a "live firing exercise" in the desert state.

Indian papers say racism thrives in India

While in Britain there were institutions in place to deal with discrimination and Western nations were alert to racist attitudes, the Express concluded, in India the victims of such abuse often have nowhere to turn.

Almost 20,000 British viewers of "Celebrity Big Brother" have complained Shetty, 31, has been subjected to racist abuse on the show, prompting an investigation into the charges by British media watchdog Ofcom.

Shetty, known for her sensuous dancing, is famous in India but her career over the last year has been overshadowed by an up-and-coming generation of Bollywood stars.

One contestant referred to Shetty as "the Indian" and asked her if she lived in a shack, while another said: "You don't know where those hands have been." Two have mimicked her accent.

Leading woman militant held in Kashmir

A leading hardline woman separatist in revolt-hit Indian Kashmir was detained as she raided a cybercafe, police said yesterday, as part of her morality crusade in the main city of Srinagar.

"We have detained Aasiya Andrabi and five members from her party as they raided a cybercafe in downtown Srinagar," a police spokesman said.

Andrabi, head of the separatist Dukhtaran-e-Milat, or Daughters of Faith, has formed squads in the Muslim-majority state to raid brothels, cybercafes and other places where she says "immoral activities are carried out".

In a break with the past, when attitudes towards mixing between the sexes were more conservative, younger people in Kashmir are frequently seen dating in restaurants and walking in parks, raising the group's ire.

"We will expose those indulging in immoral activities," the 41-year-old Andrabi, who wears a head-to-toe veil, told people before storming the cafe.

The husband of Andrabi, a fiery speaker who has in the past voiced admiration for Al-Qaeda leader Osama bin Laden, is in jail on charges of being a militant.

Last year, she advertised a mobile telephone number for people to call "whenever you are convinced a man or woman has entered some place to commit adultery".

Adultery is illegal in the state and carries a potential jail term.

Andrabi was jailed for two months in 2005 for carrying out a similar campaign.

The group had earlier smeared black paint on racy Bollywood film posters portraying women in revealing clothing. It has also campaigned for women to veil themselves fully.

The drive has been largely unsuccessful in a region which espouses a more liberal form of Islam.

Indian Kashmir has been gripped by a 17-year-old revolt against New Delhi's rule that has claimed over 44,000 lives by official count, and double that number by the separatists' tally.
