The worst president!



I am writing with reference to "Saddam's end," by Prof. Juan Cole (Dec. 31).

Although Saddam Hussein was a brutal dictator who committed countless atrocities against his people, the way he was tried by highly biased judges and his almost immediate execution will leave many questions unanswered. US President George W. Bush shared the burden of misjudgement because Saddam was captured by the

American troops and not by the Iraqis. Prof. Cole is absolutely right when he says: "The political ineptitude of the tribunal, from start to finish, was astonishing. The United States and its Iraqi allies basically gave Saddam a platform on which to make himself a martyr to Iraqi unity and independence -- even if by unity and independence Saddam was really appealing to Sunnis' nostalgia for their days of hegemony."

Furthermore, if Bush wanted to salvage his failed presidency by the execution of the Iraqi dictator, he may be in for bitter disappointment. The capture of Saddam Hussein gave President Bush a temporary boost in the polls. But since then Iraq has spiralled into sectarian violence and the US military death toll is nearing 3,000 and Mr. Bush is now considered as the most unpopular president in recent history.

The execution of Saddam Hussein will do little or nothing to bolster Mr. Bush's paltry public approval ratings -- currently 70 per cent of Americans think he is doing poorly in Iraq -- or to improve a deteriorating security situation in Iraq. "Anytime the White House uses the term 'milestone' it's a stone around the president's neck," said Prof. Ray Tanter, national security expert at Georgetown University and a National Security Council member under former President Ronald Reagan. "You do not change the situation in Iraq by capturing Saddam, convicting Saddam and executing Saddam." Nothing changes the insurgency except a political deal. The president might get a little bump from this, but it will quickly go down because the situation on the ground hasn't changed.

This explains why Bush is dubbed "worst president" by many prominent US historians. "I would rate him as the worst at this point," said Robert McElvain, professor of history at Millsap University in Jacksonville, Mississippi. When the Washington Post asked five leading historians to assess Mr. Bush's legacy, the best he received was fifth worst.


Mr. Lind ranks Buchanan as the worst president in history because he allowed the nation to disintegrate under his watch before Abraham Lincoln saved it. He ranks Mr. Nixon as "second-worst" because he "perverted the constitution" during his efforts to cover up the Watergate scandal. Mr. Bush, in Mr. Lind's view, ranks as "fifth-worst" behind Buchanan, Nixon, Andrew Johnson and James Madison, who botched the War of 1812.

"It seems to me you condemn a president who started an optional war that could have been avoided, even if the costs are lower than a war that was very difficult to avoid, like Korea and Vietnam," Mr. Lind said in an interview. "If you create the crisis and make it worse, then you are a terrible president."

Bush still refuses to admit that in Iraq, the cost in blood and bullion has soared because of his insistence on staying on the failed course. The number of US military casualties stood at 2,999 on the day Saddam was hanged. And the conflict will bleed the US treasury by what will soon be a staggering \$1 trillion. Already a lame duck, now hobbled further by Democrat control of Congress, Bush has lost the backing of most Americans.

Saddam's hanging will be of little consolation if Bush is consigned to the dustbin of history.
