The Chairman, Mongla Port Authority has been allocated public fund from the Government of the People's Republic of Bangladesh (GoB) towards the cost of the Dredging at the Outer Bar in the Pussur Channel, and it intends to apply part of the proceeds of this fund to payment under the contract for consultancy services for monitoring of dredging and assessment of sustainability of the dredged channel at the outer bar in the Pussur channel using numerical modelling technique.

The services include: Monitoring of the dredging activities and assessment of the sustainability of the dredged channel in terms of backfilling rate and the sedimentation pattern in the dredged channel for an optimum navigational channel at Pussur entrance area using mathematical modelling, monitoring of pre and post dredging survey, assessing the probable maintenance dredging volume and frequency, environmental impact of the dredged spoil in terms of recirculation and increasing sediment concentration, development of baseline information on hydrological and morphological conditions in the Pussur entrance area and preservation of mathematical model for future consultation, dissemination of monitoring and modelling results to the stakeholders through interaction meetings and workshops.

The Chairman, Mongla Port Authority now invites eligible applicants to indicate their interest in providing the services. Interested consultants with international experience in the similar field are invited to provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar operating conditions in home and abroad, availability of appropriate professional qualification and experience, administrative strength and financial capability).
