

# Bush orders more troops to Kabul

President George W Bush said yesterday 3,200 more US troops being deployed to Afghanistan will help NATO forces launch a spring offensive against the Taliban.

The Pentagon announced on Wednesday that a US Army brigade of 3,200 troops will now go to Afghanistan instead of Iraq in order to maintain higher troop levels against the Taliban.

In a speech before the American Enterprise Institute, Bush said he was asking the US Congress for \$11.8 billion over the next two years to help the Afghan government of President Hamid Karzai.

"I've ordered an increase in US forces in Afghanistan. We've extended the stay of 3,200 troops now in the country for four months and will deploy a replacement force that will sustain this force for the foreseeable future," Bush said.

"These forces and funds are going to help President Karzai defeat common enemies," Bush said.

Nato, US and Taliban commanders have warned of an increase of fighting in the spring

when the snow melts, after the bloodiest year since the hard-line Islamists were ousted by a US-led coalition in 2001.

"This spring there's going to be a new offensive in Afghanistan, it's going to be a Nato offensive, and that's part of our strategy -- relentless in our pressure," Bush said.

For Nato to succeed in Afghanistan, Bush said member nations "must provide commanders on the ground with the troops and the equipment they need."

He said Nato allies must help fill security gaps and lift restrictions on the forces they supply "so Nato commanders have the flexibility they need to defeat the enemy wherever the enemy may make a stand."

Bush is bolstering the anti-Taliban forces in Afghanistan at the same time when he is sending 21,500 more US troops to Iraq, a decision for which he has drawn sharp criticism from Democratic lawmakers in the US Congress as well as many of his Republican allies.

## Murder accused Dicon remanded

A Dhaka court yesterday placed Shuib Saif Dicon, shown arrested in the Dr Aftab Ahmed murder case, on a two-day remand.

Dicon is also accused in the Indian rice trader Majid Alam murder case and the case of grenade attacks on Awami League rally at Bangabandhu Avenue on August 21, 2004. He is a close associate of top listed criminal Tanvir Ahmed Joy.

Earlier, the joint forces arrested Dicon and detained him in jail. He was produced before the Chief Metropolitan Magistrate's (CMM) court yesterday for hearing on a 10-day remand prayer submitted by the investigation officer.

Metropolitan Magistrate Shafiq Anwar placed Dicon on remand when the Detective Branch (DB) Inspector Mohammad Hasan Ali produced him before the magistrate's court.

On September 23 last year, former vice-chancellor of National University Dr Aftab was shot by a group of assailants at his Fuller Road residence on Dhaka University campus. Dr Aftab succumbed to his injuries on September 26.

Later, his wife Noorjahan Akhter filed a case with Shahbagh Police Station without mentioning any name of suspects involved in the murder.

Husain said he apprised him of the Tata projects.

Asked if he got positive response to the project from the adviser, he said, "We just apprised him, and I think, we should give them time to assess the situation."

He, however, said: "Since the benefits of the project are so good, obviously, we hope that they will also be looking at how to take it forward, if possible."

Husain was asked if he feels encouraged about their project after the current caretaker government recently signed a Tk 1033-crore deal with an Indian company for setting up 240MW power plants in Bangladesh. "I think, the best thing is to wait for some time," he said.

The official ruled out the possibility of any delegation of Tata visiting Bangladesh in the near future.

Asked if he thinks the current situation is favourable for foreign investment, Husain said, "Well, every situation is favourable for foreign investment... Only thing, intention should be there. And I think, every well-meaning Bangladeshi will have the good intention of getting foreign investment."

civil society members and election watchdogs, the sources said.

If the proposals are enacted, unregistered political parties will not be allowed to take part in the election. Besides, one intending to register with the EC will have to show a minimum popular acceptability. In that case, the EC will use a yardstick to measure the support a political party enjoys among the populace. The measures aim to keep the name-only parties from the polls.

A registered party will have to follow its constitution strictly in its functioning. It will have to have its accounts audited. The registration might be cancelled on violation of any provision of the laws.

Currently, the registration is optional. None of the major political parties has applied for enrolment since introduction of the relevant law in 2001.

The EC also plans to devise a mechanism to prevent use of unauthorised money by the political parties and candidates, the sources added.

Before the 2001 election, the commission's initiative to ban utility service bill defaulters from the polls failed in the face of opposition from the major political parties. This time, it is determined to have the necessary provisions in effect as the caretaker government has already hinted at massive reforms in the electoral system.

Many of the former lawmakers will have to pay their outstanding bills if they are to contest the election with the proposed law coming in force. Some 183 members of the last parliament owe the government Tk 1.25 crore in telephone bills.

that the answer would be given after a new chairman and two commissioners are appointed.

Delwar's statement of assets of his and his family members shows that he heads a five-member family and has served the government for 28 years.

He has in his possession a TV, a refrigerator, a computer, an air-conditioner, a washing machine, three beds, 10 chairs and tables and three cupboards. His immovable properties include a 7.5 katha plot allotted to him in Purbachal residential area and a small abandoned village home in Katchua of Chandpur. His earnings constitute government salary, honorarium for professional lectures at various training programmes, savings from travel allowances when visiting foreign countries etc. He holds a credit card with a limit of Tk 2 lakh. He resides in government quarters in Azimpur and does not own any house or car.

The ACC secretary has a savings account with the City Bank Ltd where salary and other cheque transactions worth Tk 30,000 to 40,000 are made every month.

Delwar said that he has taken huge loans from friends and relatives for the education of his three children who study in private universities and college. He hopes to pay back these loans upon his retirement.

"My statement may not be fully flawless -- but I welcome you (the press) to cross-check it and meet me at my Azimpur quarters," he said.

The ACC secretary said that he made this statement of his own volition because he believes this would uphold transparency and accountability in the ACC. "Whether the new chairman and commissioners would do the same would be their own choice to make," he added.

The chairman and two commissioners appointed by the previous alliance government in late 2004, resigned recently following the president's request. The posts are still vacant.

Among the 746 ACC employees, there are many bureaucrats on deputation.

impressive socio-economic progress over the recent years."

She added, "Upgrading the railway network will directly reduce transport costs of Bangladesh's major exports, especially readymade garments."

Zhu Xian, the World Bank country director, said their \$ 40 million development-support credit is one of the flagship operations with our Country Assistance Strategy partners.

The donor agency executive further said it will play a "catalytic role for ensuring the success of the reform programme by coordinating with all donors and the wider government ministries and agencies".

The Railway Sector Investment Programme (RSIP) is the first joint initiative of ADB, JBIC and WB, which, together with the DFID, have developed joint strategies to assist Bangladesh in a "more coordinated manner", says a joint release from the funding agencies.

Of the ADB's \$130 million, \$100 million will go to support Bangladesh Railway's priority investments and \$ 30 million for funding the reform process.

The Manila-based Asian development-financing institution's total commitment for the comprehensive RSIP scheme amounts to \$ 430 million under the Multi-Financing Facility. The balance of the loan will be made available later, in line with the agreement between the ADB and the government.

The World Bank's \$ 40 million will be used to support the government effort to make institutional and governance improvements in Bangladesh Railway, as well as to improve financial management and

professionally or would be able to override any form of fellow feeling while dealing with corruption of a senior bureaucrat, he said "It's not true that the ACC will not be able to take action against a secretary for his corruption. We will try to prove our neutrality."

appear before the court yesterday due to illness. Therefore, he prayed for adjournment of the verdict in the case.

Earlier, the prosecution and the defence had completed their arguments and the court recorded statements of eight prosecution witnesses including the complainant and investigation officer (IO) of the case.

Around 16 years back, a team of customs officials held four people including two foreign nationals from Zia International Airport on July 17, 1990 during their attempt to smuggle around 3.6 kg of gold worth around Tk 2.5 crore into Bangladesh.

A smuggling case was filed with the Cantonment Police Station the same day against the four -- Bernhard Rudiger of Germany, David Anthony Chalmers of England, then manager of the Zia International Airport Major (retd) Ashraf Uddin Sekender and Abu Taher, an airport security guard.

During the investigation, the IO found evidence of Ershad's involvement in the smuggling and his name was included in the charge sheet on August 31, 1991.

prevented Bangladesh from moving forward. The administration and law enforcement agencies have now got an opportunity to play a vital role in this situation.

He however warned that in the ongoing drives, the poor, vulnerable and honest people must not be harassed or harmed.

The CG is committed to rejuvenating the economy and keeping the prices of essentials at a tolerable level, the CA said. He asked both administration and police officials to play their role in ensuring a stable supply of goods in the market. "Divisional commissioners and deputy commissioners have been given orders in this regard," he added.

"Continue your drive against the business syndicates and ill-motivated wholesalers to maintain reasonable prices of essentials. Be proactive in taking legal action against smugglers, loan defaulters and people who adulterate food products. Especially, take initiatives to expedite the legal processes," said Fakhruddin.

About the AL-led grand alliance, the LDP leader said, "It will remain as it is now."

Responding to a query, he said they discussed the latest political situation prevailing in the country and their plans for the coming days.

"We have discussed on what course to take and how we to proceed forward after the withdrawal of restrictions on political activities," he said.

"We have raised some demands to the caretaker government... the corrupt people must be arrested and steps have to be taken so that they cannot participate in the election," Oli said.

Referring to the grand alliance's demand for recasting the Election Commission (EC), he said the EC has been reconstituted and those who have been appointed are good people. "I think free, fair and credible elections are possible under their supervision," the LDP leader observed.

Oli expressed his opinion for a total shake-up of the Anti-corruption Commission so that it could take action against all corrupt people, even the top people of any government.

About a provision that bars any appointment in the armed forces if the person was involved with student politics, he said similar system should also be introduced in recruiting civil servants.

Responding to a question about Noble laureate Prof Muhammad Yunus' plan to launch a political party, Oli said anybody in the country can join politics.

"But those who win a prestigious award like the Noble Prize should not switch over to political platform, leaving their own domain of work," he observed, but hastened to add that he would welcome Prof Yunus if he joins politics or launches a political party.

"Now it is for him to decide how he will enter politics and when," said Oli.

months with his income, land property and shares in different companies growing manifold.

Pintu's statement shows that his annual income shot up 104 times from Tk 3 lakh to Tk 3.13 crore while his land property expanded from 1.31 katha to 176 katha during the period.

HIS SURRENDER

Pintu surrendered to the Court of Chief Metropolitan Magistrate, Dhaka at 10:00am yesterday although the hearing of the two cases was scheduled for 12:30pm.

A few of his cadres accompanied him to the court.

His lawyers--advocate Sanaullah Mia and Masud Ahmed Talukder--took him to the court of Metropolitan Magistrate Shafiq Anwar at 12:45pm where his cases were scheduled to be heard.

Kabir Hossain, a BNP worker of Baragram in Kamrangirchar, filed the alleged murder case with the chief metropolitan magistrate's court on January 25 after local police refused to record his complaint.

Shahidul Islam, another resident of Munshihati in Kamrangirchar, filed a theft case against Pintu on February 13.

Pintu and his lawyers submitted that the charges against him are false and sought bail while the prosecution prayed for sending him to jail.

Hearing both the sides, the court ordered to send Pintu to Dhaka Central Jail.

On June 26 last year, Pintu called BNP worker Kabir out of his house and beat up mercilessly with hockey stick for "larnishing" his image. The former lawmaker dumped Kabir--with fractured hands and injuries to the head--in a nearby dustbin.

Kabir went to Hazaribagh Police Station to lodge a complaint against Pintu, but the police refused to take the complaint.

Later, acting on a court order, the Hazaribagh police investigated the incident and found the former BNP lawmaker guilty.

On February 13, Pintu and three others went to Shahidul's house around 12:30am and demanded why he got Faruque Member, a supporter of Pintu, arrested with a firearm. As Shahidul protested the allegation, the four beat him up and took away from him a gold chain, a mobile phone and Tk 4,700 in cash.

"While leaving, Pintu threatened me with life if I disclosed the incident to anyone," Shahidul said in his complaint.

Pintu was arrested on December 26, 2004 for the charge and was later given a 30-day detention.

In April 2005, the government withdrew another case against Pintu filed for assaulting and injuring police and AL members with a procession in Lalbagh on April 15, 1998.

The police arrested Pintu along with 12 others from the spot and filed the case against them, but he received bail from the court.

# Journos barred from entering JS secretariat

Speaker Jamiruddin Sircar yesterday barred journalists from entering the parliament secretariat for 'security reasons'.

Directed by the Speaker, security staff barred two reporters at the entry to the Jatiya Sangsad Bhaban yesterday even after they showed accreditation cards, which are used to get access to government offices.

The restriction on journalists was imposed following publication of news in several daily newspapers on alleged corruption in appointment of fourth-class employees in the parliament secretariat.

The Speaker, however, told reporters over telephone that he has imposed temporary restrictions as parliament is not in session.

"Temporary restrictions have been put on journalists' entry to the parliament building for security reasons," Sircar said.
