

Fish market raids reveal formalin horror

6.5 tonnes medicine-mixed fish destroyed; 10 traders jailed

Metropolitan Magistrate Rokun Ud-Doula never discloses early which place his mobile court is going to raid, not even to his team. When he started at 4:00am yesterday, with 23 journalists from both print and electronic media, nobody knew where they were going.

The drive eventually proved to be a huge one in its history as the mobile court jailed 10 wholesale fish traders and destroyed 172 maunds or six and a half tonnes (a maund=37.5kg approx) formalin-treated fishes and seized five maunds jatka (small Hilsha) from the wholesale fish markets at Sawarighat, Kaptan Bazar and Waizghat in the city.

The court comprising a large group of the joint forces seized and destroyed 164 maunds Ruhi fish, five maunds Cheoa fish and about a maund shrimp for presence of toxic formalin in them.

After an instant trial it awarded five traders 11 months' imprisonment and fined them Tk 50,000 each under the Fish Protection and Conservation Act.

The court also sold five maunds jatka seized from Kaptan Bazar and Waizghat fish markets for Tk 19,800 at auction. It sentenced five traders to 11 months' imprisonment and

fined them Tk 5,000 each.

The joint forces arrested all the ten fish traders and the mobile court sent them to jail.

Officials from the Department

of Fisheries were also present during the drive.

Sawarighat is one of the biggest wholesale fish markets on the bank of the Buriganga where fishes come

from different parts of the country as well as Myanmar.

More than 800 wholesalers and stockists operate in the market for

AL focuses on party reforms

Moves for internal democracy, transparency in accounts, EC registration

Awami League (AL) is making a move to reform itself by strengthening internal democracy, bringing transparency to the party's accounts, and modernising the system of induction of members.

It will also register with the Election Commission (EC), take collective decisions, hold councils on time, establish accountability at all levels, and take actions against corrupt and criminal members,

among other things, according to party sources.

AL President Sheikh Hasina held a closed door meeting with some of the party's top leaders and all joint and organising secretaries in her Dhanmondi office on Friday night as part of her initiative to reform the party with a long tradition, the sources said.

The meeting candidly debated about many problems prevailing in the party and reached a consensus

A Dhaka court yesterday sent to jail former state minister Mir Nasiruddin's son while the joint forces in countrywide drives arrested the public prosecutor (PP) of Meherpur and several ward commissioners and union parishad (UP) chairmen.

In the port city, the army-led teams held Chittagong City Corporation Ward Commissioner and port CBA leader Jahangir Alam and Sandwip Ward Commissioner Nazim Uddin. In Sylhet, they arrested Sylhet City Corporation

Ward Commissioner and BNP leader Farhad Chowdhury Shamim.

A press release of the police headquarters yesterday said the lawenforcers arrested 1,489 people on various charges and seized 11 firearms and 50 bullets from across the country in 24 hours ending at 6:00am yesterday.

Shopping malls all over the country will shut at 7:00pm daily from today under load management plan aimed at tackling a chronic power crisis.

Kitchen markets and medicine stores are exempted from the measure taken last week in a meeting between Power and Energy Advisor Tapan Chowdhury and representatives of the Shop Owners Association at Bangladesh Secretariat.

To enforce the decision, about 100 mobile teams of Dhaka Electric Supply Authority (DESA) will move and monitor the compliance in the capital.

Member (Engineering & Commercial) Ataul Masud told the news agency that his organisation

ACC deadline ends today

Only 5 out of 50 submit wealth statement

The 72-hour deadline for submissions of wealth statements by 50 corruption suspects to the Anti-corruption Commission (ACC) expires at 5:00pm today with only five of them so far complying with the order.

If any listed suspect fails to submit his or her wealth statement to the anti-graft commission within the deadline, movable and immovable properties of that person will be confiscated, accord-

ing to the summons signed by ACC Secretary Delwar Hossain.

Delwar Hossain on Thursday told newsmen that some of the listed suspects received the summons late, so the commission might extend the deadline for them till 12 noon or 1:00pm Monday.

Former BNP lawmaker Rashiduzzaman Millat and former Jamaat lawmaker Shajahan Chowdhury submitted their wealth statements on Tuesday. Awami League Presidium Member and
