VLANDALISM AT SC
Kamal, Amir,
Rokan asked
to appear in
court April 19

A Dhaka court yesterday directed lawyers Dr Kamal Hossain, barrister Amir-Ul Islam, barrister Rokanuddin Mahmud and 10 others to appear before it on April 19 in connection with a case filed for vandalism on the Supreme Court (SC) premises on November 30 last year.

After scrutinising the case docket and other relevant documents, Metropolitan Magistrate Mohammad Shamsul Alam set the date for next hearing of the case.

Advocates Syed Rezaur Rahman and Kamruzzaman Mahboob submitted two petitions seeking time for Kamal and 11 others, as they could not appear before it on personal grounds.

Earlier on December 22 last year, Detective Branch Inspector Naimur Huq, also the investigation officer (IO) of the case, pressed charges against 13 including Kamal, Amir and Rokan, showing 28 people as prosecution witnesses.

Detention of SQ Chy declared illegal

Monju, Aminul denied anticipatory bail

UNB, Dhaka

The High Court yesterday declared illegal the detention of former lawmaker Salahuddin Quader Chowdhury under the Special Powers Act, 1974.

Passing the verdict upon a habeas corpus petition, a division bench comprising Justice MA Wahab Mian and Justice M Emdadul Huq directed the government to release SQ Chowdhury if he is not wanted in any other case.

Army-led joint forces arrested SQ Chowdhury on February 4 in its crackdown on suspected corrupt politicians, businessmen and influential persons.

Later, he was sent to jail on a 30-day detention under the Special Powers Act.

AD-INTERIM ANTICIPATORY BAIL OF MONJU, AMINUL REJECTED

The High Court yesterday turned down the plea for ad-interim anticipatory bail for former ministers Anwar Hossain Monju and Barrister Aminul Huq but restrained law-enforcers from arresting the two former ministers.

Loss on environmental damage 4pc of GDP

Says World Bank report

Environmental damage accounts for economic losses equivalent to more than 4 percent of Bangladesh's GDP, says a World Bank (WB) report.

The report titled 'Bangladesh Country Environment Analysis' also estimates that environmental factors cause as much as 22 percent of deaths and diseases that cost high in terms of the nation's health.

Launched at a city hotel yesterday, the report was jointly prepared by the Ministry of Environment and Forest and WB.

It also said that the largest share of the economic losses is attributed to a lack of basic infrastructure

services, such as water, sanitation and energy.

The report identified three sources of environmental degradation that need priority attention, which are indoor and urban air pollution, degradation of water quality in Dhaka and over-fishing.

Bangladesh's achievement of steady economic growth of more than 5 percent over the last decade has been key to reducing poverty, but at the same time it created many environmental challenges, particularly in the urban and industrialised areas, it noted.

"The challenge, therefore, is to identify policies and interventions that foster economic growth without damaging the environment and

people's lives," the country environment analysis suggested.

Linking air pollution to health, the WB Senior Environment Specialist Paul Jonathan Martin in the presentation said the respiratory infections and diseases caused by poor air quality, both indoor and urban, contribute up to 10 percent of the nation's total burden of diseases.

Inhaling smoke generated from cooking with biomass fuel can cause both temporary and permanent damage to human health, he said, suggesting public education campaigns as short-term measures and promotion and commercialisation of cleaner fuels

Nazmul Huda, Falu denied bail

Aman shown held in graft case

A Dhaka court yesterday rejected the bail petition of detained former communications minister barrister Nazmul Huda in connection with the case filed against him for extorting Tk 2 lakh in 2004.

First Class Magistrate Khadiza Nazneen passed the order after Huda's lawyers submitted a bail petition.

On March 6, Ayub Ali of Dohar filed the case with Dohar Police Station against five persons including Huda and his brother Kamrul Huda for extortion.

FALU'S BAIL REJECTED

Another Dhaka court yesterday rejected the bail petition of detained former BNP lawmaker and businessman Mosaddak Ali Falu in a criminal case filed in connection with misappropriating government relief materials.

Judge Mohammad Rafiqul Islam

of the District and Sessions Judge's Court passed the order following a criminal appeal filed against the rejection order of the lower court on February 27.

On February 9, the army-led joint forces had seized government relief materials from a factory in Savar owned by Falu.

Following the seizure, Ashulia police filed the case against Falu and several other unnamed officials and employees of the factory.

On February 12, Falu was shown arrested in the case.

Falu, also owner of private satellite television channels ntv and RTB and Bangla daily Amar Desh, is now in jail on a 30-day detention. He was charged with activities against the state, obstructing public safety, and illegally erecting hoardings.

South Asian University to be set up in India

Prof Asaduzzaman said that the South Asian University would be located at the best possible place of India where a congenial academic atmosphere will prevail. The admission and jobs will be on the basis of merit, he said.

Two UPDF men held for 'killing' of army captain

The joint forces arrested two listed criminals, who are also accused of Captain Gazi killing, with arms and ammunition from remote Maischhara area under the Sadar upazila of the district yesterday morning.

The arrestees, Bimal Bikash Chakma and Milon Bihari Chakma, were held with a foreign made revolver, 10 bullets, some one thousand Indian rupee leaflets and books for collecting subscription, police said, adding that they are members of United Peoples Democratic Front (UPDF) and confessed to extorting ransom in Chittagong Hill Tracts.

They are accused of killing army Captain Nurul Azam Gazi who fell victim to the gunfire between Parbatya Chattagram Jana Sanghati Samity and UPDF at Gilachari in Rangamati district on December 17, 2006, sources said.

Contacted over telephone, UPDF Central Committee Member Samari Chakma said the two arrestees, who belong to their organisation, are innocent but the army branded them as terrorists after handing over arms to them.

JMB member held with arms

Govt drafts policy on stocking essentials

An inter-ministerial meeting arranged by the commerce ministry yesterday drafted a proposal defining the amount and period for hoarding of nine essential items including paddy, rice, wheat, lentil, sugar, edible oil, onion, milk powder and baby food, sources said.

The following the meeting chaired by the additional secretary of commerce ministry, the draft proposals were sent to different business bodies for opinion by March 14, sources said.

Meanwhile, the central bank holds a meeting with the commercial banks today to discuss import situation of essential commodities.

The commerce ministry draft divided hoarding into three

levels -- import, wholesale and retail -- and proposed highest one month for storage of each item at every level. A trader will be allowed to store 5,000 tonne imported paddy and rice for highest one month, but the wholesale traders will be allowed to hoard highest 500 tonne paddy and rice and retailers 10 tonne same items for highest one month.

A trader will be authorised to hoard highest 6,000 tonne imported wheat while at other levels, the period and amount for hoarding will be the same as that of paddy and rice.

The draft says that traders will be authorised to store highest 1,000 tonne sugar and edible oil at import level while the amount will

be 100 tonne and five tonne at wholesale and retail levels.

In case of onion and lentil, the importers will be allowed to hoard highest 100 tonne which will be highest 30 tonne and five tonne for the wholesale traders and retailers.

The importers will be allowed to store highest 50 tonne milk powder and baby food, wholesale traders highest 20 tonne and retailers two tonne.

Yesterday's meeting reviewed the Special Powers Act 1974, East Bengal Food Stuffs, Price Control and Anti-hoarding Order 1953 and the Essential Commodities Control Order 1982 before defining hoarding in view of the 'present context'.

Bombers kill 29 in Iraq after talks

Shia ritual despite attacks by suspected Sunni Arab insurgents that have killed scores.

A suicide bomber blew himself up on a minibus, killing 10 people and wounding eight, in northeastern Baghdad near the Shia militia stronghold Sadr City police said.

A car bomber attacked a truck carrying Shia pilgrims in central Baghdad, killing 19 people and wounding 25, police said.

The pilgrims had been returning from the holy city of Kerbala, south of Baghdad, where millions gathered over the weekend for a major

opportunity for Washington and its adversaries Tehran and Damascus to sit together at the same table. Washington accuses Syria and Shia, non-Arab Iran of supporting militants in Iraq, a charge they deny.

UN watchdog chief leaves for N Korea to underpin atom pact

The UN nuclear watchdog chief left for North Korea yesterday to broker a return of inspectors to the secretive Stalinist state under a precarious six-party pact to dismantle its atomic bomb program.

International Atomic Energy Agency (IAEA) director Mohamed ElBaradei said he wanted to look at how to put the agreement into effect and bring North Korea back closer to the agency some four years after it expelled IAEA inspectors and quit the global nuclear Non-Proliferation Treaty.

"I'd like ... to discuss the broad framework of how to implement the new agreement which foresees that the agency will monitor and verify
