

Finance adviser asks bankers not to harass clients

Finance Adviser Dr Mirza Azizul Islam yesterday asked bankers not to harass their clients by taking advantage of the sense of uncertainty triggered by the ongoing anti-corruption drive.

There have been numerous reports that the bank officials are discouraging disbursements of credit, which must not be done, he warned the banks while addressing a launching ceremony of a project titled "Remittance and Payments Partnership (RPP)" at Hotel Sheraton.

The three-year long project will be implemented by Bangladesh Bank and the UK Department for International Development with a

BOU VC Bari removed for corruption

Bangladesh Open University (BOU) Vice Chancellor Dr Ershadul Bari was removed yesterday following a University Grants Commission (UGC) report against his irregularities and corruption.

Chief Adviser Fakhruddin Ahmed approved the removal order yesterday, sources said.

A probe committee led by UGC Member Prof Tareq Samsur Rehman held Dr Bari responsible for a series of irregularities and corruption and submitted the primary report to education ministry on Monday.

In the primary report, UGC recommended that the ministry

Detention of ex-minister Mosharraf declared illegal

The High Court (HC) yesterday issued a rule upon the government to explain in ten days why the detention of former health minister Khandaker Mosharraf Hossain should not be declared illegal.

After hearing on a habeas corpus petition filed by Mosharraf's son challenging the detention order, a division bench comprising Justice MA Wahhab Mian and Justice M Emdadul Huq passed the order.

The army-led joint forces arrested Mosharraf, also a BNP stalwart, at his residence in the

Qaeda man claims 9/11 responsibility

During the hearing, held to determine whether he meets the US definition of an enemy combatant, Mohammed also seemed to indicate he had been mistreated in US custody.

Mohammed is among 14 prisoners identified by US authorities as "high-value" terrorism suspects and transferred to Guantanamo last year from secret CIA prisons abroad.

US officials have said Mohammed, arrested in Pakistan in March 2003 and handed over to US custody, was the mastermind of the September 11, 2001, attacks that killed nearly 3,000 people, destroyed the World Trade Centre and damaged the Pentagon.

Mohammed spoke both on his own and through his representative, a member of the US military.

"I was the operational director for Sheikh Usama (Osama) Bin Laden for the organizing, planning, follow-

up and execution of the 9/11 operation," he said through his representative.

Mohammed's full statement claimed responsibility for 28 separate attacks or plots. It also said he shared responsibility for three other plots, including one to assassinate

Pope John Paul in the Philippines and another to kill Pakistani President Pervez Musharraf.

The transcript of the closed hearing had been edited by US officials, a practice the Pentagon said was necessary to remove sensitive security information.

Mohammed, in a long statement in broken English, appeared to express some regret at the deaths caused by the September 11 attacks but suggested they were justified as part of a war against the United States.

al-Qaeda suspect Khalid Sheikh Mohammed has claimed he organised the September 11 attacks on the United States and a string of others, according to the transcript of a military hearing at the US detention camp in Guantanamo Bay, Cuba, released on Wednesday.

"I was responsible for the 9/11 Operation, from A to Z,"

Mohammed, speaking through a personal representative, said according to the transcript of the hearing on Saturday at the US military's Guantanamo Bay prison camp in Cuba.

Mohammed, a Pakistani national, also said he was responsible for a 1993 attack on New York's World Trade Centre, a nightclub bombing in Bali, Indonesia, an attempt to down two American airplanes using shoe bombs and other attacks.

Mobile courts fine food shops, restaurants

Mobile courts in the capital yesterday fined a number of food manufacturers, a restaurant, a hospital and a kerosene seller for a range of irregularities.

A mobile court led by Metropolitan Magistrate Abdur Rauf Khan raided Yakub Foods and Agro Ltd in Shyampur area, issued arrest warrants against its two owners and fined three of its officials Tk 50,000 each for multiple counts of violations of Pure Food Ordinance.

The violations included operating without BSTI approval, manufacturing substandard juice and pickles, employing child workers, workers handling foods without gloves, chemical ingredients stored in unlabeled containers and for not having any chemist.

The same mobile court fined Hirajhil Hotel in Motijheel Tk 20,000 after it found unhygienic

2 Rab killing suspects killed in 'crossfire'

Two people who were suspected to have links with the killing of two Rapid Action Battalion (Rab) personnel at Amin Bazar on March 3 were killed in crossfire during a shootout between their accomplices and members of Rab in Savar early yesterday.

The dead were identified as Adnan, 23, son of Abdul Sobhan of Sherpur, and Baset, son of Hares Ali of Borodeshi in Savar. Police sources claimed both were members of "Gangchil Bahini", a notorious criminal group of Amin Bazar.

The two were caught in the crossfire at Modhumoti Model Town around 4:00am yesterday when Rab 11, after having had their confessional statements, raided the area along with them to recover illegal firearms. As Rab personnel went there, accomplices of Adnan and Baset opened fire on the elite force. Rab members retaliated and a firefights ensued, sources said.

Lankans cruise


