



EMERGENCY POWERS RULES AMENDED

Right to bail curbed until trial ends

Accused cannot also seek redress from higher court

The government yesterday promulgated an amendment to the rules under Emergency Powers Ordinance 2007, suspending the rights to appeal for bail and seek redress from any higher court until a case is resolved in trial court.

The amendment also gives sweeping powers to the Anti-Corruption Commission (ACC) to

investigate, arrest or seize property by itself without the permission of the government or the official appointed by it.

The government issued a gazette notification last night promulgating the amendment with a retrospective effect from February 13.

According to the amended law, an accused will not be able to file a bail petition during the investiga-

tion or trial of a case.

Additionally, an accused will not be able to seek redress from any higher courts against any order given by any court or tribunal before or during the trial-until the delivery of the final verdict.

A court or tribunal will have to dispose a case filed under the Emergency Powers Rules within 45 days, but the court or tribunal

Anti-graft body seeks to bolster its muscles
Wants to appoint high profile lawyers to fight cases

To kick-start its activities effectively, the Anti-Corruption Commission (ACC) has sought a number of facilities from the government and taken up a few measures on its own.

Sources said to come out of traditional practices the anti-graft body has decided to appoint a panel of high-profile lawyers to fight cases in trial courts on its behalf.

These lawyers will be paid professionally in sharp contrast to the existing ACC rate of maximum Tk

500 per hearing for public prosecutors and government pleaders. The ACC has already informed the finance ministry of its decision.

Meanwhile, the commission has made preparations to launch a massive countrywide campaign against corruption and, as part of this, sent a letter to the Cabinet Division yesterday, seeking permission to use a helicopter of Bangladesh Air Force.

Sources said the ACC will bear the fuel cost of the helicopter that the ACC chairman will take across

President's nod to form Supreme Judicial Council

President Iajuddin Ahmed yesterday gave consent to form Supreme Judicial Council (SJC) to conduct an inquiry into the case of High Court Judge Faisal Mahmud Faizee, highly placed sources said.

The approval came after Chief Justice Md Ruhul Amin sent a letter to the president on March 12 seeking his permission to form the SJC.

Chittagong University recently cancelled graduation certificates of judge Faizee and others after a probe committee found evidence of tampering with the tabulation sheets.

McKinnon for early lifting of emergency

Suggests reinstatement of right to political activities

Commonwealth Secretary General Don McKinnon yesterday said the state of emergency and the 'suppression' of political activities should be lifted without 'unnecessary delay'.

McKinnon also stressed the need for the government to provide a 'best estimate' timetable and a roadmap leading up to and inclusive of elections, if it is to sustain the popular support required to complete its task of 'redesigning and rebuilding' democratic institutions.

"Note the current state of emergency and the suppression of political activities. These should be lifted without unnecessary delay, and certainly should not be

Arrest warrant against Shibir leader Salehi

The Chief Metropolitan Magistrate's Court in Rajshahi yesterday issued arrest warrant against Mabubul Alam Salehi, president of RU unit Islami Chhatra Shibir, the main accused in Rajshahi University professor S Taher Ahmed murder case.

The High Court earlier granted bail for Salehi but it was cancelled as he violated the HC bail conditions of appearing before the lower court, said the lawyers concerned.

The bail granted on grounds of no charges against him also went useless on March 18 when charges of the murder were pressed against six people including him, sources said, adding that as he did not

Tigers in deep trouble

AFF, undated

Bangladesh lost half of their side for next to nothing as they were in pursuit of a massive 319-run target set by Sri Lanka in their Group B World Cup match at the Queen's Park Oval in Port of Spain yesterday.

The former world champions rode on Sanath Jayasuriya's devastating century as they piled 318 for 5 in their 50 overs after being put in by Tiger captain Habibul Bashar. In reply, Bangladesh lost five wickets for only 55 runs after 22 overs.

Opener Shahriar Nafees's hero World Cup continued when he left an incoming ball from left-arm seamer Chaminda Vaas in the first over, only to be out plumb in front.

His partner and hero of the last match Tamim Iqbal fell for only six, edging a Lasith Malinga delivery to keeper Kumar Sangakkara.

Atab Ahmed gave in to his temptations to a big shot as he holed out to Jayasuriya at square-leg. One-drop Mashfiqur Rahim soon followed, out caught at point of Farveez Maharoof. With the score on 41, Sakib Al Hasan fell to off-spinner Muttiah Muralidaran.

Mohammad Ashraful joined captain Bashar and with the innings in tatters, the two men at the crease should look to play face-saving knocks.

Earlier, left-handed Jayasuriya, who had left the field on 83 due to cramp, returned in the closing overs to score an 87-ball 109 for his

24th hundred in one-day internationals.

Jayasuriya struck seven sixes and as many fours in an engrossing display of aggressive batting, reaching his century with a six off left-arm spinner Abdur Razzaq.

The 37-year-old Jayasuriya had already put his team on course for a big total before he had retired hurt.

Sangakkara and Chamara Silva continued the good work to ensure Bangladesh chased a stiff target in their second Group-B match, which was interrupted for 30 minutes due to rain.

Sangakkara smashed 56 and Silva cracked a 48-ball 52 not out for their second successive half-centuries.

Businessmen against steps that may lead to harassment

They say panic situation to hamper economy, want review of proposed sweeping power to ACC

Leaders of the country's business community yesterday suggested the caretaker government not to take initiatives that might make way for harassment of business people.

"Bad elements might exist in all sectors including among the business people, government officials, and politicians. But they should be brought to justice under existing laws of the land so that the measures cannot give rise to panic among the business people,"

Mahbubur Rahman, president of the International Chamber of Commerce and Industry (ICCI) said after a meeting with Finance and Commerce Adviser Mirza Azizul Islam in his Planning Commission office.

Mahbubur said if panic grips hold of the business people it will hamper normal economic activities in the country.

"Nobody likes an emergency situation forever. The emergency situation should go after the government carries out necessary reforms," Annisul Huq, former president of Bangladesh Garment

CA urges all to help curb price hike

Chief Adviser (CA) Fakhruddin Ahmed yesterday urged all professionals, growers, suppliers, distributors and consumers, to play their wider role in controlling market price of the essential commodities.

"People's active support is indispensable to curb corruption and improve law and order situation in the country," the CA said at an opinion-exchange meeting with the elite and representatives of various professions of Rajshahi division at the local circuit house.

He said the present government is working with an ultimate aim to hold a "meaningful election so that people's representatives can take the responsibility of the government".

Mentioning various reform steps taken by his government, he said, "Measures are being taken to keep the election free from the

influence of black money."

He said judiciary is being separated from the executive with a view to bringing check and balance in democratic system.

The CA expressed the hope that Monga crisis would be resolved within next few years through a well-coordinated effort of the government and the private sector.

Citing financial constraints and limitations of institutional capacity of the government, the CA stressed prioritising works to be implemented for the development of the country.


Four textile firms fined for polluting river
