Technical Assistance Grant No. BD 0143

- The Government of Bangladesh has received a Technical Assistance Grant from the Islamic Development Bank and intends to apply part of the proceeds of this grant to conduct a technical and financial feasibility report for construction of Barisal-Bhola-Borhanuddin 132 kV transmission line through employing services of an experienced IDB member consultancy firm. Once the short-list is developed based on receipt and evaluation of expressions of interest from interested firms, the Request for Proposals (RfPs) will be issued to the short-listed consulting firms in May, 2007.
- The expected duration to conduct the proposed feasibility study is four months. The feasibility study will include identification of optimum transmission line route, suitable locations for river crossings, detailed engineering design, environmental aspects and considerations on unstable soil and possibility of crossing the river either by using towers with caisson foundation or submarine cables etc. The study will also consider construction of a new substation at Bhola and extension of an existing substation at Barisal. Detailed EIRR and FIRR for the project will also be computed.
- The Power Grid Company of Bangladesh (PGCB) now invites eligible consultants (companies) to indicate their interest in providing the services. The EOI shall be submitted in company's letterhead and must include information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc). Consultants may associate consultants/experts from other countries to enhance their qualifications.
- A consultant will be selected in accordance with the procedures set out in the Islamic Development Bank's Guidelines for the Use of Consultants under Islamic Development Bank Financing, approved in June 2005.
