

# 3,600 acres govt forestland recovered in Tangail

The Forest Department has recovered about 3,600 acres of grabbed forestlands in Madhupur and Dhanbari upazilas in Tangail district since it launched a drive on February 15.

The drive to recover forestlands was ordered by higher authorities, Tangail forest officials and local administration said yesterday.

The lands were recovered by destroying banana and pineapple plantations.

At least 20,000 acres of forestland out of 45,000 acres in Madhupur reserve forest remained grabbed for long. A large number of outsiders grabbed the forestlands and raised banana and pineapple orchards on those, they added.

Forest and Environment Adviser

of the Caretaker Government Dr Chowdhury Sazzadul Karim at a view exchange meeting at Madhupur on March 8 advised the district and upazila administrations and high officials of Forest Department to recover grabbed lands, recreate 'shal' and 'gajari' forests on those and monitor activities of sawmills near reserve forests.

Among others, Chief Forest Conservator Mohammad Osman Gani, Assistant Chief Forest Conservator Ali Kabir Haider and Divisional Forest Officer (DFO) in Tangail Abdullah-al-Mamun attended at the meeting.

The adviser also formed a 13-member committee headed by Madhupur Upazila Nirbahi Officer (UNO) Dr MA Parvez Rahim and ordered him to submit a report within 15 days.

Banana is grown on about 11,000 acres of hill lands in Madhupur and Dhanbari upazilas, which involve about 4,500 families, most of them outsiders, it was gathered from different sources.

They said about 200 commercial banana farmers in Madhupur and Dhanbari upazilas will lose about Tk 10 crore due to the drive as their plantations have been destroyed.

Recently, a team of farmers from the two upazilas met the local administrations and forest officials and requested them to delay the eviction till harvest. As per a decision at the meetings, the farmers agreed to destroy orchards after plucking fruits, sources said.

Most of the farmers cultivated banana by taking loan from banks and NGOs.

When contacted, Madhupur UNO Dr MA Parvez Rahim said the

drive to recover grabbed government land would continue.

"We advised banana farmers to destroy their orchards on grabbed forestlands after plucking fruits," the UNO said.

On the other hand, the authorities have already sealed over one hundred illegal sawmills adjacent to forests in Madhupur, Dhanbari, Ghatail, Mirzapur and Sakhipur upazilas in the district.

Divisional Forest Officer (DFO) Abdullah-al-Mamun said programmes will be taken up to recreate 'shal' and 'gajari' forests on the recovered forestlands.

There are about 1,22,876 acres of reserve forests in five upazilas of Tangail district—45,565 acres in Madhupur and Dhanbari upazilas, 47,220 in Sakhipur, 21,855 in Ghatail, 7,576 in Mirzapur and 659 acres in Kalihati upazila.

**Khulna police asked to review journo Harun murder case**

Earlier, the advisor inaugurated Nagar Bhaban, the newly constructed building of Khulna City Corporation and exchanged views with ward commissioners.

## Protest against admission of fake students at RU

Several hundred students of Social Work Department of Rajshahi University yesterday staged a demonstration on the campus protesting admission of eight fake students in the department.

The eight fake students were admitted to first year honours course in 2006-07 academic session though they did not qualify in test, the students alleged.

The students boycotted classes besieged the administrative building, where they were locked in an altercation with the Proctor and the Student Advisor. Police chased them away, campus sources said.

At a brief rally there the students alleged that a clerk in the department was behind admission of the fake students and demanded his punishment.

The claimed that the clerk realised Tk 1.69 lakh for admission of the fake students.

Chairman of the department Prof Fakhrul Islam later told newsmen that the clerk confessed the wrongdoing and that some students of the department were also involved in it.

The students boycotted classes besieged the administrative building, where they were locked in an altercation with the Proctor and the Student Advisor. Police chased them away, campus sources said.

Talking to newsmen yesterday department chairman Prof. Fakhrul

Islam said, on March 25, he received a telephone call that several fake students were admitted to the department in exchange of money.

"I investigated the matter and found the allegation correct. I also identified the clerk behind it."

The culprits did the mischief by replacing photos and certificates of genuine students who qualified in the admission test with those of fake students, Prof. Fakhrul Islam said.

Admission of the eight fake students will be cancelled and genuine students will be taken in, he said.

## PARIS EXHIBITION RU VC sued over sending rare Bengal treasures

The famous Guimet Museum in Paris is sponsoring a four-month exhibition styled 'Sonar Bangla' from Oct 24 this year to March 3 next year.

Some 120 objects selected from Bangladesh National Museum, Mahasthangarh, Paharpur and Mainamati Archeological Museums and BRM are scheduled to be displayed at the Guimet Museum.

## Arms smuggling, disputed lands feature Sylhet border meet

A BDR-BSF sector commander level meeting at Beanibazar has agreed to resolve some major

cross-border problems through talks and by taking 'steps in time'.

The meeting decided to maintain status quo on the 500 acres of cultivable land along Zakiganj border till it is settled by higher authorities. Bangladeshi farmers will continue to cultivate the lands now under their possession, BDR Sylhet Sector Commander Col Abul Hossain told the Daily Star yesterday.

Dispute over the lands led to gunfights between BDR and BSF on several occasions in past few months.

BDR rejected a BSF proposal for raising border fence within 150 yards of the no mans land, saying border rules do not allow this.

The meeting began at a community centre near Dubag border Beanibazar at 10 am Tuesday and lasted till 11:45 pm.

Sylhet Col. Abul Hossain led the Bangladesh side while the Indian side was led by a DIG of BSF. Three Battalion Commanders from India and two from Bangladesh also attended the meeting, held in a cordial atmosphere, Col. Hossain said.

Cross-border problems including illegal migration, border fencing by BSF, smuggling of explosives and firearms from India, killing of Bangladeshi by Indian border guards and armed civilians came up for discussion at the meeting.

Bangladesh officials denied the allegation of use of Bangladesh territory by Indian insurgents.

The Indian side agreed to take effective steps to stop smuggling of explosives and firearms to Bangladesh.

BDR officials informed BSF that explosives are smuggled into Bangladesh easily as those are used in large scale in Meghalaya hills for limestone extraction.

The agenda also included smuggling of contrabands including drugs into Bangladesh, erecting stolen border pillars and stopping killing of civilians.

Col. Hossain said BSF officials showed a positive attitude to resolve the cross-border problems.
