

Police reform
govt's priority,
says CA

UNB, Dhaka

Chief Adviser (CA) Fakhrudin Ahmed has said reform of the police force is essential and the government takes it as a priority task.

The CA made the remarks while addressing senior police officials at the International Conference Centre (ICC) yesterday morning on the occasion of Police Week-2007.

He said the radical reform of an organisation is possible only when the demand comes from its own workforce and hoped that the ongoing reform project of the police force, including its legal one, will achieve its objectives.

Appreciating various activities of police, he said their (police) activities during the last three months have proved that they are capable of reining on the bad people and helping the good ones.

Responding to various suggestions, including legal and institutional reforms, the CA said the government will be able to take

US offers further help to fight graft

The United States has offered further cooperation to the government in its drive against corruption, particularly in identifying concrete, short-term support for investigations and prosecution of corruption suspects.

The US has also committed to increase their aid to Bangladesh by 40 percent, with a significant amount earmarked for bilateral initiatives to combat corruption.

Economic Relations Division (ERD) Secretary Aminul Islam Bhuiyan said.

US Ambassador Patricia A Butenis extended this offer to Foreign Affairs Adviser Iftekhar Ahmed Chowdhury in a recent letter, where she also provided recommendations to prosecute corruption suspects in light of her country's own experience.

A government inter-ministerial

working group headed by the ERD secretary met yesterday to identify possible areas of bilateral cooperation between Bangladesh and the US in combating corruption and punishing the corrupt.

Representatives from the Anti-Corruption Commission, ministries of home, law and foreign affairs, Bangladesh Bank, and the National Board of Revenue participated in the meeting.

Waiting for son at jail gate

A 65-year-old rickshaw-puller had been waiting at the Dhaka Central Jail gate for 11 hours yesterday for the release of his son who had been arrested 15 days ago on charge of stealing.

"I have been waiting here for my son since 7:00am because my lawyer told me Tuesday evening that my son would be released today. I am very hungry as I could not eat anything," Shaheed Ali told The Daily Star at 6:00pm yesterday.

"But my hunger will end as soon as I meet my son."

Shaheed said he regularly came to the jail in the last 15 days, cancelling his professional work and had to wait for long to meet his son Mohammad Rafiq and provide him with food and other essentials.

Like Shaheed, several hundred people gathered in front of the Dhaka Central Jail gate yesterday waiting for the release of their relatives.

A total of 482 accused, including

Cases against 55 graft suspects on the cards NBR to sue them in special court

The National Board of Revenue (NBR) is preparing to file cases against the top 55 graft suspects for concealing information about their income, submitting fabricated tax statements and non-compliance with income tax rules.

The cases will be filed in a special court in phases under the Income Tax Ordinance, 1984, which will be first of its kind, sources said.

Talking to the reporters at his office yesterday, NBR Chairman

Badir Rahman said preliminary scrutiny has been completed. "Now we will formulate a model format for filing the cases and we will discuss with the law experts to create this format."

He, however, declined to disclose any specific date regarding the start of filing of the cases.

Once the format is approved by an NBR body in compliance with the section 169 of the Income Tax Ordinance, the board will start the
