British Airways refuses to fly Hasina to Dhaka

Dhaka court issues arrest warrant against her in Paltan killing case

The British Airways (BA) last night refused to fly former prime minister Sheikh Hasina from London to Bangladesh as a Dhaka court ordered her arrest in October 28 Paltan killing case.

A tearful Hasina left the airport at Bangladesh time 8:10pm after intense negotiations with the BA authorities, who told the Awami League (AL) chief that the government would not let the flight land in Dhaka if they carried her, Syed Nahas Pasha, editor of the largest circulated UK-based Bengali newsweekly Janamat, told The Daily Star over the phone.

Hasina, who had two British

MPs with her during the negotiations, was also asked by BA authorities to consider the 'safety and

Govt to back genuine politicians for reforms Says Mainul

Law, Justice and Information Adviser Mainul Hossain yesterday said political parties have not been banned in the country and the present government is tolerant towards the politicians who are working to bring reforms in party politics.

"We are happy that genuine politicians are coming up to bring change and reforms in politics," Mainul told reporters at his secretariat office yesterday.

Asked about the BNP secretary general's recent meeting with party leaders and Awami League leader Suranjan Sengupta's interview with a television channel at a time when politics is banned, he said, "They

Why govt not be asked to produce Khaleda in court

HC asks for explanation in five days after court told Khaleda not confined

The High Court (HC) yesterday issued a rule on the government to explain within five days why the court will not direct the government to produce former prime minister Khaleda Zia to her residence. He also said that there is no restriction on her movement and she had met with her eldest son Tarique Rahman on Saturday.

The rule came hard on the heels of the former premier's reported readiness to go into exile anytime under government pressure.

A High Court bench issued the directive that underlines growing concern over the condition of Khaleda who ruled the country for 10 years in two terms.

Additional Attorney General Salabuddin Ahmed who stood for the state informed the HC that the government did not issue any order for house arrest or confinement of Khaleda Zia to her residence. He also said that there is no restriction on her movement and she had met with her eldest son Tarique Rahman on Saturday.

"The law will take its own course if she [Khaleda] is forced out of the country," the court told the additional attorney general.

The HC bench however turned down an appeal seeking the court's injunction on forcing Khaleda out of the country and directive to allow her to move freely. The court

also rejected an appeal for producing the BNP chairperson before the court.

Khondker Babul Chowdhury, a



member of the BNP national executive committee, filed the appeal on April 19, urging the court to order the government not to send Khaleda abroad against her wish and challenging the reported confinement of Khaleda to her house.

Following the petition the court ordered the government to inform it about the present state of former prime minister and BNP Chairperson Khaleda Zia, including whether she is confined or not on April 22.

As the hearing resumed yesterday morning, Salabuddin had told the court that Khaleda had not been

departure had been delayed.

Till early Saturday, when she met her elder son Tarique Rahman either at Kashimpur Jail or in the cantonment situated in Dhaka or Savar, she had been trying to convince the government to let her elder son accompany her. The government however declined to entertain her request.

Family sources said BNP Chairperson Khaleda Zia has been ready to leave Bangladesh since Friday, stayed up all night on Saturday waiting to avail a flight, and went to sleep early morning yesterday, after the expected

Court to frame charges against Harris, Mamun tomorrow

A Dhaka court will frame charges against Harris Chowdhury, former political secretary to former prime minister and BNP Chairperson Khaleda Zia, in absentia tomorrow in connection with a graft case.

The defence lawyers of controversial businessman Giasuddin Al Mamun, close friend of BNP Joint Secretary General Tarique Rahman, yesterday submitted a discharge petition to the court and completed their submissions on it in connection with a graft case.

HC to consider bail petitions

UNB, Dhaka

The High Court yesterday ruled that it has the jurisdiction to dispose of petition seeking bail by any person facing a criminal case under the Emergency Power Rules 2007.

A division bench headed by Justice Nozrul Islam Chowdhury issued the ruling after inviting a legal debate on March 29 over revocation of the right to seek bail.

The amended Emergency Power Rules (EPR) revoked the right to bail of those being held up during the current countrywide

operation against crime and corruption.

Before giving its ruling it had sought opinions of senior lawyers on the issue, suspending the High Court orders on bail petitions moved on behalf of bigwigs, including politicians, detained on charges of corruption and serious crimes.

On the night of March 21, the government issued a gazette notification to this effect under the Emergency Powers Ordinance 2007 with retrospective effect since February 13.

More leaders gather under Bhuiyan umbrella

Many BNP leaders are trying to be united under the leadership of Secretary General Abdul Mannan Bhuiyan to face any probable conflict with the party following possible departure of Chairperson Khaleda Zia.

More leaders, including a few former ministers, met Bhuiyan at his Gulshan residence yesterday to express their solidarity with him as they think a group of party leaders are engaged in anti-party activities

to serve their own interest. Sources said some former ministers and senior leaders have already talked to many district level leaders and asked them not to be confused over the "so-called initiative" taken by the party chairperson to bring changes in the party leadership.

A vested group in the party is trying to serve their own interest and grab the leadership using the name of the party chairperson, a BNP leaders said.
