



Hasina moves to challenge homecoming bar in court

Lawyers ask govt to remove restriction on her

A representative of Sheikh Hasina yesterday moved to file a writ petition with the High Court (HC), challenging legality of the government press note that bars the Awami League (AL) president from returning home.

Meanwhile, 600 lawyers of the Supreme Court (SC) and 31 leading intellectuals in separate statements yesterday called for an immediate withdrawal of restric-

tions on Hasina's coming home.

The same day Sammilito Nari Samaj asked the government to ensure that the top leaders of the two major political parties are free to stay in the country.

WRIT PETITION

Hasina's Protocol Officer Manzila Faruque and her lawyers went to an HC bench for permission to file the petition. But the bench asked them to come tomorrow as that (Thursday) is the day for the court to receive fresh petitions.

"We went to file a petition but the court has advised us to come on Thursday," said Mahbubey Alam, one of the counsels.

The lawyers said they expect a hearing to take place on Sunday, given that the HC would receive the affidavit on the intended petition tomorrow.

Barrister Shafique Ahmed yesterday told The Daily Star that Manzila has been given the power of attorney to act on behalf of Hasina regarding legal matters.

Earlier, the government on April 18 issued the press note. It said if allowed to enter, she might attempt to preach hatred among the public and disrupt the law and order.

Besides challenging the legality of the press note, Manzila plans to seek a court directive asking the government to remove all barriers to the former prime minister's entry.

In her petition, Faruque argues that it is a constitutional right of a

The UK also stressed the importance of the Bangladesh government's commitment to proper process and human rights, he told reporters after a meeting with Chief Election Commissioner (CEC) ATM Shamsul Huda.

"I stressed that it was important that the government demonstrate commitment to due process and



Iftekhar leaves for Yangon today

Accord on direct road link likely

Bangladesh and Myanmar are likely to sign agreements on direct road link and avoidance of double taxation during Foreign Affairs Adviser Iftekhar Ahmed Chowdhury's four-day official visit to Yangon, beginning today.

In Yangon, the foreign adviser is expected to hold bilateral talks with Secretary-1 and Acting Prime Minister Lt General Thein Sein, Foreign Minister Nyan Win and other dignitaries, a foreign ministry press release said yesterday.

3 killed, 160 hurt as storm lashes 6 dists

Three people were killed, 160 others injured and over 1800 houses damaged as nor'wester lashed six districts—Kushthia, Meherpur, Chuadanga, Rangpur, Kurigram and Brahmanbaria—yesterday.

Our Kushthia correspondent reported that the storm started lashing the three districts in the evening and lasted for 19 minutes, killing three people and injuring over 100 in Gangni and Mujibnagar upazilas of Meherpur and in Daulatpur upazila of Kushthia.

The dead were identified as Nasrin, 13, of Baliahat village under Gangni upazila and Maria,

32, of Munakhali village under Mujibnagar upazila of Meherpur, and Azizul, 42, under Daulatpur upazila in Kushthia.

Of the injured, 30 were admitted to Kushthia General Hospital, while the rest given first aid.

Standing crops were damaged and a large number of trees uprooted by the storm in the three districts.

In Rangpur, the storm accompanied by heavy rain swept over Rangpur Sadar, Kounia and Gangachara upazilas at around 5:00 am, damaging at least 1500 houses and injuring 50 people.

Standing Irri-boro crops on about 1000 hectares of land were

Tharanga keeps SL up

Left-arm paceman James Franklin struck twice as Sri Lanka reached 111 for two after 25 overs in their World Cup semifinal against New Zealand at Sabina Park in Kingston, Jamaica on Tuesday.

But despite the early dismissal of dangerman Sanath Jayasuriya (1), other opener Upul Tharanga steadied the innings with a solid half-century.

The left-hander was batting on 72 with captain Mahela Jayawardene on nine.

Jayasuriya was the first man out for the 1996 champions when he was clean bowled hitting across the line off a Franklin delivery in the third over with the score on 13.

Wicketkeeper-batsman Kumar Sangakkara was caught by New Zealand captain Stephen Fleming at mid-on for 18 off Franklin in the 14th over with the score on 67.

Earlier, Sri Lanka won the toss and decided to bat.

New Zealand welcomed back

fast bowler Shane Bond and pace bowling all-rounder Jacob Oram who missed Friday's 215-run defeat by Australia. Off-spinner Jeevan Patel retained his place.

Sti Lanka's unorthodox fast bowler Lasith Malinga returned to the team after three games out with ankle ligament damage and Dilshan Fernando also returned after missing the team's last match, an eight-wicket thrashing of minnows Ireland, with an ankle problem.

Under-pressure opener Tharanga retained his place, seeing off the challenge of the experienced Marvan Atapattu.

When the teams met in a Super Eights match in Grenada on April 12, Sri Lanka won by six wickets.

The Kiwis got off to a great start on Tuesday thanks to Franklin. Jayasuriya tried to turn the lanky pacer on the on-side but missed the ball completely and his stumps were castled.






