The South Asia Enterprise Development Facility of the International Finance Corporation (IFC-SEDF) is a multi-donor funded facility to support the establishment and growth of private small and medium enterprises (SMEs) in Bangladesh, Bhutan, Nepal, Northeast India, Sri Lanka and Maldives. IFC-SEDF is managed by the International Finance Corporation, the private sector arm of the World Bank Group. IFC-SEDF started its operations in October 2002 and since then has completed numerous projects aimed at SME development.

IFC-SEDF is assisting an independent, non-profit, non-government, policy research and implementation organization to transform into a commercially viable consulting firm so that they can offer quality and sustainable services that address critical gaps in the local RMG sector especially in the area of Environment and Social Compliance. The first stage of this project involves assessing the organization's current capacity and designing an action plan to address organizational development, legal requirements and institutional capacity building that may be required.

Scope of Work: An indicative, but not exhaustive list of Scope of Work is as follows:

1. Assessment of institutional capacity, strategy, service/product portfolio, pricing and organizational set up of the concerned organization.
2. Assessment of the demand for the services/products to be offered by the research organization as a commercial service provider, market competitor and other market factors in the RMG and textiles sectors in Bangladesh, that may affect the success of the organization as a service provider.
3. Identify a path forward for the organization to transition to commercial service provider
4. Define milestones going forward

The Deliverables for this Project include a project proposal detailing:

1. An analysis of the organization's overall strengths, weaknesses and opportunities relating to institutional capacity, strategy, product/service portfolio, pricing and organizational set up.
2. Market assessment for services/products to be offered.
3. The organization's plan for commercialization of services including: strategy, new institutional structure, product/service development plans, roles and responsibility and sustainability.

Time schedule: 4 weeks, from 3rd June to 3rd July, 2007
