## Jalil, Babar, Hashem on remand in graft probe

Joint forces continue raids, pick up ex-AL minister Rafiqul, Barisal Mayor Majibor

Awami League (AL) General Secretary Abdul Jalil, former state minister for home Lutfuzzaman Babar and former BNP lawmaker and Partex Group Chairman MA Hashem were remanded in custody last night by a Dhaka court for interrogation about alleged corruption.

The three, who were among

those picked up in high profile raids Monday by joint forces, were remanded for four days at a crowded court that also sent former minister Altaf Hossain Chowdhury and former state minister Fazlur Rahman Patal to Dhaka Central Jail with recommendations for 30 days' detention.

The moves came hot on the heels of the rounding up of AL leader and former state minister

for energy Rafiqul Islam and BNP leader and Barisal City Corporation Mayor Majibor Rahman Sarwar early yesterday. Rafiqul was later sent to jail by another Dhaka court with the recommended detention of 30 days.

All of them were arrested under section 16(2) of the Emergency Power Rules.

On Monday morning, the army-led joint forces had also detained

former AL lawmaker Sheikh Fazlul Karim Selim, former FBCCI president Abdul Awal Mintoo, and Sylhet City Corporation Mayor Badaruddin Ahmed Kamran.

The whereabouts of them could not be known as of 7:00pm yesterday as they were neither produced before any court nor handed over to any police station.

The ACC asked them to come up with wealth statements within seven days of receipt.

## BABAR'S LITANY OF 'MISCHIEF' Master manipulator of state power

Arrested BNP leader Lutfuzzaman Babar virtually enjoyed the power of a full minister while serving as a state minister for home affairs, and played dubious roles in the investigations of major terrorist incidents, in instilling partisanship within the police department, and in bulk purchase of government motor

vehicles, according to reliable government sources.

As a close aide to BNP's detained Senior Joint Secretary General Tarique Rahman, who is also the elder son of former prime minister and BNP chief Khaleda Zia, Babar led law enforcers in resorting to extreme violence in order to suppress opposition

## Forest boss held with tucked away Tk 1cr

Chief Conservator of Forests (CCF) Osman Gani was arrested yesterday at his Uttara house with Tk 1 crore in cash that he had hidden at some unusual places in his house.

A joint team of Anti-Corruption Commission, army, Rab and police raided Osman's Bonobithi house at Sector 8 at around 11:00am and found the money, in several currencies, hidden inside a rice drum

in the kitchen and inside a pillow kept in the balcony, among other places. The joint team also recovered two passports of the Forest Department head during the nine-hour raid.

Syed Nazrul Islam, officer-in-charge (OC) of Uttara Police Station, told The Daily Star that the joint forces had the information that the CCF had a lot of money hidden at his house. They have

## Mamun alleges he was threatened with 'crossfire'

Says he was unofficially detained for weeks

Giasuddin Al Mamun, the detained businessman friend of Tarique Rahman, yesterday told the court that he could not submit his wealth statement in time since he was in the joint forces' custody from January 31 to March 26.

During hearing of the case against him for not declaring his assets to the Anti-Corruption Commission (ACC), he pleaded not guilty. The anti-graft body issued the notice for him to turn in the statement in person on February 18 within 72 hours of receipt.

He said while in captivity the

joint forces had taken him to a site and threatened to kill him and his staff in crossfire.

Mamun was taken to the fifth graft tribunal at the Sher-e-Bangla Nagar MP Hostel at around 11:00am yesterday. In the dock, he took some time from the judge and
