

Hasina vows to establish people's rights

Awami League (AL) President Sheikh Hasina yesterday said her main mission is to establish people's rights—fundamental, democratic and voting—so they can elect the government of their choice by exercising their franchise.

"People will elect the government of their choice by exercising their voting rights. If it is ensured, transparency and accountability of the government will be established," she said.

Hasina made the remarks to the reporters at Bangabandhu Memorial Museum at Dhammendi after placing wreaths at the portrait

Polls roadmap by mid-July

CEC tells EU Troika

Chief Election Commissioner (CEC) ATM Shamsul Huda yesterday said the Election Commission (EC) would be able to declare by mid-July a roadmap for the next general election.

The CEC told this during his meeting with the visiting five-member European Union (EU) Troika delegation led by Andreas

Michaelis, director general for Asian and Pacific Affairs of the German Foreign Office.

The delegation also comprising four others from Germany, the European Commission, European Council Secretariat and the Portugal embassy in New Delhi discussed how the EC's consultations with political parties could be started without infringing on the ban of indoor political activities.

"We have taken a pilot project to prepare a new voter list. The project will be complete by the end of June and we will be able to declare a roadmap of elections by the middle of July," the CEC told reporters after the meeting at the EC.

He said the Troika delegation enquired about the roadmap of the election, especially regarding the 18-month timeframe.

Tax incentives for mobile firms going public

Cellular phone operators would be offered tax incentives once their companies are enlisted on the stock exchanges.

"Mobile phone operator companies' corporate tax rate would be 45 percent, but the tax rate would be 35 percent if the companies are converted as publicly traded companies and listed with the stock exchanges," said Mirza Azizul Islam, finance and planning adviser, in his budget proposal for the fiscal year 2007-08.

The corporate tax rates will otherwise remain unchanged as prevailed in 2006-07 fiscal, the adviser added.

ICT sector gets 21pc higher allocation

Reconditioned car dealers' commission to be raised

UNB, Dhaka

Finance Adviser Mirza Azizul Islam in his budget speech yesterday proposed to increase the commission for the dealers of reconditioned cars.

"To facilitate the availability of vehicles to the middle class people, increase of the dealers' commission discount rate on used reconditioned cars is proposed to be raised from 25 percent to 30 percent," he said.

"The price of imported reconditioned cars will be reduced slightly and it will help the middle-class people to afford a car," said a car dealer.

He urged the government to consider their demand for allowing the import of six-year-old cars, as now they can import four-year-old ones.

VAT net widens

The proposed budget for 2007-08 has extended the VAT (value added tax) network bringing more goods and services within the net.

The new categories of goods and services which will come under VAT net include immigration advisers, soft drink, mineral water, toilet soap, restaurant, warehouse, port, land developers, building construction companies, telephone, teleprinters, telex, fax, internet service providers, SIM card distributors, cinemas, WASA, insurance companies, organisers of cultural programme participated by foreign artists, health clubs, fitness centres, sports organisations, engineering firms, chartered planes and helicopter rental companies.

The same truncated base value facility has been extended to photo lab, courier services and air-conditioned bus services.

Tk 550cr extra fund for jobs for rural poor

"Creation of increased employment opportunities is essential for social empowerment," Finance and Planning Adviser Mirza Azizul Islam said in his budget speech.



25pc budget fund set aside for HR development

The caretaker government has proposed a Tk 19,701-crore budgetary allocation for human resources development which, it believes, is the cornerstone of social infrastructure development.

Of the amount, which makes up 25 percent of the entire budget for

fiscal 2007-08, 15.2 percent is meant for education and 6.9 percent for health sectors.

An allocation of Tk 10 crore has been proposed to be earmarked for education research grants.

"Education and health are the main vehicles for human resource development. It is not possible to
