

## Landslide death toll rises to 106

Rescuers yesterday dragged 20 more bodies from the ruins left by Monday's devastating landslides in Chittagong, pushing the death toll to 106.

Earlier, the joint forces teamed up with the firefighters recovered 86 bodies till Tuesday night from different areas across the port city.

Of those recovered yesterday, 18 were from Lebu Bagan, and two from Kaichyaghona.

As of last night, 56 people were

## Hasina got Tk 1cr in MiG-29 deal

*Businessman Noor Ali claims he also gave 3 flats to Sheikh Helal*

Businessman Noor Ali is claimed to have admitted to the joint forces that he gave Tk 1 crore to Awami League (AL) chief and the then prime minister Sheikh Hasina, and three flats to her cousin Sheikh Helal out of the \$ 4 million commission he received from MiG-29 purchase for Bangladesh Air Force during the AL rule.

Besides, he gifted Hasina's son Sajeeb Wajed Joy half of a floor at

UTC building at Panthapath in the capital for his IT office, and it was registered in the name of AL leader Kazi Zafarullah, sources quoted him as saying during questioning by the joint forces.

Chairman of Unique Group Noor Ali, who was the local agent in the MiG-29 purchase deal, also said three other people got around \$ 12 million commission from the deal.

He contested the general election on AL ticket from Nababganj

## HILL CUTTING IN COX'S BAZAR Over 100 houses buried under mud

Large chunks of earth and mud, sliding of a soaked hill that had been cut earlier for a now abandoned government housing project, buried some 100 houses fully or partially at Kalatali in Cox's Bazar town in the last 48 hours.

Several hundred people of the area were forced to leave their houses following the mudslide triggered by the onrush of rainwater flowing down the hill, which had been continuing.

The district administration had recently levelled hills on 51 acres of

land by bulldozer for making houses for the officials of deputy commissioner's (DC) office ignoring the protest from the environmentalists. The government finally cancelled the project.

While visiting Saikatpara and Adarshagram, it was found that many houses were buried under mud completely, while some others partially. Those still living in the area have been making preparations to move out as their houses have become unfit for living.

"We tried a lot but could not resist the mud," Nomanul Haq

## Number of GPA-5 holders up by 7pc

The number of highest grade point average holders in Secondary School Certificate (SSC) public examination saw a moderate rise of 7.07 percent compared to the previous year.

A total of 32,646 examinees of SSC (including Dakhil and SSC Vocational) exams have scored GPA 5 this year, while the number was 30,490 last year.

As many as 9,439 students achieved GPA 5 in Dhaka Board this

## 57pc pass in SSC

Pass rate in this year's Secondary School Certificate (SSC) examination has declined to 57.37 percent from last year's 59.04 percent but more students secured GPA-5.

A total of 25,732 students under seven education boards received the highest score of GPA-5 (Grade Point Average) this year -- up from 24,384 students last year.

Average pass rate of SSC, SSC (Vocational) and Dakhil examinations under nine education boards including Madrasah Board and Technical Education Board also declined to 58.36 percent against 62.22 percent last year.

However, more examinees from the same boards, 32,646 in total, secured GPA 5 compared to 30,490 last year. Among them, 9,439 are

from Dhaka Board, 6,910 from Rajshahi Board, 2,387 from Comilla Board, 2,329 from Jessore Board,

## Babar talks about illegal VoIP network

Sons of Khaleda, Saifur, SQ Chy, Nasim were involved

Most of the ministers' sons used to run illegal Voice over Internet Protocol (VoIP) business and make a profit of up to Tk 5 crore a month during the BNP-led alliance rule.

Of them, former finance minister M Saifur Rahman's son Babu and daughter both were involved in the lucrative but unlicensed Internet telephony services that deprived the government of up to Tk 3,000 crore in revenue each month.

Lutfozzaman Babar, ex-state minister for home, has recently given away the information about the high-profile VoIP syndicate to the Task Force for Interrogation

(TFI).

The names he mentioned under interrogation include Tarique Rahman and Arafat Rahman, Giasuddin Al Mamun, owner of Daffodil Computers Sabur Khan and sons of Salauddin Quader Chowdhury and AL leader and former telecoms minister Mohammad Nasim.

Sources close to the interrogators quoting Babar also said that that former premier Khaleda Zia's nephew Shahrin Islam Tuhin would control the entire business through Sabur Khan.

The VoIP rackets used to operate

## Private credit dips

*BB asks banks to improve situation*

The Bangladesh Bank (BB) yesterday asked all commercial banks to increase credit flow as growth in private sector credit shrunk by 3.33 percentage points during the first four months of this calendar year.

According to the central bank, private sector credit growth was 2.75 percent during January-April period of this year compared to 6.08 percent during the same period of the previous year.

The law enforcers' recent drive in different financial institutions and bankers' carefulness in disbursing new loans are two main reasons behind this slow pace in credit flow, BB Governor Salehuddin Ahmed told reporters yesterday after a meeting with the chief executives of all the private commercial banks.

In the meeting, the governor discussed ways to achieve the goals announced in the proposed budget with the chief executives.

The top bank officials told the governor that they often face embarrassing situation, as the law enforcers demand various information from the banks frequently without showing any valid document.

They alleged that though the government asked the law enforcers not to harass the bankers, they (law enforcers) are visiting different banks often in the name of enquiry.

The bankers viewed that the law enforcers should come through proper channels like the central
