

Charges framed against Naser in extortion case

Charges have been framed against former BNP lawmaker Naser Rahman and five others in a Tk 2-crore extortion case.

Additional District and Sessions Judge (No.3) Binoy Kumar indicted the six on the extortion charges.

The other accused are Moulvibazar Municipal Chairman Faizul Karim Moyun, Moulvibazar BNP Joint Secretary Wali Siddique, former R&H executive engineer of Moulvibazar Abdul Khaque, superintending engineer Monwar Sadik and executive engineer of Sylhet Shariful Islam.

Another accused, Sylhet City BNP President Ariful Haque Chowdhury, was not indicted on the extortion charge, as there is a stay order of the High Court.

## ADP implementation lowest in 13 years

Only 83 percent of last fiscal year's revised Annual Development Plan (ADP) was implemented, which is the lowest rate in the last 13 years, according to planning ministry figures.

Expressing his displeasure at the low implementation rate, Chief Adviser Dr Fakhruddin Ahmed yesterday told his cabinet that the current fiscal year's Tk 26,500 crore ADP will not be revised and asked all ministries and divisions to gear up for its full implementation.

Planning ministry sources told The Daily Star that last year's politi-

cal turmoil largely contributed to the low implementation rate.

The planning ministry presented a report on last year's ADP at a meeting presided over by the chief adviser yesterday, which showed only Tk 17,851 crore of the revised Tk 21,600 crore ADP was spent.

Of the local resource components, only Tk 11,629 crore out of total Tk 13,650 crore was used while Tk 6,222 crore of the total Tk 7,950 crore foreign-funded projects utilised.

The worst performing government organization was the Election Commission, which failed to spend even a single taka from the alloca-

tion. The planning ministry used only 15 percent of its budget.

The civil aviation and tourism ministry managed to spend 23 percent while the health ministry used 74 percent of their funds.

Labour and employment ministry implemented 60 percent of its ADP outlay, just below the law ministry's 65 percent.

The local government and rural development and cooperatives ministry was the best performer with 96 percent of its ADP funds utilised while the power and energy ministry used 89 percent and the forest and environment ministry 94 percent of their outlays.

It was drizzling. The day darkening with heavy overhanging clouds. Thousands of hungry faces at the western embankment of the Jamuna at Khokhabari in Sirajganj were staring into the horizon hoping for a boat to arrive with relief goods.

The flood-devastated people who had taken shelter at the embankment were disappointed yesterday as an engine-boat with only a few journalists and no "relief" turned up.

As The Daily Star correspondent was taking photos, he was startled by a grumbling yet desperate voice. "What will photos do? Don't take photos... it won't solve our problems... it won't feed my child," a woman with a nine-month-old child wrapped in a black polythene said.

"Stop taking photos and give me some milk for my child if you can,"

## GRAFT CASE

### BTTB CBA don Firoz Mia jailed for 13yrs

A Special Court yesterday sentenced Firoz Mia, a CBA (collective bargaining agent) leader of BTTB, to 13 years imprisonment in a corruption case.

Firoz was sentenced to 10 years rigorous imprisonment for amassing wealth illegally and to three years simple imprisonment for concealing information in his wealth statement submitted to the Anti-Corruption Commission (ACC).

"Both the sentences will run

consecutively," says the court.

The court also fined Firoz Tk 10 lakh, in default he is to suffer another year in jail.

However, the CBA leader's wife Rawshan Ara was acquitted of the charge, as she was not found guilty of abetting her husband in acquiring wealth through dishonest means.

The court also directed the government to confiscate Firoz's illegal wealth worth over Tk 1.35

### 62 Iraqis killed in blasts, US raids

Bombs, US raids and mortar attacks killed 62 people in Iraq yesterday, including 30 civilians who were wiped out when a suicide bomber blew up a truck packed with explosives in a northern Shia village.

The bomber detonated his deadly charge in Al-Quba, killing at least 30 people and wounding another 50, eight of them seriously, said provincial police spokesman Brigadier General Abdulkarim Khalafal-Juburi.

The reported death toll climbed rapidly through the morning with

farming village 20km north of the much larger town of Tal Afar and the nearest emergency services.

Such attacks are increasingly common in villages, as militants flee to rural backwaters away from thousands of US and Iraqi security forces cracking down on Baghdad and other flashpoint cities under a five-month-old security plan.

Attacks elsewhere killed another 15 people in Iraq, including nine wiped out when a roadside bomb ripped through an unofficial

### More than 11,000 attacked

Public and private hospitals in the capital are struggling to cope with the steep rise in number of patients suffering from diarrhoea and other water-borne diseases in last few days.

City's hospitals witnessed a sharp increase in number of diarrhoea patients yesterday. The doctors feared that the situation may worsen in coming days.

The Health Directorate said that about 11,331 people fell victim to diarrhoea across the country since

## Benazir open to power sharing after polls

Former two-time Pakistan prime minister Benazir Bhutto said Sunday she was open to a power-sharing arrangement with embattled President Pervez Musharraf, but only if Musharraf gives up his concurrent role as head of the military.

Benazir told CNN that her long-time rival would have to ensure a balance of power between the parliament and the presidency if she were to resume the premiership after elections expected early next year with Musharraf still president.
