

TB kills one in every 10 minutes

One person dies from Tuberculosis (TB) in every ten minutes and another is attacked in two minutes in the country.

In the world, Bangladesh is 6th among 22 countries most vulnerable to TB. These were revealed yesterday at a discussion meeting on creating awareness against TB. National Anti-Tuberculosis Association of Bangladesh (NATAB) organized the discussion, held at Kishoreganj Press Club.

The speakers said creating awareness is more essential than treatment of TB as 70,000 people die from the disease and another 2, 62,000 are attacked annually in Bangladesh.

They said TB is spreading fast in Bangladesh as most TB patients do not complete full dose of medicine or take it irregularly.

Recently, NATAB with the help of several NGOs, has introduced Directly Observed Method (DOT) to combat TB.

In this arrangement, patients have simply to go to nearby health centers, Imam of a mosque or health workers for TB medicine provided by NATAB.

A patient can not be irregular in taking the medicine as NATAB members monitor the process, the speakers said.

President of Kishoreganj NATAB unit Kazi Shahin Khan presided over the meeting addressed by, among others Kishoreganj Press Club president Ruhul Kuddus Salim, NATAB Kishoreganj unit secretary Enamul Hoq.

Inhaler crisis in northern dists

Acute crisis of life saving inhalers for the asthma patients prevailing in the markets of northern districts. Though some inhalers are found but those are selling at higher price.

Market price of inhaler of Gloxo Smith Kline is Tk 140. But it is almost out of market and who had stocks are selling at Tk 180 to 200. Inhalers of other companies also being sold at higher price.

Local pharmacy owners when asked about the higher price and unavailability of inhalers said that the companies have decreased supply.

However a number of local medical representatives informed that the pharmaceutical companies are modifying their plans to produce inhalers using hydro flora alken (HFA) instead of using chloro flora carbon (CFC), which is harmful to environment.

Winter, the awful period for the asthma patients, is knocking at the door. In this season crisis of inhalers is a matter of great concern, commented physicians and asthma patients.

IU offices reopen

The Islamic University (IU) offices reopened yesterday after eight days of unscheduled closure.

The offices reopened following a decision taken by the university Syndicate, the highest decision making body, on Friday.

IU vice-chancellor (VC) Prof Fayaz Mohammad Serajul Haque presided the meeting. The university was closed on August 22 following deterioration of the Dhaka University (DU) situation.

However, no decision was taken about holding of classes and examinations as yet. The VC said a decision would be taken to this effect shortly.

Trial of 9 Allar Dal militants resumes in Kushtia today

Arrested son of district Jamaat Amir was second-in-command of the militant outfit, police say

Hearing of the case against nine arrested activists of Islamist militant outfit Allahr Dal will resume today in the court of Kushtia Speedy Trial Tribunal Judge Jalal Saifur Rahman.

The case was filed under Section 6 (2) of the Emergency Powers Act.

Charge of the case was framed on August 20.

One of the arrested militants--Tasnim-ul-Alamis son of Kushtia Jamaat-e-Islami Amir Abdul Wahed. Tasnim was second-in-command of Allar Dal in the district, police said.

He was a second year student of Management Department at Kushtia Government College. The eight others are Nazmul

Hasan, Tipu Sultan, Zahir Uddin, Md. Rakib Mondol, Safikul Islam, Lokman Hossain, Bappi Shahriar of Manikganj and Murad Sharif of Faridpur.

Rapid Action Battalion (Rab) in a nightlong drive arrested the nine militants from different areas of Kushtia district on June 5.

The drive followed intelligence report that Allar Dal activists were regrouping in the district.

A team of Rab-12 led by Maj. Hasibul Alam first arrested Rawnak Hossain. Haling from Raghunathpur village in Pangsha upazila in Rajbari district, Rawnak had arrived Kushtia days back and was regrouping militants. Acting on his confession, law enforcers raided different areas of the town and

arrested eight others. Rab also seized some leaflets and books on Jihad from their possession.

Later, Rab in a press briefing at its office said that the arrested persons admitted that they were members of Allar Dal, which has 56 members in Kushtia town.

It was founded by Matin Mehedi, now detained.

When contacted, Jamaat Amir Abdul Wahed told this correspondent that his son is involved with Chhatra Shibir, not with any Islamist militant organisation. Sources in different law enforcing agencies told this correspondent that a good number of activists of Islami Chhatra Shibir (student front of Jamaat) are also involved with different militant outfits including Jamaatul Mujahedein, Bangladesh (JMB).

Flood damages 710 educational insttts in Sirajganj

At least 710 educational institutions including college, high school, madrasa and primary school have been partially or fully damaged by flood in nine upazilas.

Of them, 62 were damaged fully and the rest partially, relevant sources said.

District relief office including primary and secondary education office sources said most of the educational institutions are situated on the bank of the Jamuna or in shoal areas.

River erosion and flood have caused an extensive damage to the institutions hampering educational activities to a great extent.

About 30 percent school, college and madrasas are now still under

water and the authorities concerned are facing shortage of fund, said an education officer seeking anonymity. Most of the rooms and furniture of the institutions were damaged. In many cases, necessary documents were also washed away by floodwaters.

During a visit to the flood affected areas, this correspondent saw that many schools, colleges and madrasas have no trace of foundation at all.

Mostafizur Rahman, headmaster of Shaluvita Junior High School in Sadar upazila said the school was established on one bigha of land with six tin shed rooms five years ago. Floodwaters have completely washed away the sheds. At present, the schools are running shortage of

fund. Shukur Ali, headmaster of Bhatpiani High School said the school was completely damaged by flood bringing educational activities to a standstill one and a half months ago. The school authorities are now looking for a safer place to rebuild the school. But, they need lots of money for the purpose.

Earlier, the Jamuna devoured the school four times and each time it was shifted to distant places.

Md Mohabbat Ali, education officer said, it will not be possible to resume academic activities in the damaged institutions until and unless the government comes forward with adequate fund to rebuild those.

Low guava price costs farmer's life

A guava farmer allegedly committed suicide by hanging himself from a guava tree in his orchard as he failed to pay the lease money to the landowner due to sharp fall in price of the fruit.

The incident took place Friday afternoon at Brammonkati village in Jhalakati district, famous for guava cultivation.

Khirod Chandra, 60, of Madras village leased a guava garden at Tk 1.40 lakh for the current season from Milon Bepari of Brammonkati. He paid Tk 50,000 as advance.

But as harvest began, price of guava fell to Tk 2-5 per kilogram at local wholesale market. His production cost including the lease money was Tk 8-10 per kilogram.

One Friday afternoon garden owner Milon Bepari and his men caught and allegedly assaulted Khirod. They asked him to go to police station with them.

Khirod begged time to change his dress. He went to the guava garden and hanged himself from a tree.

Seeing the unusual delay, Milon and his men thought that Khirod might have fled away. They went to the garden and saw Khirod's body hanging from a guava tree.

Police recovered the body and sent it to Jhalakati Sadar Hospital for autopsy. Police said an unnatural death case has been filed.

BSF abducts one in Kushtia

Indian Border Security Force (BSF) abducted a Bangladeshi farmer from Thakurpur border of Damurhuda upazila in Chuadanga on Thursday.

Emdadul Haq, 28, son of Abdul Mannan of the village was picked up by a BSF team at Shikarpur camp in West Bengal, BDR sources said. At that time, he was cutting grass near main pillar no-89.

BDR sent a protest note but did not gate any response from BSF till yesterday evening.

EXTORTION CASE Police say ex-BNP MP Shaheen not involved

Iswarganj police have submitted investigation report on the extortion case against former lawmaker and Iswarganj upazila BNP president Shah Nurul Kabir Shaheen.

Md. Abdul Halim, former headmaster of Uchakhila Higher Secondary School in Iswarganj filed the case with a magistrate court.

Seven others were also sued in the case filed on June 18. They are Md. Mohar Ali, Shamsul Haque, Kazi Morsheduzzaman, Md. Aminul Haque, Md. Emdadul Haque, Md. Abdus Salam and Tobarak Hossain Manik.

When contacted, officer-in-charge of Iswarganj police station Abdul Gani and investigation officer of the case told the Daily Star that he found no evidence of Shaheen's involvement in extortion as alleged by Hamil.

In his complaint, Abdul Halim said he joined Uchakhila High School as headmaster on March 11, 2002 and under his leadership the school made good results in SSC examinations.

Abdul Halim alleged that in 2004, the then lawmaker Shaheen was annoyed with him as his men were not included in the school managing committee.

The plaintiff also said that on October 21, 2005, the managing committee decided to upgrade the school to a college and introduce HSC section. He was made principal of the institution, Halim said in the complaint.

Workshop on violence against woman held in Gaibandha
