

Ratify ILO Convention 138 to end child labour

Experts urge govt

Experts at a workshop yesterday urged the government to ratify the ILO Convention 138 on minimum age for employment and formulate a policy in line with the recommendation in this regard to put an end to child labour in the country.

They also underscored the need to change the mindset of people to achieve the goal of eradicating child labour.

Bangladesh Shishu Adhikar Forum (BSAF) in association with Terre des Hommes-Netherlands organised the workshop on 'ILO Convention 138 and Recommendation 146' in the city.

International Labour Organisation (ILO) Bangladesh Programme Officer TIM Nurunnabi Khan highlighted the related provisions of the Convention in his keynote paper at the workshop.

Bangladesh, as a member state of ILO, has agreed to abide by the ILO fundamental principles and rights at work, which includes the elimination of child labour, but it is yet to ratify the ILO Convention 138, he said.

"The government, however, has ratified the ILO Convention No. 182 on the worst forms of child labour (WFCL) and thus committed itself to elimination of WFCL as a matter of priority and in a time-bound manner," he added.

Referring to the Labour Code 2006, he said Section 3 of the code seeks to prohibit or restrict the child and adolescent employment.

Despite the government's good intentions to eliminate child labour, strengthening monitoring and inspection mechanism remains a major challenge in this regard, he added.

BSAF Chairperson Wahida Banu, who presided over the

workshop, emphasised the need for education of children.

She also suggested formulating a necessary policy as an effective instrument to fight child labour.

She also called for advocacy at door-to-door level to change the mindset of people in order to stop child labour.

Addressing as the chief guest, Labour and Employment Joint Secretary Ashfaque Hamid said children must be removed from hazardous labour.

Speaking as special guest, Labour and Employment Joint Secretary Azizur Rahman said poverty and socio-cultural reasons are major obstacles to fighting child labour.

He emphasised the need to raise mass awareness and enforce laws to this end.

He also mentioned that necessary action plan has been initiated to eliminate WFCL by 2015.

Barge, 2 companies fined in Ctg

A mobile court in separate drives at Karnaphuli estuary yesterday fined a barge and two companies Tk 4 lakh for overloading and risky movement.

The court led by Chittagong Port Authority (CPA) Magistrate Mohammad Munir Chowdhury fined a barge -Sun Light Tk 2 lakh while it

was heading for Shikalbaha canal after loading 1700 tones of steel coil imported for SAlam Steels.

It also seized two tugboats - Tug SS-1 and Tug Syka that were involved in pulling the barge.

The court fined two companies M/s Three Light Navigation Company and Penta Marine Company Tk 2 lakh for overloading and posing threat to accident at the

port channel.

Meanwhile, another mobile court led by Chittagong City Corporation (CCC) Magistrate Syeda Sarwar Jahan in a drive at the city's Golum Rasul Market fined three traders Kabir Hossain, Md Hossain and Liton Tk 10000 each for illegally selling polythene products.

Govt urged to review Kalyanpur Pond Project

Landowners of Ramchandrapur, Boro Sayek and Adabor moujas in the city's Mohammadpur area yesterday urged the government to review the proposed Kalyanpur Regulating Pond Project to be implemented in the area to resolve waterlogging problem.

They said Water Supply and Sewerage Authority (Wasa) would acquire about 112 acres of land in the area for the proposed Kalyanpur Regulating Pond Project, which would affect over 500 families.

They also demanded that the government pay them according to the current market price of the lands and rehabilitate them before acquiring the lands.

They also called for involving local landowners in the planning for the project.

The demands were placed at a press conference at the Jatiya Press Club in the city, organised by the Committee for Rehabilitation of Landowners Affected by Kalyanpur Regulating Pond Project.

Alhaj Md Shariful Islam, general secretary of the committee, read out a written statement at the press conference.

Committee President Akter Biswas, Mizanur Rahman, Maulana Khalilur Rahman, Babul Ahmed, Ariful Islam and Mohammad Islam were also present.
