

# Tipaimukh dam to destroy ecology in Meghna basin

## Speakers say at Bapa roundtable in Sylhet

India, being an upper riparian country, cannot unilaterally withdraw water from the common rivers and any such move should be effectively dealt with at home and abroad, speakers said at a roundtable in Sylhet city yesterday.

Implementation of a gigantic project like Tipaimukh dam that will cause withdrawal of huge water in the Barak river near the common borders of north-eastern Indian states of Manipur, Mizoram and Assam, the entire Meghna basin in the downstream will face desertification, they said.

Bangladesh Paribesh Andolan (Bapa) with the assistance of Sylhet

Paribesh Andolan (Syapa) organised the roundtable on 'Rivers in Sylhet and Tipaimukh bundh' at a city hotel.

The speakers called upon all concerned to resist at any cost the implementation of the dam that would mean another Farakka, seriously affecting livelihood in the north-eastern regions in Bangladesh.

They said the Indian government is going ahead with the implementation of the project ignoring protests even in Manipur state where devastating effect of the project is feared.

"We are heading towards a war on water in near future. Major portion of our water comes from

outside the country. Water from rivers in India, Nepal, Bhutan, and Tibet flow through Bangladesh," Bapa founder chief AMA Muhit said as chief guest.

"Over the issue, we have to coordinate with people on movement in Manipur. Issues like flood control, forestry, preparedness for disaster etc can be discussed on joint forums with the neighbouring countries like India, Nepal and Bhutan."

Decisions taken through working jointly would be more effective, he said.

Forty-two rivers on the Meghna basin including 21 in greater Sylhet region have already lost 80 per cent of their navigability while the region's fishery, bio-diversity and agriculture are at a stake due to the critical situation, the speakers said at the roundtable.

Bapa Secretary General Dr Md Abdul Matin, also Coordinator of the National Rivers Saving Movement, read out the keynote paper at the roundtable chaired by Vice Chancellor of Sylhet International University Prof Sadruddin Ahmed Chowdhury.

Prof Abdul Awal Biswas and Dr Akhtarul Islam Chowdhury of Shahjalal University of Science and

Technology, AFM Fokhrul Islam, executive engineer of Water Development Board, Abdul Karim Kim, secretary of Sylhet Paribesh Andolan, Dr Zillul Haque, secretary of Moulvibazar Paribesh Andolan, Engineer Padmasen Sinha, chief of Manipuri Kalyan Samity, advocate Bedananda Bhattacharya, advocate Zakir Ahmed and journalist Al-Azad also spoke on the occasion.

Located at Tipaimukh in Churachand district of Manipur, the project area is close to the borders of Assam and Mizoram states and about 100 km off the Bangladesh border. Work on the four-year project is scheduled to start from 2008 at a cost of 6,000 crore rupees.

The project poses threat of ecology disaster and eviction of a large number of people, especially aborigines in the surrounding areas. Amid strong protests from environmentalist groups in the north-eastern Indian states of Manipur, Assam and Mizoram, the authorities laid the foundation of the mega project last year.

The Indian authorities initiated the barrage project for a 1500 MW electricity plant a decade ago, but could not go ahead with its implementation in the face of protests.

### Discussion, fair held in Kushtia

A daylong Harijan Children Rights Fair and a discussion meeting were held in Kushtia yesterday.

FAIR, a local NGO, working for rights of Harijan people, organised the programmes with assistance from Dhaka based NGO Manusher Jonnyo.

The programme was held at Bijoy Ullash ground of Kushtia municipality, president of Harijan Children Right Forum Aduri Rani, an 8-year old Harijan girl.

Prof Dr. Mohammad Zafar Iqbal of Shajalal Science and Technology University, Sylhet, was present as chief discussant.

Dr. Meghna Guho Thakurta, Executive Director of Research Initiative in Bangladesh (RIB) and Dr Rashid Askari, columnist and professor at Islamic University and Kushtia municipality chairman

Anwar Ali took part in discussion.

A large number of Harijan children along with their parents from different areas of Kushtia attended the fair.

According to NGO sources, at least 10,000 Harijan people live in the district but they are deprived of social rights.

Harijan children are not allowed in all educational institutions.

The discussants urged the government to take initiatives to

allow Harijan children in all schools and to ensure the people all social rights.

The discussants included former government official and team leader of Harijan Advocacy Group Nazrul Islam, FAIR chairman Tofazzel Hossain and its director Dewan Aktharuzzaman also addressed.

Several local NGOs also set up stalls in the fair to create awareness about rights of Harijan children.

## Contractor sent to jail for 'cheating'

Syed Muhammad Yunus, a millionaire contractor arrested in some cheating cases, was sent to jail yesterday.

Yunus was wanted for long, police said.

Rapid Action Battalion (Rab) arrested him from a flat in Purana Palatan in Dhaka on October 25 and handed him over to Barisal RAB-8 on Friday. He was handed over to Barisal Kotwali police on the same day after primary interrogation.

Police produced him before Sadar upazila magistrate court yesterday in an cheating case lodged by Jahangir Hossain, owner of a press.

Sub-inspector Shahabuddin, investigation officer (IO) of the case, sought 10 days' remand. Hearing on remand will be held today.

In his complaint lodged last month, Jahangir alleged that Yunus did not pay Tk 4 lakh printing bills of a hospital owned by him.

IO Shahabuddin said Yunus and his wife, a BNP leader, also face a case for taking Tk 27 crore loan against a fixed deposit of Tk 3 crore by using political influence.

He was granted bails in the case by higher court.

The anti-corruption task force is investigating all the cases, the IO said. Yunus also faces charges for swindling money from government departments, the IO said.

He was arrested earlier in mid-September in Dhaka but was released.

## Overcoming monga

### Lac farming under RIB makes 800 families solvent in Nilphamari

Several hundred enthusiastic people, both male and female, assembled at Horimondir Para village of Laxmichhap union in Sadar upazila yesterday to share their experience of overcoming poverty.

They had done 'mass research' (or group discussion) to combat monga and found initiatives like lac cultivation to be effective, they said at a meeting on the premises of the Hori temple.

Research Initiatives Bangladesh (RIB) supported by local organisations 'Loksamaj Gabeshana Foundation' and 'Grameen Atwa Unnayan Sangstha' arranged the meeting. A three-day fair was also opened on the occasion.

There were 14 stalls including lac processing factory, Kazoli Model School, Kazoli Education Centre, BRI-33 paddy cultivation stall, drum seeder process at the fair.

Lac, a natural resin produced by insect Laccifer Lacca, a parasite of a particular host tree, is widely used in industry like food processing, leather, textile, pharmaceuticals and perfume.

The concept of 'mass research' bears significance as finding out the ways for better living through group discussion contributes to the development of the country as a whole. Nilphamari Deputy Commissioner of Khandokar Moklesur Rahman said in his speech as the chief guest.

Mass research, which sharpens our brain by removing the rust from it, is a new way to alleviate poverty, said Anisur Rahman, professor of economics of Dhaka University.

"Lac farming had been proved to be effective to combat monga. The less advantaged people should detect their own problems and take initiative for

its solution. Mass research helps to grow such attitude," RIB Chairman Dr Shamsul Bari said.

Lac cultivation has helped over 800 families in the district to get rid of monga, lac cultivation researcher Motiur Rahman said at the meeting presided over by local union parishad Chairman Shyam Charan Roy.
