

Delwar talks of death threat to call it quits

Party cannot be crippled for a person: Saifur

BNP chief Khaleda Zia-appointed secretary general of the party, Khandaker Delwar Hossain, yesterday alleged that his and his family members' lives were threatened by a 'certain quarter'.

He claimed that the threat was for forcing him to resign from his current party post and to exclude the detained party chairperson from the leadership.

Meanwhile, Maj (ret'd) Hafiz Uddin Ahmed, who had been appointed as the new secretary general of the party by a national standing committee (NSC) meeting on Monday night, categorically said at a news briefing in former finance minister Saifur Rahman's house yesterday that those who do not accept the decision made by the highest policy making forum of the organisation also do not have the right to claim themselves as the bearers of BNP politics.

With the rivaling speeches, BNP is now formally divided in two factions, although both the factions seem to believe that the cloud of chaos will be cleared soon as they hope Khaleda Zia will send her message regarding the matter

through her lawyer, who is scheduled to meet her today.

"They came into my house on Sunday night and told me that I would have to agree to resign from my post, accept the new chairperson and secretary general of their choice, and would have to join Monday's standing committee meeting, or else the lives of my family members and my own

would be in danger," Delwar Hossain told journalists from a hospital bed in Birdem about the threat, while terming the NSC meeting held in Saifur's house as illegal and unethical by the standard of the party constitution.

Claiming himself as the legitimate secretary general of the party he said the party is united under

No place for acting chairman, secy gen in BNP constitution

Only the chief is authorised to convene a meeting of the party standing committee and he or she will preside over it as the committee chief.

Nine militants handed over to PS after probe

The nine people arrested for their direct and indirect involvement with the August 21 grenade blasts at an Awami League (AL) rally in 2004 were handed over to the police stations concerned yesterday after primary interrogation.

Rapid Action Battalion (Rab) recently arrested the nine with suspected links to Harkat ul-Jihad-i-Islami (Huji) and seized 16 Arges-84 grenades, four firearms and 60 kilograms of explosives and other

Yaba raid yields cache of Tk 50 crore wealth

The Rapid Action Battalion (Rab) yesterday seized diamond and gold ornaments, alcoholic beverages, bonds, shares and foreign and local currencies estimated to be around Tk 50 crore in all, raiding Dhanmondi residence of Hotel Purbani International's managing director.

They however could not arrest the owner, Mahbubur Rahman Joyal.

A team of the elite crime busters entered the house on road No. 27 acting on a tip-off that "Yaba girl Nikita" alias Ena alias Zannatul Ferdousi had been holed up there.

Rab said half an hour before the raid began at 12:30am Joyal and Nikita drove out of the house. Nikita's father Abdun Noor claimed that his daughter is Joyal's wife but Rab suspects she is his girlfriend.

Suspecting that a huge cache of Yaba pills might be stashed inside, the Rab men searched the house and seized shares of different companies worth around Tk 28 crore, bonds worth Tk 1 crore, local currency Tk 51.10 lakh, currencies of at least 15 countries, 38 credit cards of as many local and foreign banks, 17 bank cheques, and diamond and gold ornaments worth

several crore taka, alcoholic beverages and two passports.

During the swoop, they also took hold of some documents to know about Joyal's businesses.

After over 16 hours, Rab made a seizure list with the assistance of National Board of Revenue (NBR) officials.

The NBR will examine Joyal's

income tax files to know whether he had declared the wealth in his income tax returns.

The crime busters also seized

Babar jailed for 17yrs over illegal arms

A Dhaka court yesterday sentenced former state minister for home Lutfozzaman Babar to 17 years' rigorous imprisonment (RI) for possessing illegal firearms and ammunition at his Gulshan residence in the capital.

Defence lawyers rejected the verdict terming the case false and fabricated, and said they would file an appeal with the higher court against the judgement after getting a copy of it.

Judge Sayed Jahed Mansur of the Metropolitan Special Tribunal-9 handed down the sentence in a

packed courtroom at 12:45pm in presence of the four-party alliance government's influential minister.

Babar was convicted for keep-



ing an unlicensed revolver and 25 bullets of .32 bore rifle in his possession. The court awarded 10 years' RI for possessing illegal firearms under Section 19(A) of the Arms Act, and seven years' RI for possessing ammunition under Section 19 (F) of the same Act.

The verdict was given in the first case out of two filed against the former state minister since he was arrested at his Gulshan residence on May 28.

Under tight security, Babar was produced before the court at 12:15pm from Bangabandhu Sheikh Mujib Medical University

Sector commanders to sue war criminals

The Sector Commanders' Forum yesterday decided to file cases against the war criminals and called upon all to identify them at the grassroots level and send the lists of names to the forum.

Protesting Jamaat-e-Islami Secretary General Ali Ahsan Mohammad Mojaheed's recent remarks on the Liberation War and genocide of 1971, the commanders of different sectors of the Liberation War demanded his immediate arrest and trial.

At a press conference organised by the forum at the Liberation War Museum auditorium, they also demanded punishment to former

secretary Shah Abdul Hannan for describing the Liberation War as a "civil war". Hannan denied the sacrifice of the country's people for the independence of the nation, they said.

Air Vice Marshal (ret'd) AK Khandker, who was the deputy chief of staff of the liberation forces in 1971, said these persons have played seditious roles by denying the country's constitution and existence and their statements are part of a hatred conspiracy to erase the history and identity of the nation.

Most leaders of the Jamaat-e-Islami were the collaborators of the Pakistanis in committing war

High hopes, hurdles as judiciary to start new era

The country tomorrow sees the much-awaited implementation of the constitutional provision for separation of the judiciary from the executive, which has been ignored by political and military governments over the last 36 years.

From tomorrow all magistrate courts across the country will come out of the executive control and continue operating under the authority of the Supreme Court (SC).

The separation nourishes big hopes of ensuring smooth functioning and absolute independ-

ence of the judiciary but also faces a few problems initially.

According to the constitution, "The state shall ensure the separation of the judiciary from the executive organs of the state." But, the provision has remained neglected since formulation of the constitution in 1972.

The SC gave a directive in 1999 for the separation, but successive governments deliberately delayed fulfilling the constitutional demand.

The present non-party caretaker government started initiatives for separating the judiciary in January after assuming power.

Chief Adviser Fakhruddin Ahmed will inaugurate the historic event at the China-Bangladesh Friendship Conference Centre at 10:30am tomorrow by declaring the Dhaka District Judicial Magistracy and the Dhaka District Metropolitan Magistracy.

Chief Justice M Ruhul Amin will attend the programme as special guest while Law, Justice and Parliamentary Affairs Adviser Mainul Hossain will preside over the ceremony.

Around 600 executive magistrates entrusted by the administration with judicial job will return to

Mobile Court Ordinance promulgated

The government on Monday night promulgated the Mobile Court Ordinance 2007 empowering the executive magistrates to convene impromptu mobile courts and deal out punishments for certain offences.

The ordinance will come into effect from tomorrow, the day slated for separation of the judiciary from the executive.

The council of advisers on Sunday approved the ordinance, which also bar people from suing the executive magistrates or others involved with the mobile courts for any inadvertent harm done to the accused by their decisions while acting in good faith.

The ordinance gives any government official or executive

Regulatory reforms body formed to overhaul rules

The government yesterday formed a 17-member Regulatory Reforms Commission (RRC) in a bid to overhaul outdated administrative rules and regulations with specific focus on removing bottlenecks for economic investment, commerce and trade.

"The Regulatory Reforms Commission has been formed to prepare recommendations aiming to modernise the existing rules and regulations after necessary reform and review," stated a government notification.

With a tenure of one year, the commission will be chaired by former adviser and cabinet secretary Akbar Ali Khan and include former adviser Manjur-e-Elahi,

former secretary Abdul Mueyed Chowdhury, FBCCI president, two prominent economists and government secretaries and executives concerned.

The commission will come into effect once the government issues a gazette notification, expected today, according to government sources.

The RRC would also be authorised to hire experts on particular issues, who would then be needed to be incorporated through another gazette notification.

The notification stated the Board of Investment (BOI) would serve as the secretariat for the RRC, while the BOI executive chairman will serve as the member-secretary of the commission.

The commission also has the power to gather information from government, semi-government, autonomous or private organisations, according to the notification.

In relation to investment, trade and commerce issues, the commission will also be able to receive recommendations from national, regional and international development partners, and the soon-to-be-formed Bangladesh Better Business Forum and its working groups.

The government notification explained, "In the present era of globalisation and regional cooperation the huge number of existing rules of the country are not suitable for a dynamic administration."

39 Bangladeshi workers held in Malaysia

Malaysian police on Monday arrested 39 Bangladesh nationals following a gang fight involving Bangladeshis and locals in Johor Baru of Malaysia.

The fight started near a foreign workers' hostel in Taman Kota Puteri, Masai at 10:20pm. Police rounded up the 39 Bangladeshis after the clash, reported Malaysia Star.

Johor Baru's acting CID Chief Assistant Commissioner Che Yusoff Che Ngah said the two local workers and five Bangladeshis suffered injuries and were brought to a nearby clinic for treatment.

"Initial investigations showed that four locals, who were hired to relocate the workers to another place, had injured some of the workers. This angered the workers,

RELIGION-EXPLOITING PARTIES CEC agrees in principle to proposal for a ban

Chief Election Commissioner (CEC) ATM Shamsul Huda yesterday agreed in principle to a proposal placed by Jatiya Samajtantrik Dal for imposing a ban on political parties based on religion.

"A consensus has been reached over this issue. We'll see later how we can implement it," CEC Huda said during talks on electoral reforms with a JSD (Inu) delegation following arguments about the crucial issue.

Quoting article 38 of the constitution and section 20 of the Special Powers Act, the JSD leaders argued that it is illegal and a punishable offence to form or run a political

party based on religion. The EC will be accused of violating the constitutional oath taken to preserve and protect the constitution if it gives registration to any such political party, the leaders argued.

"We'll examine the issue again in the light of the constitution and hope you (JSD) will also study it further. We may hold more discussions on it," Election Commissioner Muhammed Sohul Hussain said during the talks.

The EC response came following growing demands from different quarters to keep religion-based political parties and war criminals out of polls.

Dr Wazed visits Hasina in jail

The detained former prime minister became emotional as she met her husband who has been suffering from heart disease, diabetes and other complications, sources said. Wazed was accompanied by four of his relatives.

During the hour-long meeting, Sheikh Hasina and her husband, talked mainly about their family issues, sources said. They also enquired about each other's health.

25 deposit Tk 424cr of ill-gotten money to BB

A total of 25 individuals and business firms on Sunday deposited Tk 424 crore of their ill-gotten money to the central bank.

Of the amount, Tk 410 crore was deposited locally and \$ 2 million or nearly Tk 14 crore, smuggled out, abroad during the last few years, was brought back from abroad.

The individuals and firms that deposited the money on Sunday are Giasuddin Al Mamun, a businessman and friend of Tarique Rahman, Lutfozzaman Babar, former state minister for home affairs, Rezaul Karim, director of Orion Group, Wakil Ahmed, an Awami League leader, Noor Ali, a businessman, Amin Mohammad Foundation, National Bank Ltd, AB

Bank Foundation, S Alam Group, Eastern Housing, Bangladesh Ship Breakers' Association, Partex Group and Bashundhara Group.

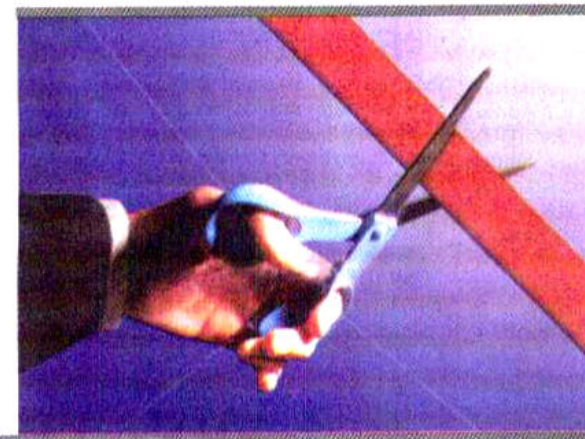
As of Sunday, the amount of illegally earned money received by the Bangladesh Bank (BB) totalled Tk 877 crore. The bank received Tk 436 crore from April through August and \$ 2.5 million or near about Tk 18 crore in last month alone, said sources.

The first time in the history of the country the central bank made such illegal money retrieval was in April this year when seven businessmen deposited Tk 270 crore of their illegal money following the government's anti-corruption drives.
