at a discussion on "Liberation War of Bangladesh, India and Joint Force" held at Bangladesh Institute of Law and International Affairs auditorium in the capital.

They said the sedition case has been filed with a regular court only to foil the demand of the people, especially of the Sector Commanders' Forum, to arrest and try the war criminals.

On Wednesday, an individual named Mohammad Fazlur Rahman filed the case with Chief Metropolitan Magistrate's Court, Dhaka against Jamaat-e-Islami Secretary General Ali Ahsan Mohammad Mojaheed, Assistant Secretary General Abdul Quader Mollah and ex-chairman of Islami Bank Shah Md Abdul Hannan accusing them of working against the Liberation War and carrying out massacres by forming Al Badr, Al Shams and Razakar forces in 1971.

"There is conspiracy behind filing of this case by an individual. Those who do not want that the war criminals tried have filed the petition," said Professor Kabir Chowdhury, the chair of the discussion.

It occurs that a few of the advisers in the caretaker government are against the trial of war criminals, Prof Chowdhury added saying, "I would like to say this clearly to the caretaker government -- sit together and take the decision on the basis of majority and start the process of trying the war criminals."

Prof Chowdhury also said the war criminals are known to all and they should be arrested before the trial. One of the advisers of the caretaker government seems to be speaking for the Jamaat-e-Islami, he alleged.

Justice KM Sobhan, president member of South Asian Conference Against Fundamentalism and Communalism, said it is not possible to try the war criminals in a regular court since war crimes are not considered crimes under the Bangladesh Penal Code.

"We have to understand that there might be a different intention if someone files a case against them [war criminals] with a regular court," he said, urging all to be alert about such ill-intended moves.

Rebutting the claims made by a few of the caretaker government advisers who said that there was no attempt to try the war criminals in the last 36 years, Justice Sobhan said following the independence of the country, around 37,000 criminals were arrested and around 3,000 of them were convicted of war crimes, but the process of the trial was stopped after the assassination of Bangabandhu Sheikh Mujibur Rahman.

Awami League Presidium Member Abdur Razzak said the Jamaat leaders do not recognise the Liberation War as they had claimed that the war was a mere civil. Moreover, they want the country to turn into Pakistan, he added.

Filing a sedition case by an individual against them is not right. Instead, the state should file a case against them, Razzak demanded.

Shamoly Nasreen Chowdhury, wife of a martyr, said the sedition case is a conspiracy to prove the war criminals innocent.

Meanwhile, speakers at a discussion said if an individual files a case against the war criminals it would hamper the entire initiative to try them.

Rice import

no difference between Saturday's estimate and the new one if import of wheat is considered.

But on Saturday, the agriculture ministry did not say anything on wheat import.

In their latest estimate, the food and agriculture ministries said the domestic demand for rice this fiscal year is 285.20 lakh tonnes while net production in the country will be 271 lakh tonnes. "Thus, we will have a deficit of 14.20 lakh tonnes," Golam Kibria, senior information officer of the food ministry, told reporters citing official data.

In Saturday's report, the agriculture ministry put the demand for rice this fiscal year at 302 lakh tonnes, and net production at 271 lakh tonnes, the same as yesterday's.

Yesterday's report on food status in the country and import requirement figures raised questions about government data.

On Saturday, the agriculture ministry said 12 lakh tonnes of rice have been imported in the current fiscal year, and import of another 19 lakh tonnes is needed.

Golam Kibria said yesterday, "To meet the deficit, seven lakh tonnes of rice have already been imported this fiscal year, and import of 7.20 lakh tonnes more is needed."

On wheat, he said the domestic demand stands at 24 lakh tonnes while its production is estimated to be 8.90 lakh tonnes, leaving a deficit of 15.10 lakh tonnes. "The deficit will be met through import."

He went on, "In the current fiscal year, 9.20 lakh tonnes of wheat have already been imported, and we need to import another 6.40 lakh tonnes."

India has recently agreed to lift the ban on export of five lakh tonnes of rice only to Bangladesh considering the crop damage in cyclone.

Referring to the Indian offer, Tapan Chowdhury told the press briefing yesterday that the Indian side has asked for import of rice through government bodies. "We want our private traders, certified by the food directorate, to import the rice," he said.

The foreign adviser, now in Delhi on a visit, will raise the issue with the Indian counterpart, Tapan mentioned.

Bangladesh sought food aid of five lakh tonnes from the donors. The food secretary told newsmen that Saudi Arabia, India and Pakistan have so far agreed to provide two lakh tonnes.

The discussion was organised by Peshajibi Nari Samaj at the National Press Club on the occasion of Freedom Fighters Day.

They said some conspirators influenced the person to file the sedition case.

The discussants demanded trial of war criminals under the International Crime (tribunals) Act-1973 and formation of a commission to collect evidence of war crimes.

Maj Gen (ret'd) KM Shahidullah said it might be part of a conspiracy to divert their movement to wrong direction.

"It would be very hard for an individual to prove crimes like rape, killing and arson committed by the war criminals," the former army chief said.

"The existing law is not enough to try the war criminals as it would be tough to prove their (war criminals) misdeeds after 36 years of the Liberation War," said Maj Gen (ret'd) KM Shahidullah.

"It is the present government that has to take initiatives to try the war criminals," said Mahfuza Khanom.

Ahad Chowdhury, Ferdousi Priyabhashini, Shaheed Jaja Salma Haq, Dr Dipu Moni, Afroza Haq Rina, and Meher Afroz Chumki, among others, spoke.

The speakers at another discussion at BILIA expressed gratitude to India for extending its full cooperation to Bangladesh people during the Liberation War and recognising Bangladesh on December 6 in 1971.

Former secretary HT Imam and Bangladesh University Teachers' Association General Secretary Prof Ajoy Roy also spoke.

Meantime, discussants at a roundtable urged the government to form a special tribunal to bring the war criminals to book, reports BSS.

The roundtable, organised by Amra Muktiyoddhar Santan, was addressed, among others, by journalist ABM Musa and Bangladesh Muktiyoddha Sangsad Central Command Council Chairman Prof Abdul Ahad Chowdhury.

Humayun Kabir, president of the organisation, chaired the roundtable.

70,000 complaints

to begin scrutinising all 70,000 corruption allegations. And considering the importance of the allegations, enquiries and investigations will be initiated," said Col Hanif Iqbal told the briefing.

The commission also decided to form three committees, each comprising three members and headed by a deputy director or assistant director, to conduct the scrutiny process.

A director general or a director of the ACC will supervise the activities of each committee and will forward selected allegations to the commission for initiating enquiries into them.

The commission also fixed three criteria based on which the allegation would be considered as non-eligible to be looked into.

The commission will not take into consideration anonymous allegations, allegations which are not in the commission's jurisdiction, and family disputes and disputes over property distribution.

If the commission did not accept an allegation, it will inform the complainant about its decision.

When asked about the filing of a case regarding the Niko deal, Iqbal said, "Today's meeting of the commission did not talk about the Niko case."

When asked about the submission of charge sheet in the Gatco case, the director general said, "There are many complexities and legal issues and one has to take a number of steps to advance. Everything must be examined carefully and the work of examination is not finished yet."

CASE AGAINST AMINUL

The ACC yesterday sued former post and telecommunication minister barrister Aminul Haque and his aide Mofiz Uddin, Tanore upazila Jubo Dal convenor, for using Tk 16.15 lakh government money for personal purposes, our staff correspondent in Rajshahi reports.

Sayed Ahmad, assistant director of Rajshahi ACC, lodged the case under sections 409/109 of the Penal Code and 5 (2) of Prevention of Corruption Act, 1947 yesterday afternoon.

The plaintiff alleged that Aminul and Mofiz constructed a bridge on Chanduria canal spending Tk 16,15,553 before the LGED department approved the work plan.

The bridge was useless to locals but it did link Mofiz's villa on the canal.

Mofiz is in police custody but Aminul is absconding.

CASE AGAINST SALIM

ACC Assistant Director Ali Akbar filed the case accusing Salim, his wife Amena Begum, his daughter Shahara Salim and son Mehedi Hasan of amassing wealth illegally.

In the first information report, the complainant said Salim concealed information about his property worth Tk 12.38 crore in the wealth statement submitted to the commission and he accumulated Tk 62.96 crore illegally.

The case was filed under sections 26 (2) and 27 (1) of ACC Act and Emergency Power Rules.
