Request of Expressions of Interest (EOI) for Selection & Employment of Audit Review Firm to Review Union Parishad Audit Reports

1. The Government of the People's Republic of Bangladesh has received a credit (Credit No. 4193-BD) towards the cost of the Local Governance Support Project (LGSP) from the International Development Association (IDA). The Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives (MLGRD&C) has initiated the implementation of LGSP and intends to apply part of the proceeds of this credit for services to be provided by two chartered accounting firms (national) under the two contract packages, mentioned below, which will be responsible for reviewing approximately 2200 Union Parishad audit reports.

2. The scope of services includes reviewing the audit reports of financial audits of about 2200 Union Parishads (UPs) in various districts and upazilas of Bangladesh; the UPs in question have been grouped into 22 contract packages, and will have their 2006-2007 financial statements audited by recognized audit firms. Each of the two chartered accounting firms will be expected to review approximately 1100 audit reports under each of the following contract packages:

The objectives of the audit review are to assist LGD to: (i) promptly ascertain if audit reports received from audit firms are acceptable; (ii) ensure quality and consistency of audit process and outcomes; (iii) follow-up on audit findings with UPs. It is expected that the audit review will begin on or around March 2008.

3. The Local Government Division of the Ministry of Local Government, Rural Development and Cooperatives now invites eligible audit firms to submit their Expressions of Interest (EOI) for providing the required services. Interested audit firms must provide information with documentary evidences indicating that they are qualified to perform the services (brochures, copy of its original registration, description of assignments of similar nature, experience in similar conditions, availability of appropriate skills among staff, etc). The EOIs received will be evaluated on the basis of the following.

- The number of full time partners in the chartered accounting firm (a minimum of four full time partners resident in Bangladesh is required).
- The number of years that the chartered accounting firms has been in public practice in Bangladesh (more than ten years are required).
- Partnership/affiliation with a reputed international accounting firm.
- Experience of auditing decentralized public sector bodies and exposure to public sector financial management environment.
- Experience of working on similar assignments (UP accounts, local government finances).
- Experience of work in rural environment.
- Capacity in terms of manpower with appropriate skill mix and logistics to provide the service in a professional manner.
- Qualifications of staff.

In order to avoid any conflict of interest, a firm contacted for the LGSP UP audits and a firm having any sort of direct or indirect interest in such a contracted firm will not be eligible to be an audit reviewing firm. One firm may express its interest for more than one contract package. Firms may associate with others to enhance their qualifications, but should mention whether the association is in the form of a "joint venture" or "sub-consultancy". In the case of an association, all members of such association should have real and well-defined inputs to the assignment.

4. Information provided by the firms will be verified with the Institute of Chartered Accountants of Bangladesh (ICAB) wherever applicable.

5. For all of the above contract packages, audit firms will be selected following SFB (selection under fixed budget) sub-method in accordance with the procedures set out in the Public Procurement Regulations-2003 and Public Procurement Procedures issued by the GOB (www.cptu.gov.bd). It is expected that completion of the assignment/services will take approximately 1 (one) year.

6. Interested chartered accounting firms may obtain further information from the office of the undersigned during office hours on working days. The authority reserves the right to accept or reject any or all EOIs received without assigning any reason thereof.

7. Expression of Interest, in 2 (two) sets, shall be submitted by 9 January 2008, in sealed envelope delivered to National Project Director, in the following address and be clearly marked "Expressions of Interest (EOI) for Selection & Employment of Audit Review Firm to Review Union Parishad Audit Reports"; Contract Package No. has also to be mentioned on the envelop.

8. EOIs received after the deadline will not be considered for short-listing. The Local Government Division of the Ministry of Local Government, Rural Development and Cooperatives will not be responsible for any delay in submission of EOIs including delay due to postal or any other reason whatsoever.
