


- The Govt. of the People's Republic of Bangladesh has received an ODA loan from Japan Bank for International Cooperation (hereinafter referred to as the JBIC) towards the cost of Design-build and Turnkey Contract for Construction of Grid Substations including Associated Transmission lines Development (Loan agreement no. BD-P52 signed on June 29, 2006). It is intended to apply a portion of the proceeds of the loan to payments under the contract for which this Invitation for Bids is issued. Disbursement of the ODA Loan by JBIC will be subject, in all respects, to the terms and conditions of the Loan Agreement, including the disbursement procedures and the 'Guidelines for Procurement under JBIC ODA Loans'. No party other than the Govt. of People's Republic of Bangladesh shall derive any rights from the Loan Agreement or have any claim to Loan proceeds. The above Loan Agreement will cover only a part of the project cost. As for the remaining portion, the Govt. of Peoples Republic of Bangladesh will take appropriate measures for finance.
- JBIC requires that bidders and contractors, as well as the Govt. of Peoples Republic of Bangladesh, under contracts funded with JBIC ODA Loans and other Japanese ODA, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, JBIC;
 - will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
 - will recognize a contractor as ineligible, for a period determined by JBIC, to be awarded a contract funded with JBIC ODA Loans if at any times determines that the contractor has engaged in corrupt or fraudulent practices in competing for, or in executing, another contract funded with JBIC ODA Loans or other Japanese ODA.
- The Power Grid Company of Bangladesh Ltd. ("the Employer") invites sealed bids from eligible bidders for design-build & turnkey contract for extension of existing 230/132 kV substation at Comilla (N) & Hathazari as defined in the bidding document (hereinafter referred to as "the Works"). The Works include:
 - Extension of Existing 230/132kV Substation at Comilla (N):**
Design, supply, installation, testing & commissioning on turnkey basis of 3x75 MVA, 230/132/13/33 kV single phase auto transformers with necessary switchgears, associated control & protection equipment and civil works at Comilla (N) substation.
 - Extension of Existing 230/132kV Substation at Hathazari:**
Design, supply, installation, testing & commissioning on turnkey basis of 1x150 MVA, 230/132/33 kV three phase auto transformers with necessary switchgears, associated control & protection equipment and civil works at Hathazari substation.
Details of the scope of work are specified in the bidding document.
- Bid is open to firms and voluntarily formed joint ventures from eligible source countries, in accordance with the Guidelines for Procurement under JBIC ODA Loans.
- Bidder shall meet the following minimum requirements alongwith other requirements as mentioned in the Instruction to Bidders:
 - Bidders (partner-in-charge in case of Joint Venture) must have successfully completed on turnkey basis, at least three (3) comparable contracts [a comparable contract shall mean design, supply, delivery, installation and testing & commissioning on turnkey basis of construction of at least two bays of 220 kV or higher voltage substation together with 100 MVA or higher capacity power transformer] and in case of Joint venture each partner (other than lead partner) must have completed on turnkey basis, at least one (1) comparable contract [a comparable contract shall mean design, supply, delivery, installation and testing & commissioning on turnkey basis of construction of at least two bays of 220 kV or higher voltage substation together with 100 MVA or higher capacity power transformer] within the last ten (10) years as on the date of bid opening. At least one installation of the above mentioned three (3) comparable contracts (Bidder or Partner in charge in case of Joint Venture) shall be in successful operation for minimum of three years. Bidders must also have project management experience (experience of Partner in charge in case of Joint Venture) to demonstrate their management capability in at least one turnkey project (contract amount should not be less than US\$ 3.0 million) outside their own country within the last ten (10) years.
 - Bidders shall provide Audited Financial statements for last five (5) years as documentary evidence regarding Liquid Assets and Annual turnover and evidence of unencumbered real assets, lines of credit and other financial means sufficient to meet the construction cash flow for a period of three (3) months with their bids. The minimum Liquid Assets and annual Turnover for the Bidder's Organization or Joint Venture shall not be less than
 - Liquid Assets (average of last 5 years), unencumbered real assets, lines of credit and other financial means net of the bidder's commitments for other contracts: US\$ 1.5 million
 - Average Annual Turnover as prime contractor (defined as billing for works in progress and completed) over the last 5 years: (Average of last 5 years): US\$ 8.5 million
- The partner in charge in case of Joint Venture shall meet not less than 40% and each partner of the joint venture shall meet not less than 25% of the minimum criteria given in items. (i) & (ii) above.
- The proposed equipment under this contract shall be procured from an ISO 9001/ISO9002 or equivalent certified manufacturer who has designed, manufactured, type tested and supplied respective equipment of similar or higher specifications required by this bid for the last ten (10) years. The equipment shall also be in satisfactory service in humid tropical climate for a minimum of three (3) years as on the date of bid opening.
