Palermo have issued a hands off warning to Europe's top clubs over star Brazilian pair Amauri and Simplicio.

Amauri is believed to be at the centre of a transfer tug-of-war between Juventus and AC Milan while Simplicio is reportedly wanted by both Italian giants as

well as Serie A champions Inter Milan and Spain's Valencia. Some websites have reported that Palermo are willing to sell, but club president Maurizio Zamparini

dismissed that. 'None of it is true, I don't know who's spreading these rumours,"

he said. Even if Palermo do manage to hang onto the pair during this

transfer window, they will surely depart for pastures new in the close season, according to Italian news agency ANSA. Striker Amauri has impressed

with seven league goals this season while midfielder Simplicio has been at the hub of Palermo's play all season.

Amauri, for one, has already spoken of his desire to move on to a higher level.

"I would like to play with players such as (Alessandro) Del Piero and (David) Trezeguet (of Juve), but also with Kaka (of Milan) it would be incredible," he said.

Palermo are rumoured to be interested in Lazio's out of favour midfielder Mourad Meghni, who is thought to be possible summer transfer target.

Meghni, like many French players of North African origin, was once talked about as the new Zinedine Zidane but his career has failed to take off in the Italian capital.

Relief for Tevez Rio looking forward

Manchester United striker Carlos Tevez is less seriously injured than first thought after being carried off during the 1-0 league win over Birmingham on Tuesday.

The 23-year-old Argentina international was forced off the pitch after 71 minutes and was then carried down the tunnel by two members of the backroom staff.

That raised fears that Tevez, who had earlier scored the winner, could even have suffered a broken ankle in a heavy challenge.

But a United spokesman told www.manutd.com this afternoon: "Nothing is broken; Carlos Tevez has just got a badly bruised right

United coach Alex Ferguson said after the Birmingham game that Tevez was a major concern for this weekend's FA Cup trip to Aston

"It was a bad tackle and the longer the game went on, the worse the injury got," Ferguson said.

"In the end, we had to bring Carlos off. We will assess him tomorrow to see what the damage is but he is doubtful for Saturday now.

On the plus side for United, Tevez' fellow striker Wayne Rooney is on track to face Martin O'Neill's side after recovering from a virus which kept him out for two matches.

Barton refused bail again

Less than a month after the family of Indian steel magnate Lakshmi Mittal took a 20 per cent stake in Queens Park Rangers, the west London club have wasted little time in signing several new players.

Rangers, co-owned by Formula One supremo Bernie Ecclestone and Renault team boss Flavio Briatore, may be only narrowly above the relegation zone in English football's second-tier Championship but the Loftus Road side are determined to get back to the Premier League.

And just days into the opening of the January transfer window, Rangers manager Luigi De Canio has spent some 1.5 million pounds on signing Hogan Ephraim, Akos Buzsaky and Matthew Connolly.

Winger Ephraim, 19, has signed a three-and-a-half year deal for an undisclosed fee - reportedly 800,000 pounds - from West Ham.

Hungarian midfielder Buzsaky, 25, has completed his permanent

signing on a two-and-a-half year deal for a fee of around 500,000 pounds from Plymouth, having joined Rangers on an initial loan deal in November.

And 20-year-old centreback Connolly, who spent the first half of the season on loan at Colchester, has also put pen to paper on a three-and-a-half year deal from
