



- " The Managing Director shall be an ex-officio member of the Board of Directors. The appointment, extension of tenure and removal of the Managing Director will be approved by majority of the shareholders of the company based on the recommendation of the Board \*.
- "The remuneration of the Directors including the Chairman shall be set by the Board and information on the remuneration shall be included in the Annual Report. If any Director being willing is called upon to perform any extra services for any purposes of the company, or to give any special attention to the business of the company, he/she may be paid such remuneration for those services as may be determined by the Board".

"The quorum necessary for transaction of the business of the Directors may be fixed by the Company in general meeting and unless and until so fixed shall be majority".

"Article 99 shall be read as 99 (i)".

" The Board shall appoint committees on audit, recruitment and promotion and procurement review. The audit committee shall be headed by an independent Director of the Board \*.
