

## Plan to take stern action against polluters of Karnaphuli

DoE meets tomorrow after a lapse of two months of expiry of deadline

The Department of Environment (DoE) will take stern action against the industrial units that have failed to meet the deadline of October 31, 2007 for dumping wastes after refining in the river Karnaphuli.

The DoE will hold with the local administration, including deputy commissioner and representatives from Chittagong City Corporation (CCC) and Chittagong Development Authority (CDA) and Chittagong Port Authority (CPA), on January 10 in this regard.

The meeting is being held after a lapse of two months to finalise the next course and method of actions against the defaulters, sources said.

Initiative has been taken to protect the river Karnaphuli, lifeline of Chittagong, from pollution that has been posing

a threat to the aquatic species as well as the human health for long.

The DoE served notices to the industrial units that have been contributing to the rampant pollution of the Karnaphuli by dumping different types of wastes everyday.

Only 10 percent of the industries responded positively to the deadline for dumping the wastes after refining in the river expired on October 31 last year, said DoE Director Mohammad Nazmul Haque.

He said dumping of the wastes after refining by the remaining industrial units are under process. He said stern action will be taken against those who are yet to comply with the directive.

Sources at DoE said more than 700 industrial units in the port city, division and both the banks of the river stretching from the estuary of the Karnaphuli to Chandraghona

under Kaptai upazila in Rangamati district, have long been dumping chemical and other wastes in the river directly or indirectly.

The industrial units include Karnaphuli Fertiliser Company (Kafco), Chittagong Urea Fertiliser Limited (CUFL), Karnaphuli Paper Mill (KPM), Karnaphuli Rayon Complex, 19 tanneries, 26 textile mills, two chemical industries, five fish processing industries, two soap industries, two pesticide plants and an asphalt bitumen plant.

Mohammad Shahadat Hossain, assistant professor of Institute of Marine Sciences and Fisheries at Chittagong University (CU), emphasised the need for identifying the actual threatening areas on the banks of the river.

Prof Shahdat, who conducted several researches on pollution of the river, said pollution will decrease automatically if different structures are built on both the banks of the river under the government control for different purposes.

He said the DoE efforts along with the administration should be well-managed and need strict supervision to achieve the goal.

In addition to these, house-

### CDA HOUSING PROJECT

## Allotment of plots within a month likely

The Chittagong Development Authority (CDA) is likely to start allotment of plots under its largest-ever housing project in the Ananya Residential Area within a month.

A patch of land acquired for Bakharabad Gas System Limited (B GSL) and a few pieces of private land in the project area delayed the process of land acquisition, making the implementation of Tk 300 crore housing project uncertain.

The district administration sent the matter to the land ministry for instructions before acquisition and handing over of the land to CDA, raising concern among some 5200 applicants, who got a total deposit money of Tk 220 crore blocked in the project.

They submitted application forms in October last year for

1521 plots in Ananya R/A being developed on 174 acres of land beside the under-construction Oxygen-Quaish Road, sources said.

The district administration has resumed the acquisition of land after having clearance from the land ministry last week while CDA is preparing to hold open lottery for allotment of plots within a month, as per instructions of the ministry.

In the meantime, CDA paid about Tk 194.45 crore, including service charge of Tk 15 crore, to the district administration on October 9 for acquisition of 169 acres of land.

Earlier, the administration handed over some 52 acres of land to CDA.

Delay in plot allotment process created resentment among the applicants, who deposited Tk 4 lakh to Tk 5 lakh for the plots, while many of them were also thinking of withdrawing the applications.

They said in case of losing plots in lottery the delay will mean financial loss to them since enrolment of the deposited money could have earned

them some profit every month.

They said the deposited money (amounting to Tk 220 crore) could have earned at least Tk 2 crore as interest a month if it were saved in banks.

In this regard CDA sources said delay in acquisition and handing over of land by the administration slowed down plot allotment process that could be completed by November.

CDA Chairman Shah Muhammad Akhteruddin said they are quite aware of the growing concern of the applicants and making efforts to complete the plot allotment process as early as possible.

He said they will hold lottery for allotment of the plots within a month if they get possession of the acquired land.

#### 'Solve problems of CU visually challenged students'


Speakers urged the Chittagong University (CU) authorities to take necessary steps in solving the problems faced by the visually challenged students of the university.
