DU teachers

detainees will be freed 'within the next few days, whatever the court verdict might be'

The DU agitators yesterday said the government's promise was not clear enough regarding in which fashion their detained peers will be freed from jail.

Former president of Dhaka University Teachers' Association (Duta) Prof AAMS Arefin Siddique said nobody is feeling assured that the detainees will be freed in a dignified manner any time soon. It seems the incidents of Rajshahi University are about to visit the DU campus, as the government is insisting on freeing the detainees through the 'legal mechanism', he

He said, "But such repetition of Rajshahi University incidents might make the situation more complicated and might not be acceptable to all. Rather it will be better if the government withdraws the cases. That will be dignified for the government and the detainees too, leading to easing of the accumulated tension between the government and the university."

The students however continued their peaceful demonstrations on the campus demanding their peers' and teachers' release by abstaining from classes for two hour vesterday for the fourth day in a row, and by collecting signatures of fellow students, with silent vigils and processions, by drawing street graffiti, and by performing agitprop street theatres.

Hundreds of students articulated their demand for the release of the detainees by writing comments and signing their names on large banners hanging at various places on the campus for the pur-

They will observe two-hour class abstention from 11:00am to 1:00pm today too. They will also hold a solidarity rally on the campus this morning. Students Against Repression (SAR) announced a * two-hour class boycott programme from 11:00am to 1:00pm every day till January 17.

A group of SAR leaders yesterday afternoon met Vice-chancellor Prof SMA Faiz and reiterated their demand for the release of all

detainees. STUDENTS' NEWS CONFERENCE The agitating DU students at a news briefing yesterday said the education adviser's comment that the detainees will be freed within the next few days, whatever the court verdict might be' is not clear enough.

SAR, a platform formed mainly by left leaning student organisations, said there had been pledges earlier from the government and the university authorities of releasing the detainees, which were not

The agitators also said release of only the detainees in two cases in connection with violating the Emergency Power Rules (EPR) 2007, will not be enough to ease the crisis, rather they demanded release of all detainees in connection with all the four cases filed in connection with the violent incidents on the campus between August 20 and 22 of the last year.

Two cases were filed against 4 teachers and 15 students in connection with violating EPR 2007, two other cases were filed in connection with torching of an army vehicle. In one of the army vehicle torching cases around 22 DU students and a few other outsiders were charged, while the charge sheet in the other case in connection with the same incident has not been submitted yet.

PROFANWAR'S STATEMENT In a news release last evening

detained Prof Anwar Hossain's son Sanjeeb Hossain said his father in the court earlier in the day categorically protested the education adviser's statement made on the night before, and expressed deep apprehension that the incidents of Rajshahi University is about to repeat themselves in Dhaka. Prof Anwar Hossain is the general secre-

tary of Duta. Prof Hossain termed the education adviser's comment as irresponsible, the release said. The release quoted him as asking, why the case against them would not be withdrawn since they did not commit any crime. Pointing at the contradiction embedded in the newly appointed education adviser's statement the night before the detained professor told the court that the adviser is in 'contempt of court' by making such a statement, the release

According to the release the professor also said all detainees in connection with the DU incidents must be freed and all cases in connection with the incidents must be withdrawn if normalcy to be restored on the campus.

Meanwhile, students of Rajshahi University (RU) vesterday continued their demonstrations on the campus demanding release of 10 of their peers and a university employee, convicted in connection with torching of a DGFI vehicle there at the time of the DU incidents that ended up spilling over to other university campuses countrywide.

They also demanded with drawal of the case filed by RU authorities against many other students for their involvement in the violent incidents on the campus on August 23 last year.

Earlier, hundreds of students attended their classes wearing black ribbons, and staged sit-ins in front of Shahidullah Arts Building.

They carried banners and placards demanding withdrawal of the cases and unconditional release of the convicted students and the employee. They also demanded release of the detained DU teachers and stu-

Adcomm clarifies

As tension mounted at MBM, authorities of around 20 other nearby readymade garment (RMG) units shut down operations at their factories in apprehension of labour

At that time rumours were spread among RMG workers that two of their fellow workers including a female were beaten to death inside Opex Style Wears Ltd by hired goons of the factory owner and their bodies were dumped inside the factory.

As the rumour spread among the workers of other factories like wildfire, they joined in the violent demonstrations with the workers who had already been on the street. They rained brickbats on the police and garment factories, damaging several RMG units.

Police at that time swooped on the agitating workers, charging batons and firing teargas shells and rubber bullets, witnesses said.

Soon the clash spread to the road stretching from Mirpur Section 10 roundabout to Kanchukhet and into

all the alleys on both sides, turning most part of Mirpur into a combat Police were seen retreating several times in the face of attacks of the

violently advancing workers. Several journalists on professional duty were beaten by police during the clashes.

According to witnesses, when the employees of MBM Garments Factory started agitation, the authorities of all factories in the area, excepting Opex Style Wears Ltd, shut down their activities apprehending attacks on their factories. After the closure of the factories, all the workers came out on the streets and joined the already agitating workers parading the roads in front of the factories.

Meanwhile, in protest against the continuing operation of Opex Style

police beat up the angry protesters indiscriminately. When contacted, Capt (retd) M Nurul Azim, director (finance) of Opex Style Wears Ltd, denied the

allegation of torturing the workers and said, "The vested quarters are trying to influence the workers to be

Earlier on Sunday, police beat up a group of RMG workers in the city's Sheorapara area after the workers blockaded the busy Rokeya Sarani to drive their demands home vandalising several vehicles.

Yesterday's agitation is the fourth of such incidents in the area since January 2. Earlier, workers of SQ Sweater Ltd staged demonstrations on January 2 and 3 while workers of three other factories of the same group of companies barricaded Rokeya Sarani on Saturday in support of similar demands.

It also commits the two sides to another joint military exercise this year, following their first-ever exercise late last year, and to pursue a possible regional trade agreement, said Singh, who arrived on Sunday.

Singh called the document "an important milestone in the evolution of our relations."

"The profound changes taking place in the world today present both our countries with a historic opportunity to work together towards a 21st century that is conducive to peace and development," he told

reporters. "It reflects not only our common perceptions but also our desire to purposefully cooperate in the

However, Singh also said in a speech earlier in the day Beijing must lift market barriers to Indian goods to bridge the rising trade deficit between us.

New Delhi is looking to rein in a trade gap with China, which it says jumped to about nine billion dollars in 2007 from four billion dollars the previous year as two-way trade has exploded recently.

Singh's three-day visit, made in the company of Commerce Minister Kamal Nath, is the first by an Indian prime minister to China in five years.

It comes as the world's two most populous nations seek to strengthen ties and overcome decades of mistrust, much of it stemming from the border dispute.

In Pakistan period, the historic general elections of 1970 were held under martial laws. And in Bangladesh, two parliamentary polls--second and third-- were held during the military rule of Ziaur Rahman and HM Ershad.

Questions have risen in public minds now whether the stalled ninth parliamentary polls will be held during the state of emergency since the army-backed caretaker government is yet to announce any timeframe for lifting the emergency, declared on January 11, 2007 suspending the January 22 general elections.

"We are not saying we want this (emergency). We want to examine the circumstances when the elections were held under martial laws so that we can reply to any queries by the chief adviser when we meet him," the CEC said.

"The Election Commission (EC) is yet to decide its strategy for asking the government to create an atmosphere conducive for holding polls," said Shamsul Huda.

The CEC avoided a reply when asked whether he still sticks to his earlier stance on revoking the state of emergency before the parliamentary polls.

The EC has reallocated seats for the districts in line with the criteria set out in the delimitation ordinance. Besides making sure the administrative units remain intact, it considered density of population and administrative convenience in the realloca-

The commission will now mark out boundaries of the parliamentary constituencies within the districts. It aims to complete the task by June.

Chief Election Commissioner (CEC) ATM Shamsul Huda published the list at a press briefing at the EC Secretariat conference room.

He said the commission is doing the delimitation in accordance with the law.

"At this stage, there is no need for us to discuss the issue with the political parties since the law tells us every thing we need to do in this regard, Huda said adding that the commission might talk to political parties once there is a draft on redrawn constituencies within the districts.

When his attention was drawn to the political parties' fear that the task might hamper the electoral roadmap, he said it's nothing to worry about. "We will still be able to hold a free and fair election," he observed.

In line with the EC's decision, each of the three hill districts--Khagrachhari, Bandarban and Rangamati--was allocated one seat

irrespective of their population. The number of seats fell to six from seven in both Sirajganj and Kishoreganj districts, five from six in Chandpur, 11 from 12 in Comilla, two from three in Barguna, four from five in either of Satkhira and Faridpur, and three from four in Manikganj and Munshiganj each.

Transport plan

There will be 50 road projects under STP and the east-west road connection will be a key feature of the development of the city communications system, he said.

Communications Adviser Maj Gen (retd) Ghulam Quader said development partners including the World Bank and the Asian Development Bank have expressed their willingness to fund the project. "So money won't be a problem in implementing it," he added.

On the other hand, Chittagong was allocated 16 seats against its previous 15, Rajshahi six against five, and Gazipur got five while previously

Barisal district has got six seats while it previously had six and a half, Pirojpur three against its previous three and a half seats, Mymensingh 11 against 11.5 and Netrakona has got three instead of its previous three and a half constituencies. Parts of Barisal, Pirojpur,

Mymensingh and Netrakona that used to make up inter-district constituencies have been deleted for their boundaries to be redrawn Dhaka district actually got 21

seats, but the EC taken one seat from it and allocated the seat for Meherpur district, a small district that did not have two seats. But the EC's decision is to allocate at least two seats to each small district. The CEC said according to the voter list prepared in 2001, each of 17 constituencies had voters below two

lakh, six constituencies each had over six lakh, seven constituencies each had between five and six lakh while the number of voters in each of 19 constituencies ranged between four and five lakh. The rest of the constituencies however are medium-sized in terms of the num ber of voters.

As the news of the demise of this multitalented personality spread across the city, the hospital was thronged with cultural activists, relatives, his well-wishers and students. He left behind his wife, relatives, a host of friends, and wellwishers to mourn his death.

Selim, a pioneer of theatre movement in Bangladesh, a researcher, an organiser and a professor of Department of Drama and Dramatics at Jahangirnagar University, was born in Shenerkhil village of Shonagazi upazila of Feni on August 18, 1949.

The playwright's body is now being preserved at Birdem hospital mortuary. The body will be placed in front of the National Museum tomorrow (Wednesday) at 9:00 am. From there it will be taken to the Shaheed Minar where people will pay their last tribute to the drama prodigy.

His namaz-e-janaza will be held at Dhaka University Jaame mosque after the Zohr prayers. His body will then be taken to Jahangirnagar University. Following a second namaz-e-janaza there, Selim will be laid to rest on the campus of Jahangirnagar University (JU) -- where he was a long-time teacher at Bangla Department as well as the founder president of Department of Drama and Dramatics.

He received his master's degree from Bangla Department of Dhaka University. In 1995 he earned PhD from Jahangirnagar University on 'Medieval Bengali Drama'

Selim Al Deen was admitted to the hospital on Friday following a cardiac arrest and had been on artificial life supporteversince. He was supposed to be flown to Bangkok yesterday afternoon for

better treatment. The doctors how-

ever declared him dead at around "Bangla drama literature can be categorised into three eras -- the Girish era, the Shishir era and the Selim era. The Selim era has come to an end today," said Rahmat Ali, associate professor of Theatre and Music
