### Biman pushes govt to ratify int'l Poor shipping links, weak deals treaty to cut borrowing costs

Biman is pushing the government to ratify an international treaty that will cut the cost of international borrowing for the country's airlines at a time when Bangladesh's national carrier prepares to renew its aging fleet.

The Cape Town Convention and Aircraft Protocol is an international rule that allows global lenders to take control of aircraft in case of default by the debtor from a coun-

try that has ratified it. The added security means the lender is prepared to finance the aircraft purchase at a lower interest rate, meaning the buyer will pay less for the plane.

MA Momen, chief executive of Biman Bangladesh Airlines, said Biman favours the ratification because it will enable the national

carrier to get easy financing from legal framework.

"We want the government to ratify the convention and the Aircraft Protocol as soon as possi-

## undermine Bangla-Pak trade

Negative attitudes, poor shipping links and weak trade agreements are undermining trade between Bangladesh and Pakistan, a seminarin Dhaka was told yesterday.

"Traders are simply not interested in going to Pakistan to participate in trade fairs," Abdur Rahman, Director (Trade Policy), Export Promotion Bureau of Bangladesh, said.

The negative attitude is reflected in the low level of exports to Pakistan that reached just \$61.1 million in FY 2006-07. Despite the closeness and shared history Pakistan does not feature among Bangladesh's top 15 export destinations.


Moreover, any increase in trade between the two countries in recent years has been due to rising imports from Pakistan as the Bangladeshi garment sector sources raw materials from its South Asian neighbour, speakers said.

"Ships come to Chittagong from Karachi through Singapore with goods but return empty. This enhances trading costs as well as discouraging businessmen, Roubina Taufiq Shah, Commercial Secretary, Pakistan High Commission in Dhaka, said.

The seminar titled 'Bangladesh-Pakistan Trade Opportunities under Safta' was held at the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI).

The situation is not helped by the protectionist attitudes of both governments who are ready to place potential import items on 'negative lists' under the South Asian Free Trade Agreement, denying them duty free or low tariff

Bangladeshi export products like woven garments, knitwear, tea and jute products are listed in the Pakistani negative list while potential Pakistani exports such as rice, fish, fruits, cotton yarn, readymade garments and bed wear are listed in the Bangladeshi negative list.

"It is not the political will but the bureaucracy which is one of the main reasons that Safta is a failure,' Manzur Ahmed, former director of FBCCI, said. He blamed the lengthy bureaucratic negotiations during the past decade for the failure.

"Businessmen have had little contribution in the important

#### Bangladesh trade fairs in 3 countries this year

UNB, Dhaka

Three single-country trade fairs will be held in the UK, Ireland and South Africa this year to showcase Bangladeshi goods as part of measures for promoting the country's trade abroad.

London-based British Bangladesh Trade Cooperation and Bangladesh-based Expo Bangla Worldwide will jointly organise the fairs. Of the events, 'Expo Bangladesh 2008 South Africa' will be held in April while 'Expo Bangladesh 2008 Dublin' in June and 'Expo Bangladesh 2008 London' in August.

The organisers said the fair in South Africa would be held in cooperation with Bangladesh High Commission in South Africa and Johannesburg Chamber while in Dublin with the help of Bangladesh High Commission in London.

They said the Bangladesh High

Commission in London and Dublin Chamber would extend assistance for holding the Dublin "The objective of holding the

trade fairs is to create market of Bangladeshi export-quality goods abroad," said one of the organisers.

The exhibits include readymade garments, leather and leather goods, handicrafts, frozen foods, dry foods, home textiles, IT and traditional goods.

#### Ukraine to join WTO

Ukraine has reached an accession agreement with the World Trade Organisation, a WTO source said on Friday.

Ukraine's candidacy will now be put to the WTO's General Council meeting on February 5, followed by a six-month ratification process, a WTO official told AFP.

On joining the world trade body Ukraine will seek a free-trade agreement with the neighbouring European Union, Ukrainian President Viktor Yushchenko said

earlier this month. Ukraine is the biggest country besides Iran and Russia outside the 151-member WTO, which governs global trade rules.

#### Fix minimum wage for workers in line with prices of essentials

#### Demands Make Trade Fair Alliance

Make Trade Fair Alliance, an international organisation consisting of several non government organisations supporting workers' rights in Bangladesh, has demanded a minimum wage for the ready made garment workers in line with the market prices of essentials.

It voiced the demand at a press conference at the Reporters Unity office in Dhaka yesterday marking the observation of the Global Day of Action.

World Social Forum declared January 26 as the Global Day of Action to establish the rights of workers and ensure a better life for all the toiling masses worldwide against the backdrop of an unjust world economic order.

The alliance raised a 4-point demand at the press meet, which include introduction of a rationing of essentials for workers, taking immediate effective measures to contain the soaring prices of essentials and Bangladesh's proper initiatives to protect the interests of net food importing countries at the WTO (World Trade Organisation)

negotiations. The alliance in collaboration with Karmojibi Nari, an NGO working for the cause of RMG workers in Bangladesh, organised the press conference.

Nasimul Hasan Dipu, a keynote speaker from Incident Bangladesh, also an NGO, said "More than 25 lakh workers are facing a hard life as their demand for a minimum wage of Tk1662.50 a month has not yet been appropriately fulfilled."

#### BB governor urges banks to help education sector

scholarships to 111 poor but meritorious students.

Of the scholarship recipients, 62 students who passed the Secondary School Certificate examinations in 2006 will receive Tk 1000 per month and Tk 2000 per year during their study periods.

The rest 49 students who passed the Higher Secondary School Certificate examinations in 2006 will get Tk 1500 per month and Tk 3000 per year during their study

#### China's GDP growth highest in 14 years ANN/CHINA DAILY

The Chinese economy expanded by 11.4 per cent year on year in 2007 -- at the fastest clip since 1994. This is the fifth consecutive year China's economy grew by more than 10 per cent, the National Bureau of Statistics (NBS) said.

The ups and downs each year have also been within 1 percentage point in the past five years, which is an "extraordinary" feat, NBS chief Xie Fuzhan told a press conference on Thursday.

#### Bush urges Congress to adopt economic stimulus package

President George W. Bush on Friday urged Congress to approve "as soon as possible" an economic stimulus plan of some 150 billion dollars negotiated with congressional leaders aimed at avoiding a recession.

Bush spoke one day after the White House and leaders of the opposition-controlled House of Representatives struck a deal on a series of measures, mainly tax cuts and rebates, to quickly stimulate the sagging economy.

The plan, a rare agreement between the Republican president and the Democratic-controlled Congress, still needs approval in the Senate, where leaders said the plan may be discussed next week.

"This bill is important to the security of the United States of America, and the Congress needs to get a good bill to my desk as soon as possible," said Bush, speaking at a political event in this West
