ZIA BLACKOUT CAAB probe body finds nothing so far

The probe committee investigating the cause behind the two-hour blackout in Zia International Airport (ZIA) on Sunday is yet to throw light on the matter.

Meanwhile the Civil Aviation and Tourism Ministry yesterday formed another probe committee in addition to the probe committee formed by the Civil Aviation Authority of Bangladesh (CAAB).

Both the committees have been asked to submit reports within the next two days.

The unprecedented incident at ZIA brought the international airport to a virtual standstill on Sunday night, besides raising serious questions about security at the airport.

GOVT HOUSE SALE SC clears way to proceed with Abbas case

UNB, Dhaka

The Supreme Court yesterday stayed the High Court order that had stalled the proceedings of a graft case filed against detained former Housing and Public Works Minister Mirza Abbas on charges of selling 18 abandoned government houses on a fake auction.

Responding to an Anti-Corruption Commission (ACC) petition, a six-member bench of the Appellate Division passed the order, clearing the way for the prosecution to go ahead with the

Passing the order, the apex court also advised the parties to get the HC rule heard as soon as possible.

The ACC moved the petition, seeking permission to appeal against the January 2 High Court

The High court, following a writ petition, had stayed the further proceedings of the case and issued a rule upon the ACC in this regard. On March 29 last year, the ACC filed the case with Motifheel Police Station against Abbas, former commerce minister Amir Khasru Mahmud Chowdhury, Harris

Working under the National Committee to Combat Serious Crime and Corruption, the task force has decided to send the dossiers on 10 employees and 13 officials to the Anti-Corruption Commission (ACC) for further investigation. The decision came after those employees and officials

had denied the allegations brought

against them after probe. Of the 10 employees, meter reader Israfil Alam was a candidate in the 2001 election from Raninagar-Atrai while Azizul Haque Majumder, another meter reader, sought to contest the cancelled ninth parliamentary election from Noakhali-1 constituency.

Immediately after their deployment at Titas Bhaban on October 25 last year, the army-led task force against corruption took a number of measures to identify the corrupt officials and employees.

Govt eyes consensus on crucial issues

Plans to inspire political parties not to boycott JS, go for street confrontation

The caretaker government plans to forge an understanding among political parties on pre- and postelection situation for creating a conducive atmosphere for sustainable democracy free from the recent political culture of parliament boycott and street confronta-

Policymakers of the interim administration that is already working for holding the muchtalked-about dialogue with political parties contemplate having a consensus among the parties on crucial issues so that after the general election they (parties) go on with the reforms to strengthen Public Works Ghulam Quader

democracy, sources said.

At the talks with parties, the caretaker government might raise vital issues like the culture of parliament boycott, hartal and strike, making parliament effective by strengthening parliamentary bodies and continuing the anticorruption drive. It is likely to pursue the issues to make the parties announce their stances on

the issues, the sources added. "Dialogue with political parties should address not only postelection but also pre-election situation. If the country goes back to pre-1/11 (January 11 last year) situation, it will not be a good sign," Adviser for Housing and

yesterday said without specifying any issues relating to the postelection situation.

Talking to reporters at his office, the adviser to the military-backed caretaker government categorically said the issues should be resolved if the dialogue with political parties is to succeed.

Education Adviser Hossain Zillur Rahman yesterday said the caretaker government is making preparations for talks with parties. "We will announce the date for talks once preparations are complete," Zillur said, adding the government hopes it can make the talks fruitful.

BSMMU PRISON CELL

14 VIPs go back to jail in a week

At least 14 VIP inmates who are having treatment at Bangabandhu Sheikh Mujib Medical University (BSMMU) prison cell are to be moved back to jail within one week.

The BSMMU authorities will gradually discharge VIP prisoners who can have treatment in jail.

Jail and BSMMU authorities made the decision yesterday after allegations were made in connection with undue overstay of VIP inmates at the prison cell depriving other sick prisoners of their treatment facilities. Several meetings were also held before in this regard.

Sources said a number of the VIP prisoners at the prison cell have been carrying out their political and business activities and have also been meeting their relatives on

Jail sources said out of the 19VIP inmates at BSMMU prison cell, 14 are allegedly staying there even though they are not seriously sick. A number of the doctors also allegedly had a hand in their undue stay at the prison cell, the sources said.

Deputy Inspector General of Police (DIG-Prisons) Maj Shamsul Haider Siddique told The Daily Star, "We are hopeful that we will be able to move back the prisoners whose treatment is possible in jail.' "We have talked to the VC [vice-

chancellor of BSMMU and the doctors concerned about this," he said, adding, "The process of taking them gradually back to jail may start within three to four days."

Prof Mohammad Tahir, vicechancellor of BSMMU, told The Daily Star, "It is true that all 19 VIP prisoners are sick. But I have told doctors concerned to consider discharging those who can have treatment in jail." The VC said, "Most of the

inmates are suffering from various minor diseases, including blood pressure (high or low) and diabetes, which are not cent percent curable. Therefore, it is possible to continue their treatment keeping them in

Dhaka seeks int'l support to bring back siphoned off wealth

Bangladesh has sought support from the international community in bringing back the wealth of the country siphoned off overseas by corrupt people.

The appeal was made by the Bangladesh delegation at the second session of the Conference of the States Parties to the United Nations Convention Against Corruption (UNCAC) that kicked off in Indonesia's Bali resort island

Around 1,000 delegates from about 140 countries, eight state observers, seven UN agencies and other international organisations and 30 local and international nongovernmental organisations are attending the conference at the Bali International Convention Centre in Nusa Dua.

The meet aims to find ways for bringing back billions of dollars in assets stolen by corrupt political leaders throughout the world.

Coordinating Minister for Political, Law and Security Affairs of Indonesia, Widodo Adi Sutjipto, inaugurated the conference on behalf of President Susilo Bambang Yudhoyono.

Bird flu spreads for poor watch, awareness

Poor monitoring mechanism of the government, absence of awareness in poultry farms and cold weather might make it difficult to contain the H5N1 virus that causes Avian influenza, commonly referred to as bird flu.

Though the government maintains that bio security measures have been beefed up in poultry farms all over the country, in reality, correspondents of The Daily Star visiting a number of poultry farms in and around the capital found that the farms lack bio security and other precautionary measures.

Poultry farm workers at Rajashon in Savar are not provided with face masks or gloves for their protection. The farms do not have footbath at entry and exit points. Disinfectants are not used properly

"I didn't know that it's crucial to spray disinfectants two times a day. That's why I usually spray it every other week," said Liakat Ali, owner of a local poultry farm that is rearing 3,000 chickens.

"Even though my farm is registered [with the government], none of the government livestock officials came to me and asked me to improve the bio security system here," added Liakat.

Rajan, whose family owns Sharif Poultry Farm at Savar, said the government officials come to visit the farm only when they repeatedly inform them of sickness of the : chickens.
