#### Biting cold grips country

Thick layers of clouds shrouded most parts of the country's skies as cold winds coupled with drizzles yesterday wrought misery in people's lives across the country, especially in the northern region.

Though a pale wintry sun peeped through the clouds for some moments, many people chose to remain indoors to avoid the chilly weather. Outbreaks of cold diseases continued to spread pushing further up the number of patients at hospitals and clinics in the capital as well as other places.

The weathermen said the situation would improve today only to welcome first cold wave in this season.

"It happened due to conjugation of easterly trough and westerly low. A mild cold wave may occur when this situation is over," Samarendra Karmakar, the director of the met office, said.

The lowest temperature in the country was recorded at 8.7 degrees Celsius in Srimangal.

# Azam identifies Selim as only accused

He does not mention Hasina's name

Businessman Azam J Chowdhury, who sued former premier Sheikh Hasina for extorting Tk 2.99 crore, ultimately did not bring any allegation against her when the trial of the case began yesterday with his deposition.

Hasina's name appeared only twice in the deposition as Azam quoted his conversations with Sheikh Fazlul Karim Selim, the former premier's cousin and another accused in the case, while

#### Detention of Tarique, Hannan Shah illegal

Declares HC UNB, Dhaka

The High Court yesterday declared illegal the detention of Tarique Rahman, senior joint secretary general of the BNP, and Brig Gen (retd) ASM Hannan Shah, adviser to BNP Chairperson Khaleda Zia.

The High Court delivered the judgments after hearing two separate writs of habeas corpus that challenged the validity of the detention orders.

The division bench of Justice. Mirza Hussain Haider and Justice Mamnoon Rahman also asked the government to release Tarique and Hannan immediately, provided that they are not wanted by police in any other criminal cases.

#### Dhaka trashes Indian media claim

UNB, Dhaka

The government has brushed aside claims in Indian media that Bangladesh is the source of avian influenza that has ravaged poultry farms in West Bengal, saying the flu might have spread in the neighbouring country in other ways.

The Ministry of Foreign Affairs yesterday said, "The ministry would like to clarify that the outbreak of bird flu was officially reported by India as early as in 2006. This is the fourth recurrence of such an outbreak in India. The cases in Bangladesh, on the other hand, are sporadic in nature, and due to intensive surveillance, the situation has remained under control."

The decision to this effect was taken on Monday night after the two arch political rivals indicated unity between them at a Chittagong court earlier on the day, sources said.

Awami League (AL) leader Mohiuddin and BNP leader Mir Nsir were produced before Chittagong Divisional special Judge's court for hearing of a graft case against the mayor and a tax evasion case against the former state minister.

They were together while being brought to the court from Chittagong jail in the same prison van and appeared before the court at the same time.

#### Bribery charges pressed against ex-chairman of **BRTC** Taimur

The Anti-corruption Commission (ACC) yesterday pressed charges against detained former Bangladesh Road Transport Corporation (BRTC) chairman Advocate Taimur Alam Khondaker in two bribery cases filed with Paltan Police Station.

ACC Assistant Director Shafiqul Haq Siddiqui, also the investigation officer of the cases, submitted the charge sheets against the accused to the Chief Metropolitan Magistrate's Court, showing 14 people in each of the two cases as prosecution witnesses.

On August 14 last year, ACC Deputy Director Golam Mostofa filed the cases against the former BRTC boss under section 161 of Bangladesh Penal Code and under Resistance Act 1947.

## Less active ministries asked to return funds

In the backdrop of poor implementation of the Annual Development Programme (ADP), the Executive Committee of National Economic approval. Council (Ecnec) yesterday asked the low-performing ministries to surrender their funds to the planning ministry by February 7.

The Ecnec expressed dissatisfaction over only 21 percent implementation of the ADP in the first six months of the current fiscal year. It also directed the ministries to complete the tendering process for procurement before approval of the authorities concerned, a planning ministry official said.

The ministries that fail to implement the allocated money should inform the matter to the planning ministry, which will divert the money to other ministries in the percent implementation was revised budget in February, sources accomplished in the previous five

The directions came at the Ecnec meeting at the planning ministry chaired by Chief Adviser Fakhruddin Ahmed. He also directed the authorities concerned to prepare work schedules for The Implementation, completing the projects in time.

The chief adviser also instructed the advisers and the secretaries to continuously monitor the progress

Coming out of the meeting, Finance and Planning Adviser AB Mirza Azizul Islam said the large 10 ministries and divisions implemented 6 percent of their allocation in December, while only 16 months.

"I hope the rate of ADP implementation will be much more in the coming months," he told jour-

#### Provocation of foreign body, labour leaders found in probe

Law enforcement agencies have confirmed that a foreign organisation and leaders of a section of garment workers were involved in provoking the recent unrest in garment factories in the city's Mirpur area.
