HASINA'S EXTORTION CASE Plaintiff now

accused in another case

Tajul Islam Farook who filed a Tk 3 crore extortion case against detained Awami League chief and former premier Sheikh Hasina in April last year is also accused in a

The case was filed for selling two luxurious vehicles he had bought taking loan from Bangladesh Finance and Investment Company (BFIC) breaching the deed of agreement and aiming at embezzling

Farook's wife Sultana Akhter was a guarantor of the loan and is also an accused.

BFIC Legal and Recovery Officer Emdad Ullah filed the case with Motijheel Police Station on January 21 under sections 420 (cheating), 406 (breach of trust) and 109 (abetment) of the Bangladesh Penal Code following recovery of one vehicle.

EC trails behind roadmap schedule

The reconstituted Election Commission (EC) completes one year of operation today but is yet to begin a few major tasks, including publication of the draft voter list and holding polls to different local government bodies within January as per its electoral roadmap.

The EC also could not complete some tasks that were supposed to be finished by this time. For instance, the dialogues with the political parties on electoral law reforms and institutional reforms were not held during September-November last year according to the EC roadmap.

CA talks to villagers about their problems

UNB, Mithapukur, Rangpur

Chief Adviser Fakhruddin Ahmed took a walkabout near Rangpur town yesterday, enquiring villagers about their everyday problems.

The chief adviser got out of his car at Baldipukur bus stoppage in Pairaband union on his way to Mithapukur upazila where he met a cross-section of the society.

Fakhruddin asked them about the prices of essentials in the area. The villagers told him that rice is selling at Tk 28 per kg and potato at Tk 10.

Farmers said they are facing scarcity of urea and potassium fertilisers. "If these are sold in the open market, it would be easier for us," said many of them.

The chief adviser, however, said open-market sale may increase fertiliser price, but the farmers maintained that they would at least be able to buy "without harassment."

Fakhruddin assured them that fertiliser would not be a problem as the government has taken adequate steps to supply it to the farmers on time.

Govt unveils plans for the North

UNB, Rangpur

The Council of Advisers at its first meeting here yesterday gave a nod to the caretaker government's 14point programme for the rapid socioeconomic development of the country's northern region, especially Rangpur.

The programmes include close and round-the-clock supervision for ensuring the Boro production in the coming season, formation of a committee headed by an adviser to resolve Monga problem, setting up of a full-fledged university in Rangpur, activating the airports of the region and taking measures to

export more manpower from there. The meeting was held at Rangpur Circuit House with Chief Adviser Fakhruddin Ahmed in the chair. The meeting started at about 12:00 noon and lasted for three

This was the first-ever meeting of the Council of Advisers held outside the capital. It was attended by all advisers, special assistants to

the chief adviser and secretaries concerned.

The programmes also include construction and maintenance of roads, railways, bridges and embankments, making Birol, Banglaband and Sonar Hat land ports functional, taking steps to increase employment and expand businesses, ensuring healthcare services and expanding inland

tourism. Briefing reporters after the meeting, the chief adviser said the specific decisions were taken after detailed discussions and directives have been given accordingly.

Responding to a question, he said meetings of the Council of Advisers will be held in other districts of the country gradually.

About holding the meeting in Rangpur, the chief adviser said there are some regional issues that need to be dealt with regionally, otherwise these problems will remain unaddressed.

LINE REPAIR

Gas supply in city disrupted UNB, Dhaka

Titas Gas Transmission and Distribution Company Limited suspended gas supply to a major part of Dhaka city for 48 hours from last midnight for repairing the main gas-transmission line at Daudkandi in Comilla.

For suspension of gas supply, about a third of the capital city, particularly the southeastern part, is being directly affected as people of the area are looking for alternative sources of energy for cooking and other purposes.

The affected areas include Postagola, Zurain, Jatrabari, Dhalpur, Bibirbagicha, Gopibagh, Kamlapur, Khilgaon, Basabo, Shahjahanpur, Badda, Rampura, Ulan, Tejgaon Industrial area, Mohakhali, Gulshan, Nayatola, Madhubagh, Santinagar, Siddheswari, Motijheel, Wari, Gendaria, Nawabpur, Sadarghat, Sutrapur, Banglabazar, Bakshibazar, Islampur, Hazaribagh and Azimpur.

Apart from the city areas, gas supply in some adjoining areas, including Sonargaon, Meghnaghat and Rupganj in Narayanganj, Gazaria in Munshiganj, Daudkandi, Homna and Titas in Commilla, and Banchharampur and Kachua in Chandpur came to a halt.

Release Hasina to make polls credible

Zillur asks govt

Acting Awami League (AL) President Zillur Rahman yesterday demanded immediate release of all political detainees, including party chief Sheikh Hasina, to make the next parliamentary polls credible. "We're demanding release of all

political detainees, including our great leader Sheikh Hasina immediately. We want to see a free, fair and credible parliamentary election," Zillur said.

The acting AL chief was addressing a press conference at the party's Dhanmondi office in the morning.

AL Relief Committee for Sidr victims, led by party presidium member Abdur Razzak, arranged the press conference to present statistics on relief materials, including cash, distributed by the party among Sidr victims in the country's southwestern districts.

Zillur also urged the caretaker government to lift the state of emergency soon, saying their fight for democracy will continue until their demands are met.

He thanked the AL leaders and activists both at home and abroad for their outstanding efforts to help the Sidr affected people.

Prime suspect's aide held in city

A close associate of Indian national Jibon Singh, a prime suspect in stealing the Nobel Prize medal of poet Rabindranath Tagore, was arrested at Azimpur in the city early yesterday.

A team of Criminal Investigation Department (CID), led by Additional Superintendent of Police Abdullah Aref, caught Mohammad Hossain Shiplu after a three-hour sweeping raid in the area. CID sources said they had infor-

mation that Jibon Singh is hiding in
