Anti-graft drive, reform to go on if AL voted to power

Detained former prime minister and Awami League (AL) chief Sheikh Hasina yesterday said if her party forms the government, reforms and the ongoing drive against corruption would continue uninterrupted as per the law.

Acting Awami League President Zillur Rahman quoting Hasina told this to journalists on the Jatiya Sangsad Bhaban premises after having an hour-long meeting with her at the sub-jail.

A special court gave 10 defence lawyers the permission to meet Hasina at the sub jail. The same court had fixed Thursday for the hearing on charge framing in the Tk 3-crore barge-mount graft case filed against her.

"If Awami League assumes power, the drive against corruption will continue as per the law while reforms will go on and remain uninterrupted," Zillur, also Hasina's lawyer, quoted Hasina as saying.

EC to talk atmosphere for city polls with CA

Lifting or relaxing emergency to feature high on today's talk

The Election Commission (EC) is scheduled to meet Chief Adviser Fakhruddin Ahmed today to discuss creation of an environment conducive to holding the due polls to five city corporations in April, under the emergency regime.

Over the last few months the chief election commissioner (CEC) has been saying that the state of emergency either has to be lifted or relaxed to hold credible elections through allowing electoral candidates to hold election campaigns.

In the electoral roadmap announced on July 15 last year, the EC had promised to begin holding the due polls to different local government bodies in January this year, but by the end of the year the commission changed the promise by saying it will hold the polls to the five city corporations in April instead

CEC ATM Shamsul Huda yesterday talked to the chief adviser over the phone and sought an appointment to meet him. The chief adviser gave the commission an afternoon appointment to meet him in his office.

The full panel of the EC including two other election commissioners Muhammed Sohul Hussain and Brig Gen (retd) M Sakhawat Hussain will also sit in a meeting this morning to discuss holding the polls to the city corporations of Dhaka, Rajshahi, Khulna, Sylhet and Barisal, and also to discuss its draft protocol for appointing election commissioners, sources said.

Asked whether the EC will discuss holding of polls to city corporations, CEC Huda said in fact there is no fixed agenda for the meeting where everything might be discussed.

"We will inform the chief adviser about the progress in the last one

year of the preparations for holding

the parliamentary election," Huda, who was appointed as the CEC on February 4 last year, told The Daily Star last evening.

He said they will meet the president and the chief adviser from time to time to apprise them of the progress of EC's work.

"We will also apprise the chief adviser about the difficulties we are facing in carrying out our duties," Huda said.

Replying to a query, the CEC said they might also discuss with the chief adviser their proposals drafted for setting up some criteria for appointing election commis-

Besides, the EC will discuss the draft ordinance which was recently approved by the cabinet to free the EC Secretariat from the control of the Prime Minister's Office (PMO).

Recent newspaper reports said another 130 officials and employees of Titas Gas are ready to return to him. wealth worth over Tk 400 crore.

In his wealth statement, Mollah, whose name is on the list of corrup-

tion suspects, told the NCC taskforce of having wealth worth Tk 208 crore. But according to the taskforce, it would not be less than Tk 2,100 crore.

Kader Mollah even boasts about his business acumen: "Do you think I have stolen this money? This money comes from my business," he told reporters.

He claimed that he owns only five industries as "only the running industries should be counted".

The taskforce will send Mollah's wealth statement to the Anti-Corruption Commission.

Kader Mollah joined Titas Gas as an ordinary employee in 1985 and retired voluntarily after 12 years as a sales assistant. During his service at Titas, he developed good relationship with a BNP-backed CBA (collective bargaining agent) leader and ended up as a close aide

GAS LINE REPAIR

Low pressure in CNG stations, household stoves

Suspension of gas supply from Saturday midnight hampered the city life, mostly in the southern parts, with low pressure of gas in the household stoves and CNG refuelling stations.

Titas Gas Transmission and Distribution Company Limited suspended the supply to a major part of the metropolis for 48 hours for repairing the faulty main gastransmission line. Repair of the line began at 7:30am yesterday at Daudkandi in Comilla.

Since early morning, city dwellers found the gas pressure was zero in some places or so low that they could not cook during the whole day, while many of the CNG (compressed natural gas) refuelling

stations were forced to shut down. Regular commuters, specially the office goers, faced trouble in finding vehicles while many passengers alleged that the drivers of CNG-run three-wheelers charged high fares showing long wait in refuelling stations as cause.

Meanwhile, panic gripped the housewives on Saturday evening as they frantically made arrangements to cook the next two days'

GRAFT CASE AGAINST HASINA

Charge-framing hearing deferred to Thursday

Three days into the beginning of detained former premier Sheikh Hasina's trial in an extortion case, she was produced before a special court yesterday for arraignment in connection with a Tk 3 crore graft case, but the court rescheduled the hearing for Thursday.

The hearing was rescheduled after the defence had petitioned for more time to examine the case documents.

Awami League (AL) President Hasina is facing four cases on different charges, which were filed after the present military backed caretaker government had assumed power and embarked on an anti-graft drive targeting high profile graft suspects.



Camp yesterday said he would welcome withdrawal of the ban on indoor politics outside Dhaka and reiterated US backing for this caretaker government.


He also said the US has certain concerns about the situation in Bangladesh but refused to share them with reporters, saying he would express the concerns directly to the government.
