> The EC on January 21 sent a draft of the rules to the law ministry for vetting, requesting the ministry to take necessary steps as soon as possible, but the ministry had yet to return the draft to the commission till vesterday, sources said.

> Officials in the EC Secretariat said they communicated with the law ministry last week to know the status of the draft that had been

Once the contents of the draft electoral rolls rules is thoroughly scrutinised, the EC will make it into a law, exercising a power which was vested upon it in August last.



Manju wants to return home, surrender

to court

Jatiya Party (JP) Chairman Anwar Hossain Manju, now in the USA, wants to return home soon, surrender to the court and join politics.

"I was not supposed to come to US. I've come to take refuge here. Insha-Allah, I will return home soon," he told the news agency over phone from Washington.

Replying to a question about his five-year conviction for possessing wine, Manju said he will surrender to the court, seek bail and move petition for quashing the case.

He left the country after the imposition of the state of emergency on January 11 last year and was tried in absentia.

Wilting in jail, he waits 15yrs for trial

Ali Hussain Allya, 62, has been languishing in jail for long 15 years without conviction in a murder case while all his coaccused have been freed on bail.

"I want immediate trial of the case. If my husband is found guilty then he should be punished. But if he is not ... I want the 15 years of his life back," demands Rokeya Khatun,

Allya's wife, urging all to make

arrangements for her husband's release since the case remains stayed for 12 years due to a High Court order.

He was 47 when he was arrested in August 5, 1992 in connection with a murder case but failed to obtain bail since he is poor and could not afford legal assistance.

Allya, son of Askar Ali of Chhaysri of Chunarughat upazila in Habiganj, was arrested along with 10 other

Submarine cable restored in Egypt

After nine days of disruption, Submarine Cable SEA-ME-WE4 that was severed onthe Egyptian coast was restored yesterday, completely restoring the country's heart-line of international telecom and Internet communications.

According to Bangladesh Telegraph and Telephone Board (BTTB), the cable was fully restored at 6 am yesterday -- enabling all types of data transfer.

Since the cable snapped on January 3 -- digital data transmission with the westward countries via Italy and France has been disrupted. However digital communication with Singapore and Malaysia was fully operational.

As bulk of the data transmission from the country relies on connectivity with Italy and France, BTTB was providing an alternative satellite support for telecom services while the Internet Service Providers were giving backup services using VSATs.

As a result, data communication was very slow.

Outlaw killed in 'shootout'

A member of Purbo Banglar Communist Party (PBCP-ML), an outlawed outfit, was killed yesterday in a shootout between law enforcers and his cohorts at Bijnagar village in Kushtia.

The dead was identified as Akbar Ali, 51, son of late Mafizur Rahman of Naodapara in Mirpur upazila.

Police said acting on a tip-off, they cordoned off a banana orchard at Bijnagar village of Mirpur upazila where members of the outlawed outfit were holding a secret meeting at about 10:30am.

Sensing the presence of the law enforcers, the outlaws fired on the policemen, prompting them to retaliate.



Osama bin Laden and Mullah Mohammad Omar are hiding in Pakistan with their top commanders, a senior US administration official says -- a charge vehemently denied by Pakistani officials. The US official, speaking on

condition of anonymity, said Friday that their presence poses a "huge challenge" to the security of both Pakistan and neighbouring Afghanistan. "There is no question that the iconic leaders of al-Qaeda

(Ayman al-) Zawahiri, bin Laden . are in the tribal areas of Pakistan, the senior official told reporters at a media briefing in Washington. "We believe that the Taliban's shura (consultation) council leaders led by Mullah Omar reside in

Quetta in Pakistan," he said, referring to the capital of rugged Baluchistan province bordering Afghanistan. The sanctuaries were not only helping Taliban fight the insurgency against Afghan President
