Galloping house rent makes tenants' life a misery

* Low and middle income groups bear the brunt as rentals double in 17 years

Taslima Alam (not real name), 32, and her three children live in a two-room flat at East Badda, said she is facing eviction as she cannot afford to pay the monthly rent that her landlord had suddenly increased -- from Tk 4,000 to Tk 6,500.

Her rent was paid through a teaching job in a nearby school and the occasional endowment sent by her husband, a con-Arabia as.

Mozaffar Hossain, a resident of Mohakhali, recently received a notice from his landlord that his monthly rental would go up starting from the next month.

"He [landlord] asked me to pay Tk 8,000 in place of Tk 6,000 from February," said Mozaffar. "He told me that he is charging all the other tenants Tk 8,500, but since I have been residing in the flat for quite some time, I would have to pay Tk 8,000 -notTk8,500."

"This is outrageous. Not only did they raise the rental by a A million people who live in quarter without any prior notice, they are charging the tenants as much as they please," he added.

A recent study conducted by Consumers Association of

Bangladesh (CAB) shows that house rentals in Dhaka have more than doubled (249.62 percent) in the last 17 years. The increase was around 17 percent in 2007 and 16 percent in 2006. The rentals in Dhaka witnessed a jump in 1991 by over 23 percent and it continued the trend later on, finds the study.

Tenants who are from upper middle, middle, lower middle and lower income groups are the worst victims of the rising trend of house rentals. This section of the population spends nearly 50 percent of their monthly incomes in house rentals alone.

Laments son of language martyr Abdul Jabbar

Language Martyr Abdul Jabbar's son, M Nurul Islam Badal, has lamented that till date little has been done to remember and respect the memories of his father.

"The Language Movement was the seed of the Liberation War. Had there been no Language Movement, there wouldn't be any war. The Language Movement clearly delineated that the Bangalees and the Pakistanis are two different nations. But how much do we know about them [language martyrs]?" Badal, who is also a martyrs. freedom fighter, told this correspondent, last week.

Nearly 60 years have gone since the Language Movement -a struggle that inspired the independence movement -- took place, but the nation is yet to

language martyrs, observed a historian.

"As yet, little is known about the lives of the language martyrs. More research should have been done on the history of the language movement. But it is time we shed more light on it," said Dr Sharifuddin Ahmed, professor, Department of History, Dhaka University (DU).

Junaid Murshid, 26, a service holder residing at Uttara, said, "All I know about them are their names." He also said he does not know any place where he can learn details about the language

"A museum and a library is being built in Jabbar's name at Gafargaon [the martyr's birthplace], but none of us lives there now. All of his relatives now live in Haluaghat thana," Badal said.

The DC however proposed Gafargaon [as the site of the museum and the library]," Badal went on saying, "A meeting was held with families of language martyrs, but we came to know about the meeting from newspapers. BRIDGE OVER GULSHAN-BANANI LAKE

Legal battle likely alleging lack of environmental clearance

The LGRD ministry's project to build a bridge across Gulshan-Banani Lake may face a legal battle as environmentalist groups and locals are planning to file a writ petition against the project for "not having environmental clearance and impact assessment."

they have decided to go for public interest litigation (PIL) jointly with Paribesh Bachao Andolon (PBA) against the project.

Though the government declared the lake an 'ecologically critical area' in 2001, the project has been undertaken without carrying out environmental impact assessment and clearance, said Abu Naser Khan, chairman of PBA, an environmentalist group.

However, LGED officials claimed that they have done such assessment.

A legal notice has recently been served upon the authorities concerned asking for explanation within seven days on whether they have complied with all the technical and environmental prerequisites for the project, Fazlur said.

The Local Government, Rural Development and Cooperatives ministry has undertaken the Tk 12.47-crore project to build a 90 metres long bridge across the lake.

Engineering Department (LGED) will implement it.

Locals fear that land filling in the Gulshan Lake for building the bridge will virtually destroy the water body and encourage the land grabbers. While environmental

experts alleged that the project has been undertaken without Vice-president of Gulshan environmental clearance or ance." Society Fazlur Rahman said impact assessment, transport experts said there has been no detailed engineering analysis for construction of the bridge.

> According to the legal notice served jointly by Gulshan Society and Paribesh Bachao Andolon, the project is required to obtain environmental clearance certificate as per section 12 of the Environmental Conservation Act of 1995.

that in accordance with rule 7(6) of the Environmental Conservation Rules (ECR) required to carry out a prior Viability Assessment Report, an Initial Environmental Examination and an Environmental Management Plan, for the project.

Bangladesh Environmental Lawyers Association (Bela) on November 26 wrote a letter to the LGED asking whether they have obtained environmental clearance or carried out any environmental impact assessment for construction of the bridge. But the project authorities did not make any response to the query.
