Ex-PMO official gets 3 yrs for receiving bribes

BSS, Dhaka

A special court vesterday sentenced former administrative officer of Prime Minister's Office (PMO) MM Ahsan Habib to three years' rigorous imprisonment and the owner of Bengal Consultant, Ahmed Mirza Khabir, to two years' rigorous imprisonment in a bribery case.

Judge of the Special Court-1 in Sangsad Bhaban area M Firoj Alam handed down the verdict to the two convicts. Both of them were tried in absentia.

The court also fined former PMO official Habib Tk 95 lakh. If he fails to pay, he will have to serve three more months in jail.

Anti-Corruption Commission (ACC) official Shamsul Alam filed the case against them with Motijheel Police Station on April 2 last year.

According to the prosecution, Habib received a bribe of Tk 93.50 lakh through his friend Ahmed Mirza Khabir from the proprietor of Munshi and Monty Traders, Afzal Hossain, to help him get cigarettes, seized by the customs department, at auction.

2318 cans of soybean, mustard oil seized

Accomplice of Indian kidney snatcher surrenders

The suspected accomplice of an Indian doctor arrested over a massive illegal kidney transplant racket surrendered to police yesterday, officials said.

Saraj Kumar was one of several people wanted for helping Amit Kumar, who was arrested in Nepal last week. The suspect "surrendered to the Gurgaon police Monday afternoon," said a Delhi police official who wished to remain anonymous.

He is due to be produced in court in Gurgaon, a wealthy New Delhi suburb, on Tuesday where investigators will seek an extension of custody, the officer said.

Meanwhile, officers of the Central Bureau of Investigation (CBI) continued questioning Amit Kumar for the third successive day Monday, a spokesman for the agency said.

Kumar, the subject of an Interpol alert, was nabbed by Nepalese police at a hotel in the country's south on Thursday. He was flown to

New Delhi late Saturday. Dubbed "Doctor Kidney" or "Doctor Horror" by the Indian press, Kumar allegedly lured or forced hundreds of poor into giving

up their kidneys. He made millions of dollars by selling the organs to wealthy Indians and foreigners for trans-

plants, police believe. The CBI has charged him with causing grievous hurt with a weapon, wrongful confinement and fraud, the spokesman said. According to the Press Trust of India, he faces up to 10 years behind bars.


