The miscreants sent four letters on September 30, 2005. to the victim's father demanding Tk 5 lakh ransom for his release.

On May 29, the victim's father filed a case with Shyamnagar police station.

Later, local people detected Basu Dev Haldar of the same village to be sender of the letters. They caught and handed him over to Shyamnagar

But police released him and were allegedly trying to divert the case and destroy its merit, sources claimed earlier.

Most criminals commit crimes within the knowledge of police or have links with them, Inspector General of Police (IGP) Nur Mohammad said here yesterday.

He was speaking at a ceremony marking laying foundation of Katiadi model police station.

IGP Nur Mohammad said, an instinctive fear about police prevails in the mind of people and it takes time to create such a fair. Police have to take the responsibility to remove the fear and earn people's confidence.

For this, police should behave as friend of people not of criminals, the IGP said.

Katiadi is the native upazila of Nur Mohammad. He also told the gathering at the ceremony that some local people told him about availability of drugs in the upazila but police denied it.

"Of course police know the drug traders and peddles and they have to stop the henous act".




