

CID allowed to quiz ex-OC Rafique

COURT CORRESPONDENT

A Dhaka court yesterday allowed the Criminal Investigation Department (CID) to interrogate AKM Rafigul Islam, the then officer-in-charge (OC) of Motijheel Police Station, at the jail gate in connection with the case for charging grenades at an Awami League (AL) rally on August 21, 2004.

Rafique, also an accused in a case for killing college student Kamrul Islam Momin on September 13, 2005, was sent to jail on October 16 after he surrendered before the court. He has been in jail custody since then.

Metropolitan Magistrate Ehsanul Haque passed the order after CID Assistant Superintendent of Police (ASP) Fazlul Kabir, also the investigation officer (IO) of the case, submitted a petition for interrogating Rafique.

In his petition, the IO mentioned that Rafique should be grilled about the grenade attack on the AL rally for the sake of proper investigation.

Govt to set up nat'l ID registration authority

Promulgating ordinance for its formation, responsibilities

The government is going to form a statutory body styled 'National Identities Registration Authority (NIRA)' to give legal coverage to Election Commission's national ID card and voter registration project.

The government is also promulgating an ordinance incorporating NIRA's formation process, its duties for issuing national ID cards, and conviction provision for wrongdoings by citizens in this regard.

empower the home ministry to direct citizens to show their ID cards and submit copies to obtain certain services and facilities as citizens of the country, said law ministry sources.

showed or copies be submitted to obtain at least 18 facilities and services from public and private

sector including utility and financial services, and for business, transportation, property, voting right and jobs.

The sources said the draft ordinance would incorporate a special provision to bring the already distributed ID cards under NIRA's jurisdiction.

With the objective of national identities registration, EC would hand over its collected information, data and biometric features to NIRA. The citizens' info and data The proposed ordinance will would be considered as the property of the proposed statutory body, according to the draft.

> The law ministry has recently prepared the draft in nine chapters which will be sent to EC soon.

Following approval by EC and National ID card will have to be then by the advisory council, President Iajuddin Ahmed will promulgate the ordinance, said ministry sources.

The sources said though the commission has launched the project of preparing and issuing national ID cards there is no law in the country in this regard.

As the military-backed caretaker government has initiated formulating a law, in absence of parliament it will be enacted by promulgating 'National Identities Registration Authority Ordinance,

After promulgation of the ordinance the government will set up NIRA comprising a chairman and no more than four members through issuing a gazette notifica-The home ministry will appoint

chairman and members to NIRA and also fix terms and conditions of their job.

BUILDING DESIGN FRAUD

Janakantha editor, Rajuk official jailed

A special court for dealing with graft cases yesterday sentenced editor of the daily Janakantha Atiqullah Khan Masud to seven years rigorous imprisonment (RI) on charge of getting approval of a building design from Rajuk through fraud.

Special Court-6 of Tanzeena Ismail delivered the verdict in which Rajdhani Unnayan Kartripakkha (Rajuk) official SM Asaduzzaman was also awarded seven years' RI in the case.

In addition, the two were fined Tk 6.03 crore each. They would have to serve an additional year in jail if they fail to pay the amount.

ACC deputy assistant director Mahmud Hasan filed the case with Motijheel Police Station on September 30, 2007 accusing three persons. The name of Akram Hossain, another Rajuk employee, was later dropped in the charge sheet.



Additional Chief Metropolitan Magistrate Golam Rabbani passed the order after investigating officer ACC Assistant Director Ashraful Islam submitted a petition to interrogate Salman.

Bangladesh transit route for heroin trafficking

Says International Narcotics Control Board

Bangladesh has become the prime transit route for trafficking heroin to Europe from South East Asia, according to the latest report from the International Narcotics Control Board (INCB).

"There is evidence that heroin consignments destined for Europe are increasingly passing through Bangladesh," states INCB's annual report 2007, that was released worldwide on Wednesday.

"The geographical nature of Bangladesh, in particular its long borders with India and Myanmar,

makes it particularly suitable for heroin trafficking," the report adds.

INCB notes that the most common methods and routes for smuggling heroin into Bangladesh are -by courier from Pakistan, by commercial vehicles and trains from India and by sea via the Bay of Bengal or overland by truck or public transport from Myanmar.

An independent and quasijudicial monitoring body which implements UN Drug-related conventions, INCB also blamed a lack of resources and training of law enforcement agencies for Bangladesh's failure to 'properly

implement' its drug control policy. The report quotes Bangladesh police as saying that the

Chittagong seaport is the 'main exit point for drugs leaving the country', while the rest is smuggled out through Sylhet and Chittagong airports. It also cites press reports of

couriers trying to carry heroin to Europe on their way from Pakistan through the Zia International Airport in Dhaka.

The report observed that the use of Bangladeshi courier services for drug trafficking is on the rise, SEE PAGE 15 COL 8

The party of slain opposition leader Benazir Bhutto delayed nominating Pakistan's next prime minister yesterday, casting the nucleararmed nation deeper into political limbo after elections.

The Pakistan People's Party, which won the most seats in the February 18 parliamentary polls, failed to agree on a candidate because of discord over the frontrunner Makhdoom Amin Fahim, a stalwart Benazir aide, party officials said.

The delay comes amid mounting uncertainty over how the new premier and his government will handle key US ally President Pervez Musharraf, whose allies were trounced by the PPP and the party of ex-PM Nawaz Sharif. "It is up to the party leadership


