### Iraq suicide attack kills 4 policemen

AFP, Mosul

A suicide bomber blew himself up near a police station in northern Iraq on Friday and killed four policemen, a day after at least 63 people were slaughtered in a twin attack in Baghdad.

The bomber attacked the Al-Waqhas police station in the Ras al-Jadha neighbourhood of Mosul at around 7:00 am (0400 GMT), police officials said.

Four policemen were killed and 17 others, including 15 policemen, were wounded in an attack that once again highlighted the danger Iraqi security forces face.

"We have received bodies of four policemen killed," doctor Ghanim Ahmed at the Mosul general hospital told AFP.

Another medic there confirmed admitting 15 wounded policemen.

A police officer said the targeted neighbourhood housed several government offices, including one belonging to the interior ministry.

The US military claims Mosul to be the last urban bastion of the Iraqi branch of Al-Qaeda and is involved in a massive operation there.

### Police arrest relatives of Israel attacker

Israeli police early yesterday arrested more than 10 relatives and friends of a Palestinian suspected of gunning down eight students at a Jewish religious school, witnesses

Police have only said that the man suspected of entering the Merkaz Harav Yeshiva in predominantly west Jerusalem late Thursday and opening fire with an automatic rifle came from the Jabal al-Mukaber area of east Jerusalem.

But relatives of Alaa Hisham Abu Dheim, 25, said police informed them that he was the author of the attack that killed eight veshiva students and wounded anothernine.

Dheim's father, who was among those detained, was released hours later, they said.

Police declined to comment, with spokesman Micky Rosenfeld -saying only that "a car directly linked to the terrorist" was found in Jerusalem and that "an investigation is continuing."

Immediately after the attack on Thursday, police said that the suspect -- who was killed by security forces -- was known to Israeli security services.

# Israel on alert, seals US raises security off West Bank

AFP, Jerusalem

Israel went on alert on Friday as crowds mourned eight teens killed by a Palestinian at a Jewish religious school in Jerusalem in an attack that threatened efforts to mend faltering peace talks.

Police arrested more than 10 relatives and friends of the 25-yearold man, a resident of occupied east Jerusalem, who sprayed automatic gunfire at the students before being gunned down by security forces late on Thursday.

The army sealed off the occupied West Bank and Israeli police declared a "general state of alert."

"We have imposed a strict closure on Judea and Samaria (West Bank) until Saturday night," a spokeswoman told AFP. Israel's main ally, US President

George W. Bush, led a global chorus of outrage, but the UN Security Council failed to agree on a condemnation amid Libyan opposition. Eight students -- most of them

15 or 16 years old -- were shot dead at the Merkaz Harav Yeshiva, a theological school in predominantly Jewish west Jerusalem. Another nine were wounded.

The school is considered the centre of Israeli religious nationalism, where the Gush Emunim (Bloc of the Faith) settler movement was

born after the 1967 Six Day War. Police identified the gunman as Alaa Hisham Abu Dheim, 25, of the

Authorities fearing alleged Syrian links with terrorism are increasing security for ships sailing into US ports after making calls in Syria, an official said, as Washington raised pressure on Damascus.

The new measures come after Washington deployed warships near Syria in the eastern Mediterranean, stepped up sanctions on Syria and blacklisted men who allegedly used Syria to aid Al-Qaeda operations in Iraq.

State Department deputy spokesman Tom Casey said Syria was placed on a so-called "Port Security Advisory List" because of "concerns about the connections between Syria and international terrorist organizations."

### Merchant of Death' held In Thailand

A Russian dubbed the "Merchant of Death" for allegedly supplying weapons to Africa's bloody conflicts over power and diamonds was arrested Thursday in Thailand on suspicion of conspiring to smuggle guns to Colombia's leftist

Viktor Bout, 41, whose dealings reportedly inspired a 2005 movie about the illicit arms trade.

The U.S. is seeking Bout's extradition, but he will remain in Thailand pending an investigation into whether he used the Southeast Asian nation as a base to negotiate arms deals, officials said yesterday.

### UN HR chief to step down

The United Nations high commissioner for human rights, Canadian jurist Louise Arbour, said Friday she will step down when her current term in office expires on June 30.

"It is very much for personal reasons. I'm not prepared to make this commitment for another four years," said Arbour in Geneva.

Arbour, 61, a former chief prosecutor of the UN war crimes tribunal in The Hague, has been at odds with several UN member states, notably in the developing world, for her tough stance on their human rights records.

### Man shot dead ahead of polls in Spain

A Socialist former legislator was shot dead in Spain's northern Basque region yesterday, the regional government said, two days before the country holds general elections.

The former town councillor and member of Spain's ruling Socialist Party was shot in the Basque town of Mondragon, a spokesman for the Basque interior ministry told

"We have just confirmed that the person who died was a former Socialist town councillor in the town of Mondragon," the spokesman said.

# Obama friend, fundraiser on trial for corruption

A long-time friend and fundraiser of presidential hopeful Barack Obama was accused by prosecutors Thursday of using his political clout to carry out a kickback scheme aimed at extorting millions from firms trying to do business with the state of Illinois.

While Obama is not accused of any wrongdoing and has subsequently donated all the money raised by influence-peddler Antoin "Tony" Rezko to charity, prosecutors have alleged that some of the kickbacks ended up in the Illinois Democratic senator's campaign coffers.

Obama is also under fire for entering a land deal with Rezko in 2005 when it was widely known that the real estate developer was under federal scrutiny, something Obama later called a "boneheaded" move.

The Rezko dealings will likely dog Obama as he vies for the Democratic presidential nomination.

The trial in a Chicago federal courtroom is expected to last months and Obama's name came up on day one, when the defense noted in opening statements that Rezko had not only raised money for the charismatic politician, but had tried to hire Obama while he was still studying at Harvard law. "Of all the politicians he sup-

ported, not one of them will come here and say he asked for anything for himself," defense attorney Joseph Duffy said as he argued that the Syrian-born businessman's fundraising stemmed from a passion for politics rather than selfinterest.

It is unlikely that Obama will be called to testify on his friend's behalf, Duffy told reporters.

"I can assure you he's not been subpoenaed by the defense," he said. "There's no intention to do

Prosecutors, however, have stayed mum on their potential witness list.

They argued Rezko used his influence as a top fundraiser for Democratic Illinois Governor Rod Blagojevich to get friends and associates appointed to key state

"Rezko was the man behind the curtains, pulling the strings, assistant US attorney Carrie Hamilton told the jury.

"Rezko had the clout to get people on board and off boards," she said. "He was willing to use this

clout for cash." Rezko used his influence on one

such board to get a controversial hospital project approved in exchange for a share of a million dollar kickback from a construction company, she alleged.

### Obama breaks fundraising records

Democratic White House contender Barack Obama demolished fundraising records with a February haul of 55 million dollars, his campaign said Thursday.

The total obliterated rival Hillary Clinton's fundraising figure last month of 35 million dollars, and easily topped Obama's own previous record of more than 32 million posted in January.

"No campaign has ever raised this much in a single month in the history of presidential primaries," the Illinois senator said in an email to

supporters. "But more important than the total is how we did it," he said, noting that more than 90 percent of the donations were 100 dollars or less, and the campaign in February passed the milestone of one million contributors in all.


