The ordinance lays out some rules and regulations to ensure giving higher allocations to areas transparency in government expenditure. It imposes legal bindings on how the government borrows from local or international financiers, frames macroeconomic policies and mentions do's and don'ts in public expendi-

> It dictates that the government increase. borrowing from internal resources

should remain within two percent of the country's GDP. The government should also try to avoid taking loans from the central bank.

The government should not take hard-term loans, including supplier's credit or non concessionary loans, exceeding one percent of the GDP.

The government should also not exceed its annual borrowing target--except in case of national security and natural disaster. In cases of exceptions, the finance minister will explain to the parliament why borrowing had to

Term of Speedy Trial Act gets 2yr extension

UNB, Dhaka

The Council of Advisers yesterday extended the term of the Speedy Trial Act for another two years, amending the tough law meant for effectively dealing with serious crimes.

A meeting of the council, with Chief Adviser Fakhruddin Ahmed in the chair, approved the home ministry's proposal for extending the duration of the law by endorsing the Law and Order Disruption Crimes (Speedy Trial) (Amendment) Ordinance 2008.

The Speedy Trial Act 2002 was formulated to ensure quick trial of serious crimes like extortion, obstruction to transport movement, damage to vehicles, destruction of movable and immovable property, snatching, creating the reign of terror and anarchic situation, and tender hooliganism.

The law was enforced on April 10, 2002 primarily for two years. The duration of the law was extended for another two years in 2004 while in 2006 it was given another two-year extension.

There is still no visible move to bridge the rising differences between the government and political parties over holding local government elections before parliamentary polls that has triggered a fresh spell of uncertainty about the immediate political scene.

the latter cannot blame it," former adviser Maj Gen (retd) Moinul Hossain Chowdhury said.

"There might be some uneasitinue opposing holding local government elections before parliamentary polls. So, issues should not arise that might obstruct holding of the parliamentary elections

Echoing the view, former adviser M Hafizuddin Khan said had the caretaker government opened the dialogue in January, things could have been better now.

"It might lead to an alarming situation if the political parties continue opposing the local government polls and the government moves for holding them despite the objections," he said.

The army headquarters yesterday termed false and fabricated some newspaper reports and editorial that the army chief of staff during his India visit had stated that Bangladesh would show respects to the martyred Indian soldiers of 1971 on March 25 every year.

"As a matter of fact, during his India visit, the army chief didn't make any such statement formally or informally," said an ISPR release.

It said that at different meetings during the visit, apart from entourage of the army chief, the Bangladesh high commissioner to India was present.

"During the meeting of the two army chiefs, the Bangladesh army chief recalled with respect India's cooperation and sacrifice during the Liberation War and expressed his gratitude," the release said.

The theme of this year's Women's Day is "Investing in Women and Girls". Women and Children Affairs

Adviser Rasheda K Chowdhury presided over the function. Women and Children Affairs Secretary Begum Rokeya Sultana also spoke on the occasion. At the function, the CA formally

unveiled the cover page of National Women Development Policy 2008 that suggested setting aside onethird of parliamentary seats for women and arranging direct election to the reserved seats.

It also suggested appointment

of an adequate number of women, if necessary, under the related section of the constitution to the highest-level of Cabinet Division and the policy-making level of the administration.

On health and nutrition part, it called for formulating and implementing a law for providing maternity leave to working women for five months. The CA said, "The country

needs to think about such a social structure where women will get the full opportunity to express and show their capabilities and efficiencies.

"For this, it's necessary to change social attitude towards women first. If we can build a liberal and real democratic system through combined efforts then certainly there will be a remarkable and acting secretary general. change in Bangladesh's women sector," he told the function.

Advisers, diplomats, noted personalities, senior civil and military officials and women and girls were present at the function.

10hr outage at 4 city hospitals

Four major hospitals in the city experienced severe power outage for around 10 hours yesterday due to technical glitch, causing an ordeal to patients.

Dhaka Shishu Hospital, Shaheed Suhrawardy Hospital, the National Institute of Traumatic Orthopaedics and Rehabilitation (NITOR) and the National Institute of Cardio Vascular Diseases (NICVD), all in Sher-e-Bangla Nagar, faced the power outage.

A top official from Dhaka Electric Supply Authority (Desa) said the power went off around 7:00am due to a fault in an 11KV feeder line.
