ROW OVER EC INVITE Dr Kamal against settling political disputes in HC

Sticking to his guns against maintainability of the writ petition of detained BNP Chairperson Khaleda Zia, eminent jurist Dr Kamal Hossain, counsel for the Election Commission, yesterday said that in exercise of its power under writ jurisdiction the High Court cannot embark on resolving a political question.

The rule hearing of the writ on the impugned action of the Election Commission before the High Court bench of Justice Mirza Hussain Haider and Justice Mamnoon Rahman remained inconclusive for the seventh day yesterday, keeping the EC in anxious waiting with its plan of electoral dialogue with the BNP.

CA off to Dakar

Chief Adviser Fakhruddin Ahmed last night left for Dakar to attend the 11th summit of the Organisation of Islamic Conference (OIC) beginning in the Senegalese capital tomorrow.

A flight of the Emirates Airlines carrying the chief adviser and his entourage took off from Zia International Airport at 9:53pm.

The head of the caretaker government is leading a small delegation including Foreign Adviser Iftekhar Ahmed Chowdhury and Chief Adviser's Press Secretary Syed Fahim Munaim.

Finance Adviser Mirza Azizul Islam, LGRD Adviser Anwarul Iqbal, dean of diplomatic corps, chiefs of the three services and senior civil and military officials saw him off at the VVIP tarmac of the airport.

The chief adviser is scheduled to reach Dakar, via Dubai and London, at 6:05pm Senegalese time today.

Oil prices struck a record high of 109.72 dollars per barrel yesterday after the dollar hit a fresh all-time low against the euro and amid persistent energy supply concerns, traders said.

New York's main oil contract. light sweet crude for delivery in April, soared to the historic level, beating the previous peak of 108.21 dollar that was set on Monday.

Also on Tuesday, Brent North | the Indonesian island of Bali yes-Sea crude for April hit a record high 105.82 dollars on barrel, beating the prior high of 104.42 dollars touched on Monday.

In the foreign exchange market, the European single currency surged to a record high 1.5495

dollars. A weaker US currency tends to increase demand for dollardenominated oil as it becomes cheaper for buyers using stronger currencies.

Govt won't pass any anti-Islam law

Law adviser assures Ulema on nat'l women policy

STAFF CORRESPONDENT

The caretaker government has not passed any "law" regarding inheritance, Law Adviser AF Hassan Ariff yesterday said, adding that the National Women Development Policy, 2008 has been misinterpreted.

During a view exchange meeting with the Ulema (Islamic scholars) at Islamic Foundation in Baitul Mukarram, the adviser also said that the government has no plan to enact any law that goes against the rules and spirit of Islam.

"No such 'law' has been passed about inheritance and there is no question of enacting such a law," Hassan Ariff, also adviser to the religious affairs ministry, said

adding "it is really regretful as a situation of misunderstanding is created over a matter that does not exist at all."

The adviser held lack of communication for the wrong representation of the policy and stressed the need for enacting Right to Information Act to avoid any such confusion over government decision in future.

At the meeting, the Ulema urged the Muslims of the country not to act on any rumours or speech that is given by 'people or the media who usually talk against the spirit

ATTACK ON UK ENVOY

Zandal now drafted in charge sheets

The Criminal Investigation Department (CID) yesterday submitted supplementary charge sheets of two cases filed in connection with the grenade attack on the British high commissioner at the shrine of Hajrat Shahjalal (RA) in Sylhetin 2004.

Inspector Zobayer Ahmed of the CID filed the separate charge sheets with the Chief Judicial Magistrate's Court last evening accusing Hurkatul Jihad al Islami (Huji) leader Abu Zandal, also known as Mufti Mainuddin and Masum Billah Khaza, of delivering the grenades for the attack.

Zandal; son of Nurul Islam of Amdanga under Lohagara upazila

of Narail, is in a jail in the capital in another case. He was captured a few weeks ago in Dhaka and grenades were recovered from his possession.

Zobayer, the investigation officer, told The Daily Star that although charge sheets of the cases were submitted earlier, further investigation was carried out after the confessional statement of Huji leader Mufti Abdul Hannan, the prime accused.

During quizzing, Hannan admitted that Zandal provided the grenades through Huji operatives Sharif Shahedul Alam Bipul and Delwar Hossain Ripon, Zobayer added.


