The Additional District and Sessions Judge in Khulna Md STAFF CORRESPONDENT, Khulna Barekuzzaman has directed Jail Md Solaiman Ali and other concerned persons to show cause by April 6 for their failure to produce before the court two JMBmilitants on last March 10 for trial of a bomb blast case filed on August 17 in 2005.

The court has also asked the jail superintendent to appear before the court in person to reply why necessary legal action should not be taken against him for his failure to produce the two accused of the case -- JMB militants Shahidullah alias Lokman and Ruhul Quddus.

Khulna Jail Superintendent received the show case notice at 7:30pm on Tuesday from office of the Additional District and Sessions Judge.

It has been stated in the show cause notice that trial of this very important case has been delayed and hampered due to negligence and audacity of the jail superintendent as he failed to produce before the court two accused militants of outlawed JMB on March 10, says the show-cause notice.

1 lakh Sidr victims in Sharankhola still facing water crisis

Superintendent of Khulna district | Victims of cyclonic storm Sidr that hit the southern region of the country in mid-November last year, over one lakh people of Sharankhola upazila are still suffering from acute crisis of pure drinking water.

It is feared that the crisis will take an alarming turn in the coming summer due to lack of ponds having pure water, salinity and arsenic contamination. Ponds filled with filth and garbage during the Sidr are yet to be cleansed while the remote Sidr-hit villages are yet to get services of NGOs to purify the water. NGOs have not come forward to solve acute crisis of pure drinking water in the remote villages, said Abdul Majid of Dakkhin Rajapur village. He said about 40,000 people of Sidr-hit Dakkhin Rajapur, Uttar Rajapur and Malia Rajapur have been facing crisis of pure drinking waterforthelastfourmonths.

Chhoto Rajapur, Uttar Rajapur, Malia Rajapur and Uttar Sonapur are some other worst affected

Ponds that are main sources of made of polythene sheets. drinking water in most of Sidr-hit villages in Sharankhola have become totally useless, a project coordinator of CARE said, adding that installation of tube wells is not also possible due to technical reasons.

Admitting severe crisis of pure natural disaster. drinking water in most areas of the upazila, UNO Shahnewaz Talukder said 200 sand filters (PSF) are needed on an emergency basis to overcome the situation. Non-governmental organisation ECHO has agreed to finance the PSF project, he added.

A number of landless people in the upazila are still living in makeshift tents under the open sky as they did not get any help from government and non-government organisations to reconstruct their houses destroyed by the calamity.

Landless people said their woes would increase in the coming summer and rainy seasons as they have been living in makeshift tents

Shefali Begum of Southkhali said she lives with her five children in a polythene-made tent as her house on the bank of the Baleshwar River was completely destroyed by the

Jainab Begum, a widow, said she is living with her children in a tent for the last four months as Sidr destroyed her tin-roofed house at Southkhali. Similar complains were made by

Yusuf Fakir, Shahidul Howlader, Mukta Begum and Emdad Ali of Uttar Southkhali have also similar stories to tell.

Neither the government nor NGOs provided them any help to reconstruct their destroyed houses they said.
