Joint forces arrested Gangni municipality Chairman Ahmed Ali from jail gate soon after he was granted bail from a local court on Monday evening.

Earlier on March 9, authorities suspended him from chairmanship of the municipality.

Ahmed Ali is accused in four cases -- two for murder and two for extortion.

Arrested by joint forces on January 12 last year, Ahmed was released on bail after two and half months, police said.

The joint forces again arrested him on July 8, 2007.

After seven months, Meherpur 'District and Sessions Judge's Court granted him bail on Monday. When he was released at

around 7:00pm and came out from jail, a joint force team arrested Ahmed at the jail gate. Joint forces handed him over to

police the same night. Police yesterday produced him before Judicial Magistrate's Court in Meherpur under Emergency Powers Act and the court sent him to jail.

Different sources including law-enforcing agencies said Ahmed, a leader of Meherpur district Awami League, allegedly maintained close relation with an outlawed party.

Indigenous leaders demand after release on reinvestigation of Chalesh Ritchil's death

Indigenous leaders have demanded proper investigation into the death of Madhupur indigenous leader Chalesh Ritchil who died on this day last year.

At the memorial meeting of husband. Chalesh Ritchil at his village Maguntinagar at Madhupur upazila in Tangail to mark his first death anniversary yesterday, they the government should try the 'killers' of Madhupur indigenous leader Chalesh Ritchil.

Chalesh Ritchil was vocal about the rights of local indigenous people and he always talked against torture and oppression, they said.

With convener of the death anniversary observance committee Abraham Remang in the chair, former lawmaker Promod Mankin attended the memorial meeting as chief guest.

Among others, general secretary of Adivashi Adhikar Andolon Prof Mezbah Kamal, indigenous author Subhash Jemchang, general secretary of the Indigenous People's Forum Sanjib Drang, indigenous leader Albert Mankin, president of Joinshahi Adivashi Unnayan Parishad Ajoy-a-Mre, Chalesh's wife Shandhya Rani Simsanj, Benedict Mansang and indigenous women's leader Rakhi Mrong spoke.

Earlier, a special prayer directed by father Nikolas and father Sushanto was held at the grave of Chalesh Ritchil. Chalesh Ritchil, arrested by the

joint forces from Kalibari area under Muktagachha upazila in Mymensingh on

March 18, died on the same day in Madhupur.

After the death, administration officials said Chalesh fell unconscious when he ran to escape arrest by joint forces and died after he was taken to Madhupur Upazila Health Complex.

Dr Kamruzzaman of Madhupur Upazila Health Complex filed an unnatural death case with Madhupur Police Station in this

Chalesh's family members, however, alleged that he was died due to torture by the joint forces at Kakraid Army Camp and demanded to the government of proper investigation of the incident.

Chalesh's first wife Shandhya Rani Simsang on March 21 submitted a petition to Madhupur Police Station holding some local forest department officials and an officer of a law enforcement agency was responsible for the death of her

Tuhin Hadima, Piren Simsang and Protab Jambil, who had also been allegedly detained along with Chalesh, were made witnesses in the petition.

Madhupur police received the petition but they are yet to record it as a case.

Government on May 5 formed a one-member probe committee with a retired district and session judge Rofi Uddin Ahmed to investigate the death.

But the probe report is yet to be published.

26 PWs submit deposition in court

Three more prosecution witnesses (PWs) in five August 17 series bomb blasts cases gave statements before a court at Satkhira yesterday in presence of 11 out of 19 charge sheeted accused.

With them, a total of 26 PWs were examined by court till date. Earlier, the court recorded statements of 23 other prosecution witnesses on different dates in February and March.

The cases in Satkhira are being tried over three years after the countrywide blasts by Jama'atul Mujahideen Bangladesh (JMB)) on August 17 in 2005.

Judge Mahbubul Alam of the Additional District and Sessions Judge's Court at Satkhira recorded the statements of three prosecution witnesses and fixed April 7 for next hearing of the

The witnesses who testified yesterday are Satkhira Pourasava Commissioner Shafiquddowla Sagar, Nazrul Islam and Jamaat Ali.

Trial of the five August 17 blasts cases began with deposition of the complainants of the cases Sub-inspector (SI) Jasim Uddin, SI Abu Taher and SI on February 14.

The charge sheeted Rahman Sunny.

accused Nasir uddin Dafadar, Monowar Hossain Ujjal, Maniruzzaman Munna, Nur Ali Member, Anisur Rahman Khokon, Gias Uddin, Mahbubur Rahman Liton, Billal Hossain, Asadul Haque, Ismail alias Habibur and Rakib Hasan alias Rusel alias Hafez Mahmud alias Mahmud were on the dock while five other charge-sheeted accused are absconding.

Following information from pickpocket Raswshan, the lone eyewitness of the bomb blast on the premises of the Women and Children Repression Prevention Court at Satkhira, police arrested JMB operative Nasir Uddin Dafadar of village Bakal Islampur and his accomplices and consequently was able to detect JMB's involvement in the series bomb blasts across the country on August 17 in 2005.
